Appellants, certain respondents, and Jason King, P.E., have filed a joint motion for an extension of time. The motion requests an extension of time for (1) Mr. King to file a brief of amicus curiae in support of appellant, (2) respondents to file their answering briefs, and (3) appellants to file their reply brief. Respondent Nevada Department of Wildlife (NDOW) has filed a notice of non-opposition. Cause appearing, we grant the motion to the following extent. NRAP 30(f); NRAP 31(b)(3)(B). Mr. King shall have until January 25, 2019, to file and serve an amicus brief. Respondents Lyon County, Centennial Livestock, Bridgeport Ranchers, Schroeder Group, and Walker River Irrigation District shall have 60 days from the date Mr. King's amicus brief is filed to file and serve their answering briefs. We decline to extend the time for filing the reply brief at

this time. Appellants may renew their motion after the answering briefs are filed, if deemed necessary.

The Walker River Paiute Tribe (WRPT) has filed a motion for an extension of time to file its brief of amicus curiae consistent with the extension requested by Mr. King. Respondent Walker River Irrigation District has filed a notice of non-opposition. Cause appearing, we grant the motion. NRAP 30(f). WRPT shall have until January 25, 2019, to file and serve its brief of amicus curiae.

Natural Resources Defense Council, Sierra Club, Western Resource Advocates, National Wildlife Federation, and Nevada Wildlife Federation have filed a motion for leave to file a brief of amicus curiae in support of appellants. Several professors of law also seek leave to file an amicus brief in support of appellants. Cause appearing, we grant both motions. NRAP 29. The clerk shall file the amicus briefs received on December 3, 2018, and December 7, 2018.

Finally, attorney Robert Eisenberg has filed what appears to be the exhibits to a motion to associate foreign counsel John D. Echeverria. SCR 42(3)(c)(2). However, no motion to associate has been filed in accordance with SCR 42(3)(c). Accordingly, we take no action on the exhibits.

It is so ORDERED.
