

STATEMENT OF AMICI INTEREST

Municipal purveyors throughout Nevada rely on settled water right decrees to deliver water to their customers. Municipal purveyors like Carson City and the City of Fernley serve the public with their water rights, and accommodate growth and development in their cities with their water resources. Before any new home or business can be approved, a determination must be made that adequate water resources are available, and those determinations are made in reliance of settled water right decrees. Municipal purveyors also rely on settled water right decrees to make long-term financing decisions, commit to the repayment of bonds, and build infrastructure. Thus, losing even a small portion of existing water rights can be catastrophic to long-term planning for municipalities.

The water right portfolios of municipal purveyors include large portions of water rights from settled water right decrees. For example, Carson City relies heavily on decreed rights and related permits, which total 3,743.73 acre-feet/annually (“afa”) from the Carson River.¹ The City of Fernley owns approximately 10,000 afa of water rights from the Truckee River that were adjudicated in the *Orr Ditch* decree. In fact, every major river in Nevada has been adjudicated by a court, and municipalities rely on water rights from those decrees.²

Municipal purveyors are interested in this case's outcome because their ability to provide water to their citizens depends on the purveyor's underlying water rights.

SUMMARY OF ARGUMENT

Mineral County would have this Court apply the public trust doctrine in Nevada to destroy the prior appropriation system, and fashion a new appropriation system from whole cloth. Drastic change is not needed to solve the ecological challenge in Walker Lake, or elsewhere in Nevada. Since Mineral County began its public trust litigation, Congress enacted legislation to restore Walker Lake with hundreds of millions of dollars worth of appropriations for water right purchases from willing sellers. Since Justice Rose's concerns in *Mineral County* have already been addressed by a legislative decision, this Court should not rock the foundation of the prior appropriation system by adopting Mineral County's untethered version of the public trust doctrine.

Arid western states, like Nevada, have developed and grown because water appropriators can rely on specific water priorities and quantities. Many western states have declined to extend the public trust doctrine in a way that threatens these settled priorities and quantities. If this Court were to hold that settled water rights can be reallocated through the public trust doctrine, the certainty and reliability of

water rights will disappear. The incentive to invest and develop scarce water resources will be greatly impacted. That is why even states that adopt a broad public trust doctrine only use the doctrine as a last resort for solving environmental issues.

Mineral County's request would also result in a taking of private property. Mineral County claims that a federal judge overseeing the Walker River decree can take water rights from an individual owner to serve what Mineral County asserts is a greater public value. This Court long ago held "the Nevada Constitution contemplates expansive [protection of] property rights," and noted that "our State enjoys a rich history of protecting private property owners against government takings."³ Mineral County's request to expand the public trust doctrine threatens that rich history.

As with other real property rights, a water right holder enjoys due process protections.⁴ This Court has cited with approval that a water right "is property of the highest order, and oftentimes of the highest value. The water right is protected by the law as such, and is subject to all of the usual incidents of property."⁵ Specifically, "[a] water right is such a property right that it comes clearly within the constitutional provisions that property shall not be taken or damaged for public or

private use, except upon due process of law and upon just compensation.”⁶ Clearly, water right owners are entitled to compensation for taken property.

In the case of municipal purveyors, the compensation due will be staggering. Without water, cities cannot serve their customers. Without customers, water rates will not be paid. Without revenue from rates, municipal purveyors will not be able to pay debt service on municipal bonds. Additional bonds will be needed for additional water projects. Water will need to be imported to cities to replace the water that is taken away for the newly minted “public good.” Since such a drastic change to water law is not merited, Mineral County’s request should be rejected.

ARGUMENT

I. Mineral County’s Version of the Public Trust Doctrine Will Undermine The Ability of Municipal Purveyors to Serve Customers.

Long ago, this Court aptly highlighted, “[a]s time passes it becomes more and more apparent that the law of ownership of water by prior appropriation for a beneficial purpose is essential under our climatic conditions . . . [and is] *necessary for the support and prosperity of the people.*”⁷ Water law commenters have also recognized the importance of a perfected water right’s security, explaining that the

security allows the water right holder to invest, build, and develop infrastructures to use the water.⁸

Municipal purveyors rely heavily on the certainty of water rights in Nevada to serve customers, issue will-serve commitments, and approve land developments. Purveyors develop expansive water systems for their customer bases because they know how much water is available from their water rights, and what protections those rights carry. Municipal purveyors would not make these investments, or incur debt to construct purification systems, conveyance systems, treatment plants, and other related necessities, without certainty that they can maintain their water rights. For example, unless a city can show valid water rights exist, bonds for infrastructure development cannot issue. Cities will also default on bonds without their underlying water rights.

The certainty of water rights is also critical for Nevada's subdivision approval processes. Before land can be subdivided, developed, or sold, adequate water rights must be assured for the property.⁹ A developer must demonstrate that water is available, but the purveyor (not the developer) is in charge of supplying the development with water in perpetuity. From a policy perspective, if inadequate or uncertain water rights are the only available rights, development cannot continue.

Homes and businesses must be built upon secure water sources. Building a development without first securing an adequate water supply would have tremendous consequences. Homes and businesses become uninhabitable, and failed investments, without water to service them. Certainty in a water right's quantity and extent prevents overdevelopment, and protects municipal purveyors from running out of water to serve their populations.

Altering water rights, through reallocation based on an untethered determination of new public values, will result in insufficient water for already-committed purposes. Reallocation jeopardizes the water rights a municipal purveyor relies on, and could upset decades of planning and reliance on those water rights.

Reallocation will also jeopardize long-term sustainable development. If the state reclaims water rights currently earmarked for future development, then it will be incumbent on the municipal purveyor (who the citizens rely on for water service) to acquire water through purchase, lease, development, or other tools built into the prior appropriation system. Requiring purveyors to acquire other water rights (in the same location) for the municipality's citizens is illogical, and should be rejected.

II. Nevada's Public Trust Doctrine Does Not Apply to Nevada Water Rights.

A. Nevada's Legislature decided that adjudicated water rights are settled, cannot be reopened, and are in the public interest.

Prior appropriation has been Nevada's water rights law for over a century and a half, and has been determined to be the best allocation of scarce water resources.¹⁰ The Nevada Supreme Court has explained that "as a matter of public policy, Nevada has determined that the prior appropriation doctrine is the best method of allocating this most precious of natural resources."¹¹ The prior appropriation system is now codified in NRS Title 48 which includes Chapters 533 and 534.¹²

1. Nevada's Legislature already determined Walker River water rights serve the public interest.

As for water rights acquired prior to 1905, like those on the Walker River, the Legislature already determined that those water rights serve the public good. In Nevada's first comprehensive water legislation, the Legislature declared that "the use of all water now appropriated, or that may hereafter be appropriated, is hereby declared to be a public use."¹³ The Nevada Legislature, therefore, on behalf of the people of Nevada, ratified that all existing appropriations on the Walker River, and other river systems, are in the public interest.

2. Statutes and case law require water right decrees to be final.

The Nevada Legislature's goal when it codified the prior appropriation system was to settle claims to water right appropriations, so as to end litigation and questions pertaining to the water right ownership. In *Ruddell*, this Court explained that the water rights law was enacted to "have the water rights adjudicated . . . in such a proceeding as to terminate *for all time* litigation between all such water users."¹⁴

Today, the Legislature continues to dictate that surface water decrees "shall be final and shall be conclusive upon all persons and rights lawfully embraced within the adjudication."¹⁵ Perfected water rights "are those already established either through diversion and beneficial use or through a state permit."¹⁶ Once the water right is created and perfected, it can only be lost through forfeiture or abandonment.¹⁷

Notably, the Legislature did not give the State Engineer or the judiciary power to revoke or reallocate already-adjudicated or granted water rights.¹⁸ The legislative body is the proper branch to determine societal policy determinations. This Court in *Lawrence* noted that when "the Legislature has found that a given dispensation is

in the public's interest, it will be afforded deference.”¹⁹ The Legislature has determined that the State Engineer is the appropriate agency to balance the public's interests in water appropriations.²⁰

The United States Supreme Court has also agreed that decrees are final water right disbursements, and should not be relitigated. The Supreme Court has already addressed whether final decrees can be re-opened for later litigants, specifically for additional fish protection, and ruled that they cannot.²¹ In 1913, proceedings were initiated to adjudicate Truckee River water rights. The Court entered a final decree in 1944, quieting title to the various Truckee River claims.

In 1973, the United States sought to re-adjudicate the rights to account for additional water rights, specifically, to allow additional vested rights for fish. The Supreme Court ruled that the decree was final and could be relied upon as a final vested and reserved rights quantification. The Court agreed with the Court of Appeals that any other conclusion would make final relative right quantification impossible.²²

In *Nevada v. United States*, the Supreme Court found that water right adjudications were both an *in rem* and an *in personam* proceeding.²³ The parties in

the quiet title action, as well as the general public, are therefore able to rely on the decree's finality. If the Court in this case adopted the public trust doctrine that is advanced by Mineral County, the holding in *Nevada v. United States*, will no longer be final. The United States could not reallocate its water rights in the *Orr Ditch* decree for fishery purposes. But with the public trust doctrine, the Pyramid Lake Paiute Tribe will be able to seek the same reallocation that the United States Supreme Court previously denied.

3. **Nevada's Legislature codified how public interest should be considered in all water right decisions, and that codification should not be questioned.**

Since the inception of Nevada's water law, the Legislature has required that the public interest in private water rights be fully considered prior to authorizing a new appropriation. In 1905, the Legislature declared that prior to issuing water rights, the State Engineer must ensure "the appropriation [of water] is not detrimental to the public welfare."²⁴ Today, Nevada water statutes still require the State Engineer to consider the public interest.²⁵ Thus, the State Engineer has considered the public interest for all water right grants since his office's inception in 1903.

Accordingly, State Engineer-issued water rights already have the public trust doctrine principles considered and applied to the water rights. This Court should respect the Legislature's grant of authority to the State Engineer to consider public trust matters when issuing water rights, and conclude that a retroactive judicial re-evaluation the public interest would be improper.

If the Court does adopt the public trust doctrine per Mineral County's request, the water right adjudications on the Truckee River will again be under attack. Other decreed water sources may also face similar attacks. Hundreds of water sources have been adjudicated throughout Nevada on river and stream systems, and each of those systems will be open to relitigation.²⁶ A public trust doctrine rule that allows for reallocation of already adjudicated streams would serve as a tool to reopen and relitigate these settled water rights. The Court should not permit such a tool to be used in Nevada, as it could cause mass litigation and restart decades of adjudications for Nevada waters.

B. Title to public water does not transfer when a water right is acquired.

Another basis for the Court to reject Mineral County's request is that the public trust doctrine cannot apply to water rights because when water is appropriated title to a public asset does not transfer to a private owner. The public trust doctrine

acts as a judicial check on the transfer of publicly owned property to private individuals to ensure the public's interests are protected.²⁷

While the state's waters belong to the public,²⁸ the water right is separate and apart from the water itself.²⁹ This Court recognized in the 1886 case *Lobdell v. Simpson* that a water right holder "has no property in the water itself, but a simple usufruct."³⁰ Water rights can be sold, leased, valued, and invested upon like real property despite the water's *corpus* belonging to the public. Notably, and significant to the questions presented to this Court, a water right transfers no legal title to the public's water.³¹ Therefore, a public trust violation cannot occur when a water right is granted, because no title transfer occurs.

In *Lawrence*, the term "dispensation" was used to mean a conveyance or sale of publicly owned property to a private interest.³² A water right, as a usufruct right, does not convey, purchase, or transfer title of water. Rather, Nevada's water appropriation system sets out a precise procedure for a party to appropriate, or claim, a share of the public's water resource.³³ In fact, the only requirement for appropriation under the water statutes is an "application for a permit" accompanied

by various permitting fees and beneficial use requirements.³⁴ Unlike land, water appropriation does not grant the appropriator ownership of that water's corpus, but merely grants the appropriator a right to divert and beneficially use the water.

C. Mineral County's argument goes far beyond the traditional public trust doctrine and does not apply to Nevada water rights.

Mineral County's contention that the public trust doctrine can operate to reopen a settled water right decree, and reallocate perfected water rights for environmental purposes, is a far cry from the underpinnings of the public trust doctrine. The seminal public trust doctrine case is *Illinois Central*.³⁵ Notably, *Illinois Central* had nothing to do with vested water rights that were long-held and relied upon. Rather, it only dealt with the sale of submerged land, held in trust for common public use, to private companies.³⁶

The Court in *Illinois Central* explained that the core concept of the public trust doctrine is that when land is "being held by the people of the state in trust for the common use and as a portion of their inherent sovereignty" such land grants fall

under the State's police power.³⁷ The Court further explained that the issue was that the railroad might only "construct as many docks, piers, and wharves and other works as it might choose, and at such positions in the harbor as might suit its purposes"³⁸ If this happened, the public's interest in, and reliance upon, the Chicago Harbor, could be jeopardized.³⁹ Ultimately, the Court found issue with the "grant of all the lands under the navigable waters of a state."⁴⁰

But the Court explained that smaller piecemeal grants of public trust lands which do not create an oversized opportunity for substantial harm to the public are acceptable.⁴¹ On balance, the Court found that the land grant purposes in *Illinois Central* could have been accomplished without transferring an entire section of the Chicago Harbor as a fee simple transfer.⁴² Thus, even at the public trust doctrine's inception in the United States, courts recognized that state lands are alienable as long as the public's common use is not substantially impaired. Nevada later officially adopted the public trust doctrine in *Lawrence*.⁴³

The principles of ensuring that grants of public assets do not harm the general public are incorporated into water right allocation. When a water right is granted, it is strictly limited to the water's beneficial use.⁴⁴ Unlike the dispensation of land in *Illinois Central*, water rights are granted piecemeal. Needlessly large water right grants that vest control of an entire source in a single person are prohibited under Nevada law.⁴⁵ Further, when the need for the water ceases, so does the water right.⁴⁶ Thus, the Court's concerns in *Illinois Central* regarding monopoly control over a public resource by a single entity do not exist for individual water rights.

This Court found that many of the public trust doctrine's foundational tenets already exist in the legislative adoptions of the prior appropriation doctrine.⁴⁷ In his concurring opinion in *Mineral County*,⁴⁸ Justice Rose stated that it is "the [State E]ngineer's continuing responsibility as a public trustee to allocate and supervise water rights so that the appropriations do not substantially impair the public interest in the lands and waters remaining."⁴⁹

Ultimately, this Court stated that the “the public trust doctrine operates simultaneously with the system of prior appropriation.”⁵⁰

Now, Mineral County seeks to expand this doctrine beyond *Lawrence*. Ironically, a doctrine designed to protect the public’s interest against a single entity’s control over water is now being usurped to do the opposite. Instead of a “free market” for water rights, Mineral County requests that a federal judge have the powers of a water czar to reallocate water resources for a single overriding purpose. Mineral County’s request should be denied because it goes far beyond the requirements of the public trust doctrine.

D. Other states, like Nevada, have already indicated Mineral County’s public trust argument is without merit in cases such as this.

Nevada is one of eight western states that follows a pure version of the prior appropriation system to define water rights.⁵¹ None of those states have adopted the public trust doctrine that Mineral County advances in this case. Idaho, Montana, Colorado, and Arizona considered whether to expand the public trust doctrine to

water rights and declined to do so. Since the public trust doctrine is a state-based doctrine,⁵² the reasoning of similar states is particularly persuasive in this case.

Idaho rejected California's expansive public trust doctrine interpretation. Until 1996, Idaho courts indicated that water and "proprietary rights to use water . .

. are held subject to the public trust.”⁵³ But in 1996, the Idaho Legislature stepped in. Idaho’s Legislature invalidated the Idaho public trust line of cases, and confined the public trust doctrine through statute. The statutes’ purposes were to fix a recurring misperception, namely that “[t]he public trust doctrine has been cited in court decisions and pleadings in ways that have created confusion in the administration and management of the waters.”⁵⁴ The statute declared “[t]he public trust doctrine as it is applied in the state of Idaho is solely a limitation on the power of the state to alienate or encumber the *title to the beds* of navigable waters.”⁵⁵ Importantly, Idaho declared that “the public trust doctrine shall not be applied to . . . the appropriation or use of water.”⁵⁶

Montana Courts have explained that the state’s waters belong to the public, and must be allocated subject to the public interest, like Nevada. Nevertheless, Montana statutes make clear that appropriated water rights trump any other public interest in the waters, including environmental protections and public use rights.⁵⁷ Montana, a strict prior appropriation state like Nevada, has explained that although “[n]avigable waters and all streams of sufficient capacity to transport the products

of the country are public ways for the purposes of navigation and such transportation,” the public’s interest in such waters “shall not be construed so as to affect or impair, in any manner, any rights acquired prior to July 1, 1901, by any person, association of persons, or corporation.”⁵⁸

The Arizona Legislature has also stepped in to stop the public trust doctrine from impacting issued water rights. The Arizona Legislature decided that the state “may obtain any water that is necessary to maintain and protect public trust values . . . *only by complying with the requirements of title 45*” which outlines Arizona’s prior appropriation scheme.⁵⁹

The Colorado Supreme Court also refused to allow the public trust doctrine to be used to control water rights based on state water ownership. Rather, “[w]ithout permission, the public cannot use such waters for recreation”⁶⁰ that have been appropriated by others, or remain unappropriated.

Furthermore, even under a California *National Audubon* analysis, many water rights in Nevada (such as Walker Lake) would likely be found to be outside the public trust doctrine principles. The Court in *National Audubon* considered the need

for exported water, reliance on water rights, the replacement water financial cost, and environmental costs associated with replacement water before deciding to reclaim some water rights via the public trust doctrine.⁶¹ There, the Court concluded that the benefits to Los Angeles did not outweigh the burden to Mono Lake.⁶²

As the legislation and courts have made clear in other strict prior appropriation states, water rights must be protected against uncertainty. Other states' laws have shown that water rights should not be subject to the public trust doctrine's reaches after they have been issued. Nevada should be no different.

E. **Alternate solutions already exist within the prior appropriation systems for Walker Lake.**

Even the California Supreme Court limited the public trust doctrine by stating “every effort must be made to preserve water right priorities to the extent those priorities do not lead to violation of the public trust doctrine,” and “the subversion of water right priority is justified *only if* enforcing that priority will in fact lead to the *unreasonable use of water* or result in harm to values protected by the public

trust.”⁶³ Thus, the Court found that subverting the prior appropriation doctrine should be a last resort.

Mineral County’s version of the public trust doctrine does not need to be adopted to protect Walker Lake. Notably, since Mineral County asserted its public trust claims in 1994, significant progress has been made to protect Walker Lake. What may have made sense to Justice Rose in 1994 ⁶⁴ makes little sense now. In the 25 years since Mineral County initiated litigation, policy-makers worked within the prior appropriation system to restore water levels at Walker Lake.

Solutions already exist within the current prior appropriation framework. Market solutions, such as purchasing, leasing, or swapping water rights, are demonstrably effective. These solutions are ingrained in the statutory water law, and are the most effective way to reallocate water rights, while simultaneously protecting individual priority and real property interests.

For example, on the Muddy River, the endangered Moapa dace is being restored and protected through multi-party agreements setting threshold flow levels for the fish and water exchange programs. On the Carson River, a water purchase program successfully led to restoration to thousands of acres of wetland habitat for

migratory waterfowl.⁶⁵ On the Truckee River, the Truckee Carson Water Settlement Act of 1990 allowed the Pyramid Lake Paiute Tribe to acquire water rights from willing sellers, and gain instream flow water rights to protect the endangered Cui-ui.⁶⁶ The Settlement Act of 1990 effectively achieved what the United States could not in the *Nevada v. United States* litigation.

Walker Lake is currently benefitting from free market solutions after a federal program authorized a water acquisition process for the lake within the traditional parameters of the prior appropriation doctrine. In a single day, on November 1, 2018, 9.88 cubic feet/second (“cfs”) of decreed water rights, and nearly 700 afa of water rights, were acquired for the Walker Lake restoration project.⁶⁷ Approximately 108 cfs of decreed water rights have been acquired in total.⁶⁸ As Lyon County explained in its brief, the Walker Basin Conservancy has acquired nearly half the needed water for the lake’s restoration.⁶⁹ As the Walker Basin Conservancy’s hard work has shown, the public’s interests can be maintained without involuntarily seizing private property.

Through the National Fish and Wildlife Foundation, northern Nevada has benefited from dozens of projects to help develop and protect desert lakes – including Walker Lake.⁷⁰ These prior appropriation solutions are working, and should be left to continue working without unnecessary judicial intervention. In short, the foundational principles of prior appropriation do not need to be destroyed to address ecological issues at Walker Lake.

III. Just Compensation is Required if a Water Right is Taken Based on the Public Trust Doctrine.

“When a right to use water has become fixed either by actual diversion and application to beneficial use or by appropriation as authorized by the state water law, it is a right which is regarded and protected as real property.”⁷¹ Like land, if the government strips an appropriator of a portion, or all, of his water right, the appropriator is due just compensation for the lost property.⁷² “The Takings Clause of the Fifth Amendment of the United States Constitution, applicable to the states through the Fourteenth Amendment, prohibits the government from taking private

property for public use without just compensation.”⁷³ The Nevada Constitution’s Article 1, Section 8(6) also states “[p]rivate property shall not be taken for public use without just compensation having been first made, or secured.”⁷⁴

For a taking to occur, a claimant must have a “stick in the bundle of property rights.”⁷⁵ The bundle of property rights includes “all rights inherent in ownership, including the inalienable right to possess, use, and enjoy the property.”⁷⁶ Water priority and quantity are not simply “sticks in the bundle” of rights – they are the most important sticks because they determine when the appropriator is able to access his water, and how much water the appropriator can use.

A diminishment of a water right for public use is no different than a diminishment of any other property right for public use. Similar to a carve-out on real property for a public easement, a water right carve-out for the public use requires just compensation. Nevada law recognizes that appurtenant water rights are a

separate stick in the bundle of rights attendant to real property, and therefore can be separated and condemned.⁷⁷

In *Carson City v. Estate of Lompa*, this Court held that water rights can be subject to eminent domain as a separate interest in real property.⁷⁸ In *Estate of Lompa*, Carson City condemned a land parcel, as well as the water rights appurtenant to that property. This Court found that water rights are “regarded and protected as real property” and that “NRS 37.010(3) specifically allows for a city to exercise its right of eminent domain to acquire water rights.”⁷⁹ As such, little question exists as to whether water rights are granted protections against takings. If the public trust doctrine is used as a tool to take a portion of an owner’s water right to benefit the general public, that taking requires just compensation.⁸⁰

This Court answered a similar question in *McCarran International Airport v. Sisolak*. There, a “stick in the bundle” of property rights Sisolak owned (his airspace over his property) became unusable after regulation. The Court determined that Sisolak had a property interest in the airspace above his property which constituted

a “stick in the bundle” of rights appurtenant to his property. An ordinance which excluded his airspace use constituted a taking because “even if the Government physically invades only an easement in property, it must nonetheless pay just compensation.”⁸¹ Justice Hardesty explained that “the County has appropriated private property for public use” because the ordinance prevented Sisolak from using the full extent of his property right.⁸² This Court has explained that rights, such as Sisolak’s airspace, become vested and protected when “use approvals are not subject to further governmental discretionary actions.”⁸³

A water right reapportionment for public use would be no different from Sisolak’s airspace. Once a water right is adjudicated, neither a court nor the State Engineer has any further discretion over the use of that water right.
