**Third Status Report**

In its Order dated January 7, 2019, this Court continued the stay of this matter pending resolution of Appellant Gibran Richardo Figueroa-Beltran's petition for writ of certiorari to the United States Supreme Court. *See* Document No. 19-00725 (Order). This Court directed Mr. Figueroa-Beltran to file a report within 30 days of the January 7 order informing the Court of the status of the petition for writ of certiorari. Thus, Mr. Figueroa-Beltran files this status report.

Mr. Figueroa-Beltran's certiorari petition is still pending. The government's court-ordered response to the petition was originally due January 22, 2019. *See* attached Docket Sheet for *Gibran Richardo*

*Figueroa-Beltran v. United States*, 16-10388 (U.S.). On January 17, 2019, the Solicitor General received an extension of time to file the response. The government's response is now due February 21, 2019.

At this point, the Supreme Court has not reset Mr. Figueroa-Beltran's case for conference. He therefore requests this Court continue the stay in this matter until the United States Supreme Court reviews and resolves his petition for certiorari.
