11 The Appellant respectfully request that this Court
12 order the production of the transcripts, papers, pleadings,
13 and any other documents with regards to be
14 furnished to the petitioner/Appellant at State expense,
15 due to his poverty.

16 That only with proper review of those documents
17 of the above-entitled case will the appellant be
18 able to adequately prepare a post-conviction petition,
19 or a direct appeal, that would allege all issues and
20 grounds for relief that he is seeking. Peterson vs.
21 Warden, 87 Nev. 134, 483 P.2d 204 (1971)

22 holds that:

23 "... does not contemplate that a record will
24 be furnished at State Expense upon mere
25 unsupported request of a petitioner who is
26 unable to pay for them... so must he
27 satisfy the points raise merit and such
28 merit will be supported by review of the
29 record..."

1 Moreover, the appellant would be prejudiced absent the
2 Courts granting of this within motion. Appellant would
3 not have means necessary to file a proper petition
4 for Writ of habeas corpus, post-conviction or direct
5 appeal in this court, that would allow the appellant to
6 allege all available issues.
