15 The Appellant proceeded to jury trial on September 11, 12, 13, 14 and 15, 2018 for the  
16 allegations of Count I – Child Abuse, Neglect or Endangerment, a category B felony  
17 violation of NRS 200.508(1); Count II – Battery Constituting Domestic Violence, a  
18 category B felony violation of NRS 200.485(2); Counts III through V– Child Abuse,  
19 Neglect or Endangerment, a category B felony violation of NRS 200.508(1); Count VI -  
20 Coercion, a category B felony violation of NRS 207.190(2); Counts VII and VIII -  
21 Child Abuse, Neglect or Endangerment, a category B felony violation of NRS  
22 200.508(1).
- 23 Appellant was found guilty by the jury on September 15, 2018 of Counts 1, 2, 3 and 5.

1 Counts 1, 3 and 5 are Child Abuse, Neglect or Endangerment, a category B felony  
2 violation of NRS 200.508(1). Appellant was sentenced to imprisonment in the Nevada  
3 Department of Corrections for Counts 1, 3 and 5– for a minimum period of Nineteen  
4 (19) months and a maximum sentence of forty-eight (48) months, all Counts running  
5 concurrently. This sentence was suspended and Ms. Nash was placed on Probation for  
6 an indeterminate amount of time, not to exceed Three (3) Years. For Count 2, Battery  
7 Constituting Domestic Violence, a category B felony violation of NRS 200.485(2), Ms.  
8 Nash was sentenced to Credit for Time Served. Appellant now seeks to appeal the  
9 sentence in the Judgment of Conviction filed May 7, 2018.
