OVERDUE COURT REPORTER CERTIFICATE

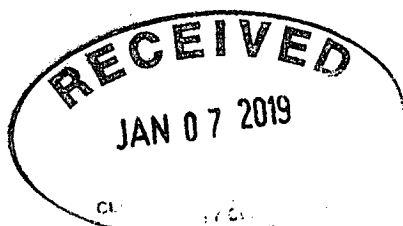


