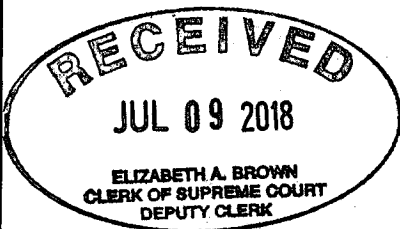
MOTION TO WAIVE FILING FEES FOR PETITION FOR WRIT OF
