

1 **POINTS AND AUTHORITIES**

2 Petitioners Amy and Vivian Mulkern move for permission to file the Appendix
3 for their Writ Petition under seal, which contains the file from a proceeding held
4 pursuant to NRS Chapter 432B.


5 This case is governed by NRS Chapter 432B. NRS 432B.280 states that except
6 in certain limited circumstances, all information maintained by an agency which
7 provides child welfare services, including, without limitation, reports and
8 investigations made pursuant to this chapter, is confidential. The Appendix of the
9 Writ Petition contains the file for this case, which includes information maintained
10 by DFS, including reports and investigations made pursuant to NRS Chapter 432B.

11 The Rules Governing Sealing and Redacting Court Records (SRCR) provide
12 guidance for appellate cases, with Rule 7 indicating that records sealed in the trial
13 court should also be sealed on appeal. This demonstrates the public policy of
14 preserving confidentiality when confidential records in district court cases are
15 reviewed by Nevada appellate courts.

16 The appeal is from a 432B case, which is sealed at the trial level pursuant to
17 NRS 432B.280 and accompanying statutes. Accordingly, Appellant requests that
18 Supplemental Appendix Volume II be filed under seal. The Appendix will be mailed
19 in a sealed envelope to the Nevada Supreme Court, and a copy will be mailed to all
20 parties.
