ARGUMENT

Petitioners Jose Valdez-Jimenez, Aaron Frye, and Nathan Grace respectfully submit this request to reschedule oral argument for an earlier date. On Friday, June 7, 2019, this Honorable Court issued an Order scheduling oral argument in the instant matter for July 2, 2019 in Carson City, Nevada. Unfortunately, counsel for Petitioners are unavailable on that date. Deputy Public Defender Nancy Lemcke will be out of the jurisdiction from June 29, 2019 until July 12, 2019 on pre-paid travel plans. Charles Gerstein, a Washington, D.C. resident, is also unavailable as his wife is due to give birth to their first child on July 4, 2019. Accordingly, counsel request that the oral argument be rescheduled to a date convenient for the Court and the parties, but prior to Petitioner Jose Valdez-Jimenez's August 12, 2019 trial date.

Undersigned counsel is mindful of the Court's caseload and the inconvenience any rescheduling request necessarily imposes upon the Court.
