

ORDER GRANTING MOTION TO ASSOCIATE COUNSEL

Petitioner Jose Valdez-Jimenez has filed a motion to associate Texas attorney Olevia Boykin with the Civil Rights Corps in Washington D.C. in this matter pursuant to SCR 42.

Attached to the motion to associate Ms. Boykin is a verified application, a certificate of good standing from the Supreme Court of Texas and a statement pursuant to SCR 42 from the State Bar of Nevada. The State Bar of Nevada's SCR 42 statement indicates that Ms. Boykin has not applied to appear in Nevada courts within the past three years.¹ Accordingly, we grant the motion to associate Ms. Boykin. SCR 42(8); see SCR 42(14)(a) (requiring the Nevada attorney of record to be responsible for

¹We note that a motion to associate Ms. Boykin was previously filed in this case on July 9, 2019. The motion was denied without prejudice because it did not include a certificate of good standing as required by SCR 42(3)(a)(2).

and actively participate in the representation of a client in these proceedings); NRAP 25(a)(5) (requiring all documents submitted to the supreme court for filing to include the original signature of at least one attorney of record who is an active member of the State Bar of Nevada); NRAP 46(a)(3) (requiring Nevada counsel to sign all briefs, be present during oral argument, and be responsible for all briefs and matters presented by foreign counsel).

Included with Ms. Boykin's motion to associate is an application for waiver of fee pursuant to SCR 42(3)(e). Cause appearing, the application is granted. *See* SCR 42(3)(e) (providing that court may waive fees upon "a showing that the applicant is providing pro bono services in a death penalty habeas corpus case or in other similar circumstances providing for pro bono representation").

It is so ORDERED.
