**STIPULATION TO EXTEND ALL DEADLINES/STAY OF PROCEEDING  
PENDING SETTLMEMENT APPROVAL**

---

WHEREAS, on December 18, 2018, this Court filed in this action an Order Removing From Settlement Program and Reinstating Deadlines For Filing Required Documents; and

WHEREAS, on December 21<sup>st</sup>, 2018, the parties reached a settlement resolving all issues as between them, including those raised in the instant appeal and cross-appeal, *subject only to* approval of the settlement by the State of Nevada Board of Examiners; and

WHEREAS, if the settlement is approved by the Board of Examiners, the settlement will resolve all issues raised in the appeal and cross-appeal and this appeal

will be voluntarily dismissed by the parties pursuant to NRAP Rule 42;


WHEREAS, it is expected that the request for approval will be placed on the February 12, 2019 (tentative date) Board of Examiners agenda, or as soon thereafter as it may be heard; and

WHEREAS, because parties have reached a settlement resolving all issues as between them, including those raised in the instant appeal and cross-appeal, *subject only* to approval of the settlement by the State of Nevada Board of Examiners, the parties have also agreed to the appearance of the Garman Turner Gordon as Appellants/Cross-Respondents' counsel in this appeal for purposes of carrying out the terms of the parties' settlement.

NOW, THEREFORE, pursuant to NRAP 26(b)(2), the parties, through their respective counsel, hereby stipulate that all deadlines reinstated by this Court's Order filed December 18, 2018 be stayed/extended until 30 days after the proposed settlement is presented to the State of Nevada Board of Examiners for final approval, which is currently expected to occur on or about February 12, 2019.
