#### JUDGMENT OF CONVICTION

The Defendant, having entered a plea of Guilty, and no legal reason or cause existing to preclude entry of judgment against her, the Court rendered judgment as follows:

- Upataua Diana Poasa, is guilty of the crime of Grand Larceny of Auto,
   Less Than \$3500, a violation of NRS 205.228(2), a category C felony, as charged in Count
