Respondents Ellen Cotter, Margaret Cotter, Guy Adams, Douglas McEachern, Edward Kane, Judy Codding, Michael Wrotniak, and Mary Ann Gould (personal representative of the Estate of William Gould) (collectively, the "Director Defendants") submit this notice to clarify a statement made by their attorney, Christopher Tayback of Quinn Emanuel Urquhart & Sullivan LLP, at the oral argument before the Nevada Supreme Court held in this coordinated matter on September 8, 2020.

On February 1, 2017, the Director Defendants filed a Petition for Writ of Prohibition or, in the Alternative, Mandamus after denial of partial summary judgment by the District Court (Nevada Supreme Court Case No. 72261). The Director Defendants' challenge to Cotter Jr.'s derivative standing was the focus of that writ petition.<sup>1</sup> This Court denied the Director Defendants' writ petition in an order dated April 14, 2017.<sup>2</sup>
