DECLARATION OF BRAD D. LEVENSON

I, Brad D. Levenson, declare:

I am an attorney at law, admitted to practice before this
Court and employed by the Capital Habeas Unit of the Federal Public
Defender, District of Nevada. I am assigned to represent James Montell
Chappell.

Appellant's Reply Brief is due on October 30, 2019. I am seeking an extension of time of sixty (60) days, including December 30, 2019, within which to file and serve the Reply. This is Chappell's first request.

3. I am requesting a sixty-day extension because I have not had adequate time to prepare the Reply. The majority of my time since the State filed its Answer has been dedicated to the federal trial case of *USA v. Schlesinger*, 4:18-cr-02719-RCC-BGM, a death qualified case from the District of Arizona. I have made three trips to Arizona, since October 1, 2019.

Besides the work described above, during the next sixty days I will be out of the office on case-related travel on November 4, November 5, November 13 through November 15, November 19, November 20, and December 17, 2019. It is also possible other caserelated travel will be planned. In addition, I have various deadlines in *Schlesinger* throughout November and December 2019.

6. The additional time requested here is necessary for me to devote the attention required to competently represent Mr. Chappell.

7. This request is not made solely for the purpose of delay, or for any other improper purpose, but only to ensure this office competently represents Mr. Chappell. Nev. R. Prof. Conduct 1.1.
