THE LYTLE TRUST (the "Appellants") hereby requests an extension of time of 30 days, up to and including March 27, 2019, to file and serve the Opening Brief in this Docket 77007. This is the first request for extension in this matter.

This Court, on initial review of the docketing statement and documents before it, believed there was a potential jurisdictional defect. The Court then ordered Appellants to show cause why the appeal should not be dismissed for lack of jurisdiction. Operating under prior precedent in *Mallin v. Farmers Ins. Exch.*, 106 Nev. 606, 609, 797 P.2d 978, 980 (1992), Appellants concurred with the Court that it lacked jurisdiction and briefed the matter accordingly. After Appellants briefed the matter, *Mallin* was overruled as to the issue at hand. *See In re Estate of Sarge*, 134 Nev. Adv. Op. 105 (2018).

Thereafter, on January 28, 2019, this Court determined it had jurisdiction and ordered this Docket 77007 to be consolidated with Docket 76198. The Court also ordered Appellants to submit an Opening Brief within 30 days of the Court's January 28, 2019 Order.
