JONELL THOMAS, hereby declares as follows:

- I am an attorney duly licensed to practice law in the State of Nevada and I am the Special Public Defender for the Clark County Special Public Defender's Office. I am handling Mr. Barlow's capital appeal. I am receiving assistance from Mr. Afshar, but I retain primary responsibility for this appeal because it is a capital case and Mr. Afshar is not qualified under SCR 250 to handle capital appeals.
- 2. Mr. Barlow's Reply Brief is due July 31, 2020. I am requesting an extension of time (60 days) to file the brief based on the following reasons:
