**MOTION TO EXTEND TIME TO FILE
DOCKETING STATEMENT**

Pursuant to Nevada Rule of Appellate Procedure 26(b)(2), appellant Jeffrey Spencer hereby moves for additional time to file a docketing statement by 30 days. The original deadline to file is Monday, October 22, 2018. Spencer seeks an extension until Monday, November 26, 2018. This is the first extension of time requested. The additional time is necessary because appellate counsel was retained after more than

four years of litigation in the district court and has not received cooperation from trial counsel Lynn Pierce in obtaining copies of the voluminous records from those proceedings. Because the docketing statement requires an initial statement of the issues presented on appeal, review of the district court record is necessary before the docketing statement can be prepared. Despite several requests, appellate counsel has still not received the records from trial counsel Lynn Pierce. Therefore, additional time to file the docketing statement is required.

Counsel for appellant consulted with counsel for respondents and they have no objection to the extension sought; however, because of travel schedules for two of the attorneys, it was not possible to obtain signatures on a stipulation.
