MOTION TO EXTEND TIME TO FILE OPENING BRIEF

Pursuant to Nevada Rule of Appellate Procedure 26(b)(2), appellant Jeffrey Spencer hereby moves for additional time to file an opening brief for 30 days after the lodging of transcripts requested or a decision on the motion to consolidate, whichever is later. The original deadline to file is Tuesday, January 22, 2019. Spencer seeks an extension to allow for the filing of transcripts that were requested and for the Court to consider a motion to consolidate appeals filed concurrently herewith. This is the first extension of time requested. The additional time is necessary because despite requesting three transcripts and serving those requests on the department in Douglas County District Court, Spencer has only obtained one transcript, which was made from a JAVS recording upon Spencer's requests. The transcripts from hearing attended by a court reporter have not yet been lodged, and those transcripts are necessary for the consideration of the appeal.

Additionally, Spencer has sought consolidation of this appeal (Case No. 77086) with the appeal from the award of attorneys' fees in the same district court action (Case No. 77711). Because the appeals are based on the same operative facts and rely on the same transcripts, consolidation serves judicial economy and would allow the filing of only one set of briefs. Until the Court decides the motion to consolidate, briefing would be premature.

For the foregoing reasons, Spencer requests that the Court grant an extension of 30 days from the lodging of the requested transcripts or a decision on the motion to consolidate, whichever is later.
