24          Respondent (Plaintiff and Counterdefendant) Northern Nevada Homes, LLC,  
25          and Cerberus Holdings, LLC, filed their Complaint against G.L. Construction,  
26          Inc., and Gordon Lemich in the Washoe County District Court (Case No. CV13-  
27          01468) on July 3, 2013. Defendant and Counterclaimant G.L. Construction,  
28          Inc., filed its Counterclaim against Counterdefendant Northern Nevada Homes,  
29          LLC, on October 28, 2013.

- 30          10.    **Provide a brief description of the nature of the action and result in the**  
31          **district court, including the type of judgment or order being appealed and**  
32          **the relief granted by the district court:**

33          Northern Nevada Homes, LLC, and Cerberus Holdings, LLC, filed a  
34          complaint against G.L. Construction, Inc., and Gordon Lemich. Northern  
35          Nevada Homes, LLC, alleged that defendants trespassed on their property by  
36          dumping dirt and other waste. In answering the complaint of Northern Nevada  
37          Homes, LLC, G.L. Construction, Inc., also filed a counterclaim against Northern  
38          Nevada Homes, LLC, for breach of contract regarding unpaid invoices for  
39          construction work which it had performed on separate projects. The district  
40          court bifurcated the case into a jury trial concerning Northern Nevada Homes,  
41          LLC's claims against G.L. Construction, Inc., and Gordon Lemich, and a bench  
42          trial concerning G.L. Construction, Inc.'s counterclaim against Northern Nevada  
43          Homes, LLC. On day three of the jury trial, the district court indicated it was  
44          inclined to enter judgment as a matter of law in favor of Northern Nevada



1 Homes, LLC as to liability on its tort-based claims, and shortly thereafter, the  
2 parties settled Northern Nevada Homes, LLC's claims for \$362,500. After the  
3 bench trial on G.L. Construction's counterclaim, the district court found in favor  
of G.L. Construction, Inc., awarding it \$7,811.00 in damages and an attorney's  
fee in the sum of \$10,000.00 pursuant to NRS 18.010(2)(a).

4 Following the district court's entry of its award of attorney fees,  
5 counterdefendant Northern Nevada Homes, LLC, prosecuted an appeal from  
6 that award of fees in which it maintained that the district court had no authority  
7 to award G.L. Construction, Inc., its attorney fees pursuant to NRS 18.010(2)(a)  
8 because G.L. Construction, Inc., was not a prevailing party inasmuch as plaintiff  
Northern Nevada Homes, LLC, had settled its trespass claims against G.L.  
Construction, Inc., and Gordon Lemich for the sum of \$362,500.00. The  
Nevada Supreme Court rejected the argument of Northern Nevada Homes, LLC,  
and affirmed the district court's award of \$10,000.00 in attorney fees.

9 Following remand, counterclaimant G.L. Construction, Inc., moved the  
10 district court pursuant to NRS 18.010(2)(a) for an award of those appellate  
11 attorney fees which it necessarily incurred in successfully defending against  
12 Northern Nevada Homes, LLC's appeal of the district court's \$10,000.00 award  
13 of attorney fees. On October 3, 2018, the district court entered its Order,  
14 denying that motion on the ground that the Nevada Supreme Court's decision  
15 in Bobby Berosini, Ltd., v. People for the Ethical Treatment of Animals had  
16 held that attorney fees which had been incurred on an appeal could not be  
17 recovered under NRS 18.010. It is this decision of the district court which G.L.  
Construction, Inc., now appeals. G.L. Construction, Inc., maintains that the  
Nevada Supreme Court's decision in *Bobby Berosini* did not address the issue  
of whether attorney fees incurred in connection with an appeal can be recovered  
pursuant to NRS 18.010(2)(a), but only decided the issue of whether a district  
court could award attorney fees pursuant to NRAP 38 where the Nevada  
Supreme Court had already determined in connection with a prior appeal that  
attorney fees pursuant to NRAP 38 were not warranted.

**ORDER DENYING COUNTERCLAIMANT'S MOTION FOR  
ATTORNEY FEES INCURRED POST-ORDER**

Currently before the Court is Counterclaimant's *Motion for Attorney Fees Incurred Post Order for Fees*, filed August 28, 2018 by G.L. CONSTRUCTION, INC. ("Counterclaimant"). Counterdefendant, NEVADA HOMES, LLC, filed its *Opposition to G.L. Construction's Motion for Attorney's Fees on Appeal* on September 12, 2018, to which Counterclaimant responded

1 through a *Reply Points and Authorities in Support of G.L. Construction, Inc. 's Motion for*  
2 *Attorney Fees Incurred Post Order for Fees*, filed September 17, 2018<sup>1</sup>.

3 Having reviewed the briefing and being fully informed, the Court DENIES  
4 Counterclaimant's motion for attorney fees incurred post-order. Counterclaimant is entitled to  
5 recover only the \$10,000.00 in attorney fees originally awarded by the Honorable Lidia Stiglich  
6 in the above-captioned matter.

### 7 BACKGROUND

8 On October 31, 2016, litigation between Counterclaimant and Counterdefendant resulted  
9 in a judgment in the amount of \$7,811.00 in favor of Counterclaimant<sup>2</sup>. In accordance with NRS  
10 18.010(2)(a), which allows a prevailing party recovering less than \$20,000.00 to additionally  
11 recover attorney fees, Counterclaimant sought attorney fees from Counterdefendant. The  
12 Honorable Lidia Stiglich, then presiding judge of this Department, awarded reasonable fees in  
13 the amount of \$10,000.00.

14 On December 9, 2016, Counterdefendant filed a notice of appeal to the Nevada Supreme  
15 Court from the order awarding attorney fees and costs to Counterclaimant. Evaluating Judge  
16 Stiglich's award under an abuse of discretion analysis, the Supreme Court issued an order of  
17 affirmance on August 2, 2018 upholding the award and finding that Judge Stiglich had not  
18 abused her discretion.

19 Counterclaimant now prays for an order from this Court to recover attorney fees for the  
20 costs related to successfully litigating Counterdefendant's appeal. Counterclaimant thus seeks:

- 21 1. \$7,811.00 principal, together with pre-judgment interest on this principal sum at the  
22 legal rate from and after March 14, 2013;

2. \$10,000 in attorney fees for those attorney fees incurred in this Court pre-judgment, together with interest on this principal sum at the legal rate from and after December 1, 2016;
3. \$10,615.00 in attorney fees for those attorney fees incurred by Counterclaimant in successfully defending against the appeal taken by Counterdefendant from this Court's award of \$10,000.000 in attorney fees on December 1, 2016; and
4. \$5,472.50 in attorney fees incurred by Counterclaimant in preparing and filing the instant motion seeking attorney fees;

For a total sum of \$33,898.50 before calculation of pre-judgment interest.

#### STANDARD OF REVIEW

The decision to award attorney fees generally lies within the discretion of the court.

*Bobby Berosini, Ltd. v. People for the Ethical Treatments of Animals*, 114 Nev. 1348, 1356, 971 P.2d 383, 388 (1998) (citing *Nelson v. Peckham Plaza Partnerships*, 110 Nev. 23, 26, 866 P.2d 1138, 1139-40 (1994)); *See also Clark Cty. v. Blanchard Const. Co.*, 98 Nev. 488, 492, 653 P.2d 1217, 1220 (1982). However, NRAP 38 limits that discretion. NRAP 38 states:

(a) **Frivolous Appeals; Costs.** If the Supreme Court or Court of Appeals determines that an appeal is frivolous, it may impose monetary sanctions.

(b) **Frivolous Appeals; Attorney Fees as Costs.** When an appeal has frivolously been taken or been processed in a frivolous manner; when circumstances indicate that an appeal has been taken or processed solely for purposes of delay, when an appeal has been occasioned through respondent's imposition on the court below; or whenever the appellate processes of the court have otherwise been misused, the court may, on its own motion, require the offending party to pay, as costs on appeal, such attorney fees as it deems appropriate to discourage like conduct in the future.

Pursuant to this rule, attorney fees and costs on appeal are permitted *only* in those contexts where the Nevada Supreme Court finds the "appeal has been frivolously been taken or been processed in a frivolous manner." *Bobby Berosini, Ltd.*, 114 Nev. at 1356, 971 P.2d at 388 (quoting NRAP 38); *See also Bd. of Gallery History, Inc. v. Datecs Corp.*, 116 Nev. 286, 288, 994 P.2d 1149, 1150 (2000).

First, attorney fees cannot be properly awarded under NRS 18.010 as Counterclaimant suggests. In *Bobby Berosini, Ltd. v. People for the Ethical Treatments of Animal* (PETA), the Nevada Supreme Court specifically addressed this issue. Like Counterclaimant now does in this case, PETA sought attorney fees on appeal pursuant to NRS 18.010. The Court held that the desired attorney fees could not be recovered under NRS 18.010 because the language of the statute is silent with respect to attorney fees on appeal. *Id.* In line with that reasoning, this Court also refuses to create a right of recovery where one does not clearly exist.

This Court recognizes the efforts and resources expended by Counterclaimant's counsel, but ultimately, there is no applicable statute or rule of law creating a right to recovery for attorney fees on appeal, and absent such, attorney fees cannot be properly awarded. *Id.* Defending the original award on appeal was, in some regard, simply the cost of doing business.

Pursuant to this rule, attorney fees and costs on appeal are permitted *only* in those contexts where the Nevada Supreme Court finds the "appeal has been frivolously been taken or been processed in a frivolous manner." *Bobby Berosini, Ltd.*, 114 Nev. at 1356, 971 P.2d at 388 (quoting NRAP 38); *See also Bd. of Gallery History, Inc. v. Datecs Corp.*, 116 Nev. 286, 288, 994 P.2d 1149, 1150 (2000).

First, attorney fees cannot be properly awarded under NRS 18.010 as Counterclaimant suggests. In *Bobby Berosini, Ltd. v. People for the Ethical Treatments of Animal* (PETA), the Nevada Supreme Court specifically addressed this issue. Like Counterclaimant now does in this case, PETA sought attorney fees on appeal pursuant to NRS 18.010. The Court held that the desired attorney fees could not be recovered under NRS 18.010 because the language of the statute is silent with respect to attorney fees on appeal. *Id.* In line with that reasoning, this Court also refuses to create a right of recovery where one does not clearly exist.

This Court recognizes the efforts and resources expended by Counterclaimant's counsel, but ultimately, there is no applicable statute or rule of law creating a right to recovery for attorney fees on appeal, and absent such, attorney fees cannot be properly awarded. *Id.* Defending the original award on appeal was, in some regard, simply the cost of doing business.


