15 **STIPULATION TO EXTEND TIME TO FILE ANSWERING BRIEF**  
16 **(FOURTH REQUEST)**

17 Pursuant to NRAP 31(b)(2) of the Nevada Rules of Appellate Procedure,  
18 the parties hereby agree and stipulate that the time for Respondent/Appellee to  
19 file his Answering Brief shall be extended 33 days from the current date of  
20 November 27, 2013 to December 30, 2013.

21 The Parties remain in the final stages of settlement discussions. Aside  
22 from a single change, Appellee has agreed to all aspects of the settlement  
23 documents. Also, aside from the single change mentioned, Appellant's counsel

9 soon, which will enable them to dismiss the appeal from the Court’s docket.
