## MOTION TO FILE AMICUS BRIEF

Shellpoint Mortgage Servicing requests leave to file an *amicus curiae* brief in support of Bank of America, N.A.'s response to SFR Investments Pool 1, LLC's petition for rehearing. The motion is timely because it is filed seven days after Bank of America filed its response to SFR's petition for rehearing. Shellpoint's proposed amicus brief responds to the *amicus* briefs filed by Saticoy Bay, LLC, and TRP Fund IV, LLC.

Shellpoint has an interest in the outcome of the rehearing petition. Shellpoint is in the business of servicing residential mortgage loans. Shellpoint's servicing portfolio includes loans secured by real property in Nevada. Shellpoint services numerous loans that are currently in litigation over the impact of a Chapter 116 foreclosure sale. Many of these litigated loans include pre-sale tenders that were not recorded in the county recorders' offices. The outcome of SFR's rehearing petition will affect all of these loans.

An *amicus* brief is desirable to respond to the two *amicus* briefs filed in support of SFR's rehearing petition. Shellpoint's proposed *amicus* brief does not duplicate Bank of America's arguments. Instead, it responds solely to the arguments Saticoy Bay and TRP Fund made regarding equitable subrogation under the Restatement (Third) of Property: *Mortgages* § 6.4 (1997). SFR did not argue for equitable subrogation, and Bank of America did not directly respond to the

amicus briefs. Having allowed Saticoy Bay and TRP Fund to present their subrogation argument as amicus parties, the Court would benefit from allowing Shellpoint to respond via its proposed amicus brief.
