Attached is an unbound, original

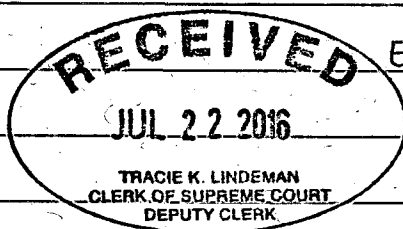
