To the Honorable Court Of Appeals Of The State Of Nevada:



Arreguin and myself, in such I was asking permission to have both our children (Carlos Adrian Ramirez Arreguin 9 years old, and Eduardo Javier Ramirez Arreguin 11 years old) spend some quality time together with me, being that it was Father's Day, and also to avoid any jealousy issues between them, due to the fact that Carlos and me have from 2:30 pm to 9:00 pm on Sundays for visitation, and with Eduardo from 5:30 pm to 8:00 pm on Wednesdays..

Although I asked and presented the parenting plan to her, I got a negative reply without any reasoning and/or arguments as to why, they couldn't be together.

Her actions don't fall into the Court recommendations that "she is the most suitable parent to allow the other parent access to the children", during the hearing in October, 2016.

I am so devastated that her alienating actions are taking a toll on the children and myself.

Most and foremost I fear that besides this, there's also the possibility that with the Emigration raids that are happening along the country, and due to her legal status she may be deported and I just don't know where or what would happen if the children get involved or lost into the process, until me or somebody claims them as legal citizens.




