This year I received \$ 88,000.00. I paid mortgage because the home had been foreclosed, Because Brian refused to split the community property. The remaining money, I paid attorney fees and interpreter fees, and I returned some of the debt (which we owed when we separated). Brian has more than 120,000.00 incomes each year. He still has several accounts (not frozen). And I am \$ 1950.00 per month alimony. He has money to pay lawyers to help him write the documents. And I have no money to find a lawyer to help. This is not fair to me.

I think Brian wrote "Appellant's Informal Brief," and his motivation is simply continuing to refuse to divide community property and delay time. His actions are a waste of courts public resources, a waste of my money (attorney fees and interpreter fees), waste of times and efforts. SO, I OPPOSE. I humbly request the Court to reject Brian' s "informal brief" , and uphold the original verdict, or the judgment give me relief.


