Comes Now, Brian O'Keefe, pro per appellant to humbly recognize this case, even now on appeal, seems clearly to have stalled.

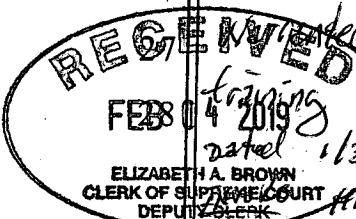
