On April 18, 2019, this Court ordered counsel for Mr. Gould to either (1) file a motion for the substitution of the personal representative of Mr. Gould as a party in these appeals, (2) inform this court whether additional time is required for the substitution of a personal representative, or (3) inform this court that Mr. Gould has no personal representative. Order Consolidating Appeal, Reinstating Briefing, and Regarding Motions at 2-3. Counsel for Mr. Gould hereby informs the Court that additional time is required for substitution of a personal representative.

John Carmack, a probate attorney based in Los Angeles who has been handling matters relating to Mr. Gould's estate, has informed the undersigned counsel that Mr. Gould's wife is expected to be appointed the executor of Mr. Gould's probate estate. At the moment, however, no executor/personal representative has been appointed. A hearing in which to appoint Mr. Gould's wife as representative for the probate estate was scheduled for March 2019, but that date was vacated for medical reasons. The hearing has not yet been rescheduled. As a result, we request a 90-day extension of time in which to file a motion for the substitution of the personal representative of Mr. Gould as a party in these appeals.
