Appellants in Case No. 77733, Reading International, Inc., Ellen Cotter, Margaret Cotter, Guy Adams, Douglas McEachern, Edward Kane, Judy Coddling, Michael Wrotniak,¹ and Respondent in Case No. 77733, James J. Cotter, Jr., by and through their respective counsel of record, pursuant to Nev. R. App. P. 26(b)(2), hereby present their stipulated motion to extend the deadline for the filing of the Opening Brief in Case No. 77733 from the current due date of May 17, 2019, to and including May 31, 2019.

This is an amendment of the second request for an extension of the deadline for this Opening Brief, submitted May 15, 2019; this Court has not yet ruled on that Second request. Prior to the May 15 request, Counsel for RDI had previously requested and been granted a two-week extension, changing the due date from the originally scheduled May 3, 2019 to May 17, 2019.

This request is not made to delay the proceedings. As stated in the Stipulated Motion dated May 15, 2019, Counsel for RDI had surgery performed on May 9, 2019. She had anticipated such surgery would have only a small effect on her ability to work on this matter, and would not prevent completion by May 17, 2019, but not only that not been the case, but her estimate that another week would suffice has also proven overly optimistic. However, based on current status and condition, RDI's

counsel is confident that an additional week's time will prove sufficient. Counsel notes that the total requested extension of time for this deadline will be 28 days.

The Parties agree that this additional alteration of this due date for the Opening Brief also does not require a change in any of the new due dates requested in the Stipulation filed on May 6, 2019.
