On April 18, 2019, the Court ordered that counsel for William Gould (1) file a motion for the substitution of the personal representative of Mr. Gould as a party in these appeals, (2) inform the Court whether additional time is required for the substitution of a personal representative, or (3) inform the Court that Mr. Gould has no personal representative. At the moment, however, there is still no executor/personal representative. Counsel will file the motion for substitution after the executor is appointed on August 14, 2019.
