**NOTICE OF APPEAL OF ORDER 02/13/2019.**

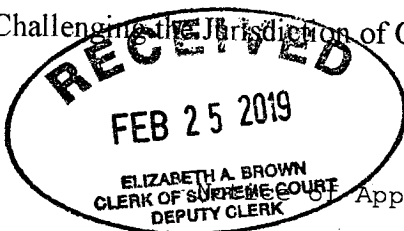




