affidavit attached to the original verified application.



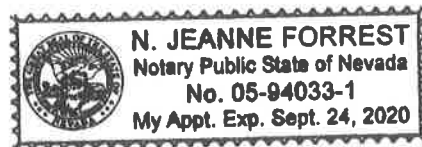
