**RESPONDENTS' ERRATUM TO ANSWERING BRIEF**

Respondents Pahrump Fair Water, LLC, Steven Peterson, Michael Lach, Paul Peck, Bruce Jabeour, and Gerald Schulte (collectively, "PFW") hereby submit this Erratum to correct an error contained within its Answering Brief filed on March 26, 2019. The following sentence appears at the end of page 26 of the brief:

Accordingly, the State Engineer is "without discretion to violate express statutory language *even where the equities lie in favor of doing so.*"

PFW has recently become aware that the end quotation marks in the sentence were inadvertently placed in the wrong location and thereby incorrectly identify paraphrased material as a direct quote. The sentence should read as follows:

Accordingly, the State Engineer is “without discretion” to violate express statutory language *even where the equities lie in favor of doing so*.

A similar sentence, with the same error, also appears in the Joint Appendix at JT APP 4966 and should be corrected in the same manner. In addition, the citation in footnote 89 at end of the subject sentence should be corrected to read as follows:

*State Eng’r v. Am. Nat’l Ins.*, 88 Nev. 424, 426-27, 498 P.2d 1329, 1330-31 (1972); *see also Great Basin Water Network v. State Eng’r*, 126 Nev. 187, 194-95, 234 P.3d 912, 916-17 (2010).

Respondents apologize for any confusion caused by this error.
