On April 18, 2019, the Court ordered that counsel for William Gould (1) file a motion for the substitution of the personal representative of Mr. Gould as a party in these appeals, (2) inform the Court whether additional time is required for the substitution of a personal representative, or (3) inform the Court that Mr. Gould has no personal representative. Order Consolidating Appeal, Reinstating Briefing, and Regarding Motions at 2-3. On June 26, 2019, the Court granted counsel for William Gould 90 days within which to file a motion for substitution of the personal representative of Mr. Gould as a party in these appeals, and ordered that counsel for Mr. Gould respond to the court's order by August 2, 2019. June 26, 2019 Order at 3.

Counsel for Mr. Gould hereby request an additional 30 days in which to file a motion for the substitution of the personal representative of Mr. Gould as a party in these appeals. John Carmack, a probate attorney based in Los Angeles who has been handling matters relating to Mr. Gould's estate, has informed the undersigned counsel that the hearing to appoint Mr. Gould's wife as the executor of the estate has been set for August 14, 2019, and that all of the appropriate notices have gone out. At the moment, however, there is still no executor/personal representative. Counsel will file the motion for substitution after the executor is appointed on August 14, 2019.
