Appellant, Las Vegas Metropolitan Police Department (“LVMPD”), by and through its counsel of record, Marquis Aurbach Coffing, hereby moves this Court pursuant to NRAP 31(b) for a 45-day extension of time to file LVMPD’s petition for rehearing.
