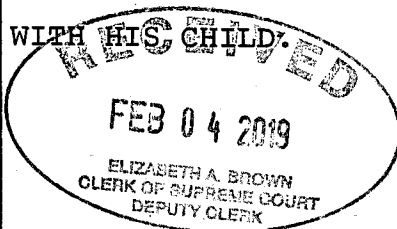
APPELLANT FREDERICK O SILVER MOTION TO CHANGE CASE SHORT CAPTION

4 knowledge of Frederick O Silver (appellant).


5 Till this date 1st February 2019, more than \$39,000 has been
