NOTICE OF APPEAL OF ORDER 02/26/2019 TO THE UNITED STATES SUPREME COURT.

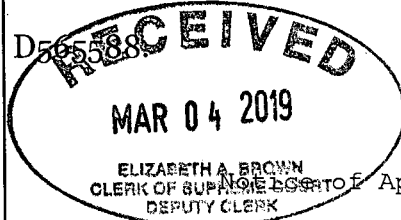




