THE COURT: All right. Thank you, Ms. Husted.

Ladies and gentlemen, you should distinctly understand that the Information just read to you is simply a description of the charges made by the State against the defendant. It is not evidence of anything. It does not prove anything. The defendant starts out with a clean slate. The defendant has pled not guilty and is presumed innocent.

This is a criminal case and there are two basic rules you must keep in mind. First, the defendant is presumed innocent unless and until proved guilty beyond a reasonable doubt. The defendant is not required to present any evidence or prove his innocence. The law never imposes upon a defendant in a criminal case the burden of calling any witnesses or introducing any evidence.

24 Second, to convict, the State must prove beyond a 25 reasonable doubt that the crime is committed and the defendant

1 is the person who committed the crime.

2	It will be your duty to decide from the evidence to
3	be presented whether the defendant is guilty or not guilty.
4	You are the sole judges of the facts. You will decide what
5	the facts are from the evidence which will be presented.
6	The evidence will consist of testimony of witnesses
7	and documents and other things received into evidence as
8	exhibits. You must apply the facts to the law which I shall
9	give you and in that way reach your verdict.
10	It is important you perform your duty of determining
11	the facts diligently and conscientiously for ordinarily there
12	is no way of correcting an erroneous determination of facts by
13	the jury.
14	You should not take anything I may say or do during
15	the trial as indicating my opinion as to how you should decide
16	the case or to influence you in any way in your determination
17	of the facts. At times I may even ask questions of witnesses.
18	If I do so, it is for the purpose of bringing out matters
19	which should be brought out and not in any way to indicate my
20	opinion about the facts or to indicate the weight or value you
21	should give to the testimony of a witness.
22	There are two kinds of evidence, direct and
23	circumstantial. Direct evidence is testimony about what the
24	witness personally saw, heard or did.
25	Circumstantial evidence is indirect evidence. It is

proof of one or more facts from which one can find another fact. By way of example: If you wake up in the morning and see the ground, the sidewalks and the streets are all wet and water is running down the gutters, you may find from those facts that it rained during the night. It is proof of one or more facts from which you can find another fact.

Conversely, if you are awake during the night and saw the rainfall, that would be direct evidence, which is something you personally saw. You may consider both direct and circumstantial evidence in deciding this case. The law permits you to give equal weight or value to both, but it is for you to decide how much consideration to give to any evidence.

14 Certain things are not evidence and you must not 15 consider them as evidence in deciding the facts of this case. 16 They include: Statements and arguments by the attorneys, 17 questions and objections of the attorneys, testimony I 18 instruct you to disregard, and anything you may see or hear if 19 the Court is not in decision, even if what you see or hear is 20 done or said by one of the parties or one of the witnesses.

21 Remember, evidence is sworn testimony from the 22 witness stand by a witness while court is in session and 23 documents and other things received into evidence as exhibits. 24 There are rules of law which control what can be 25 received into evidence. When a lawyer asks a question or

offers an exhibit into evidence and the lawyer on the other sides thinks that it is not permitted by the rules, that lawyer may object. If I overrule the objection, the question may be answered or the exhibit received. If I sustain the objection, the question cannot be answered and the exhibit cannot be received.

7 Whenever I sustain an objection to a question, 8 ignore the question and do not guess what the answer might 9 have been. Sometimes I may order evidence stricken from the 10 record and tell you to disregard or ignore such evidence. 11 This means when you are deciding the case you must not 12 consider the evidence which I have told you to disregard.

It is the duty of a lawyer to object to evidence which the lawyer believes may not be permitted under the rules. You should not be prejudice in any way against the lawyer who makes objections on behalf of the party the lawyer represents. Also, I may find it necessary to admonish a lawyer. If I do, you should not be prejudice towards the lawyer or client because I found it necessary to admonish him.

20 Only if you find the defendant guilty of 21 first-degree murder will the jury decide the sentence the 22 defendant may receive.

At the end of the trial, you'll have to make your decision based on what you recall of the evidence. You will not have a written transcript to consult and it is difficult

and time consuming for the Court recorder to play back lengthy 1 2 testimony. Therefore, I urge you to pay close attention to 3 the testimony as it is given. If you wish, you may take notes to help you remember what witnesses said. If you do take 4 5 notes, please keep them to yourself until you and your fellow jurors go to the jury room to decide the case. Do not let 6 7 note taking distract you so that you do not hear other answers 8 by witnesses. You should rely upon your own memory of what 9 was said and not be overly influenced by the notes of other 10 jurors.

Do not make up your mind about what the verdict should be until after you've gone to the jury room to decide the case and you and your fellow jurors have discussed the evidence. It is important that you keep an open mind.

A juror may not declare to a fellow juror any fact relating to this case of which the juror has knowledge. If any juror discovers during trial or after the jury has retired that that juror or any other juror has personal knowledge of any fact in controversy in this case, that juror shall disclose that situation to me in the absence of the other jurors.

This means that if you learn during the course of the trial that you have personal knowledge of any fact which is not presented by the evidence in this case, you must declare that fact to me. Once again, you communicate to the

1 Court through the bailiff.

2 During the course of this trial the attorneys for 3 both sides and all court personnel other than the bailiff are 4 not permitted to converse with members of the jury. These 5 individuals are not being antisocial. They are bound by 6 ethics and the law not to talk to you. To do so might 7 contaminate your verdict.

8 The trial will proceed in the following manner. The 9 deputy district attorney will make an opening statement which 10 is an outline to help you understand what the State expects to 11 prove. Next, the defendant's attorney may but does not have 12 to make an opening statement.

13 Opening statements serve as an introduction to the 14 evidence which the party making the statement intends to 15 prove. The State will then present its evidence and counsel 16 for the defendant may cross-examine the witnesses. Following 17 the State's case, the defendant may present evidence and the 18 deputy district attorney may cross-examine those witnesses. 19 However, as I have already said, the defendant is not required 20 or obligated to present any evidence or to call any witnesses.

After all the evidence has been presented, I will instruct you on the law. After the instructions on the law have been read to you, each side has the opportunity to present oral argument. What is said in closing argument is not evidence. The arguments are designed to summarize and

interpret the evidence. Since the State has the burden of proving the defendant guilty beyond a reasonable doubt, the State has the right to open and close the arguments.

After the arguments have been completed, you will retire to deliberate on your verdict.

e Jurors are now permitted to ask questions of 7 witnesses. If you have a question for a witness, I ask that 8 you write it down using a full sheet of your notebook paper 9 and then wait until the attorneys for both sides have had an 10 opportunity to question the witness, because very often one of 11 the lawyers will ask your questions. Then, if not, please get 12 my attention or the bailiff's attention and he will retrieve your question. The questions from the jurors are governed by 13 14 the same rules of evidence which control the questions that 15 are admissible that the lawyers ask. So please don't be 16 offended if I don't ask one of your questions. That does not 17 mean it's not a good question or an interesting question, but 18 it could call for hearsay or some other type of inadmissible 19 evidence, and for that reason I may not be asking your 20 question.

That concludes my introductory remarks.

Is the State prepared to go forward with their opening statements?

Hadland.

9 Timothy Hadland is a friend of Deangelo Carroll's. 10He's an individual that he worked with for other six months 11 and he was a former employee of the Palomino who left under some argument as to whether or not TJ was doing something 12 13 wrong at the Palomino Club or not. But Mr. Carroll and what 14 the evidence will show is that TJ was bad mouthing the club to 15 cab drivers and causing the club to lose money. The Palomino 16 Club, as you've heard before, is a topless -- actually, it's a 17 fully nude bar that actually serves alcohol, the only one here 18 in the valley that does both of those things.

19 The truth of this case is that five years ago today, 20 Mr. Carroll goes and finds a hit man that he knows by the name 21 of Kenneth Counts. He loads up his van with both himself and 22 a juvenile by the name of Jayson Taoipu, an individual by the 23 name of Rontae Zone and Mr. Counts.

He lures TJ out to a dark area, because TJ was out by the lake. He lures him off to North Shore Road, and when

13 Luis Hidalgo, Jr., Mr. H, he has two managers of his 14 club. He has his son, Luis Hidalgo, III, also known as Little 15 Lou, and Anabel Espindola. You will hear her referred to as a 16 manager and handles all the sheets and the paperwork for the 17 You'll hear her referred to as the manager, but Palomino. 18 she's also the long-time girlfriend of Luis Hidalgo, Jr., 19 There's Mr. Carroll back in 2005. Mr. H.

20 Mr. Carroll's job at the Palomino is kind of a 21 rover. He does kind of everything. He'll work the front 22 door, he'll DJ for a period of time, and then he'll do what's 23 known as promotions. What you'll learn is that cab drivers 24 get paid when they bring employees to the Palomino Club that 25 are -- sorry, when they bring customers to the Palomino Club.

They get paid money, the cab drivers do, for bringing the business up there. If the person who's coming to the club 3 doesn't have a VIP card, they pay more money, the cab driver 4 gets paid more money. 6 And that all will becomes important, but what 7 happens is Mr. Carroll's job is to go out and tell the cab 8 companies as well as go down the Strip and hand out 9 information, VIP cards to potential customers in order to get 10 business up to North Las Vegas because business is very 11. dependent up there on the cab rides that come there as well as 12 the people who will go there, the customers going traveling 13 out of their way, because it's not in the normal area of town 14 where most of the strip clubs are.

15 Mr. Carroll has a couple of younger friends. Rontae 16 Zone here is, I think, 18 years old on the day of the murder. 17 Jayson Taoipu is actually 17 years old. They're two kids. 18 They're not employees of the Palomino, but they -- Mr. Carroll ٦S provides a couple of dollars, 20, \$30 a day for Jayson and 20 Rontae to help go around and pass out these fliers and pass 21 out this information to the cab companies. And on May 19 of 22 2005 both Jayson and Rontae are with Mr. Carroll during the 23 daytime promoting.

24 Another player you need to know about is Kenneth 25 Counts, KC. Mr. Counts lives across the street from Deangelo

Carroll and catercornered from his mother's house.
Mr. Carroll has known Mr. Counts for a period of time and he knows that Kenneth Counts is the type of guy who would kill somebody for money. And he confirms it with him that he'll kill somebody for money. And you'll learn that Mr. Carroll actually utilizes Mr. Counts to commit the killing because Mr. Carroll doesn't actually want to pull the trigger.

3 What's the story of what happened on May 19th? Э Mr. Carroll's using the white van to promote the club. He has 10 Jayson and Rontae with him. And he tells Jayson and Rontae 11 that Mr. H wants somebody -- and the term he used is "dealt 12 with." You will hear Rontae tell you that he knew that meant. 13 to kill him. You will hear that Jayson says, Yeah, I'm 14 willing to do that. You'll also hear that Rontae says, No, I 15 don't want any part of this.

 realize Deangelo's the last phone call, Mr. Hadland left to go
 see Deangelo. Deangelo works at the Palomino. There's
 Palomino cards on the ground. They think to themselves, Hey,

MR. DiGIACOMO: Absolutely no legal basis. We had a five-minute discussion at the bench. There's no legal basis for the objection. The Court has previously ruled on the admissibility of this item which means I had a good-faith basis to believe that it was admissible.

The statute says that if I do not play a portion that they think is appropriate, they're free to play whatever portion that they want to after my opening. They clearly knew we were putting in Deangelo Carroll's statement, so they were free to put in whatever section that they wanted to put in, and they chose not to do so.

Even prior to the opening they made a record about the two wire recordings and they knew -- because I told them
