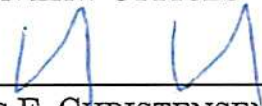
STIPULATION FOR EXTENSION TO FILE REPLY BRIEF

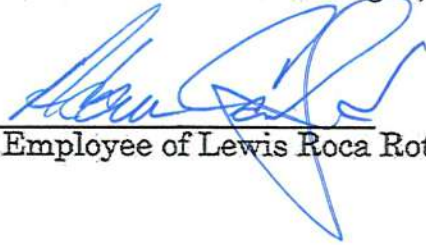
