25	residential real estate transaction. Appellants are accused of failing to disclose relevant and
26	material information, as required by NRS 645.252, about the size of the living space in the
27	structures on the property and about the size or capacity of a septic system that served the
28	property.

The district court found that the buyers (respondents herein) should have discovered the amount of living space in the property during the due diligence period. The district court found, however, that the seller's broker and agent (Appellants herein) should have known and disclosed that the septic system of the property was too small. The actual size of the septic tank was determined by inspection during the due diligence period of the escrow. Buyers were provided with the report of that inspection and signed that they had read and approved that report. They further signed that they waived and released any recourse pertaining to that system.

The court also found that the appellants suffered actual damages in the amount of some \$27,000, the cost to add additional septic system capacity. Appellants submit that the addition of that capacity was not damages because it increased the value of the property. The sellers settled the claim against them for \$50,000. The buyers licensees settled the claim against them for \$7,500. Appellants made an offer of judgment of \$5,000, which was rejected. At the point in time when the rejection of that offer was made the buyers had incurred some \$13,000 in attorney's fees and \$27,000 in alleged damages. At the same point in time, respondents had recovered \$57,500 in combined settlements. The appellants offer would have brought the respondents total recovery to \$62,500. The court has finally granted attorneys fees of \$48,000, on a showing of claimed hourly time and charges. However, respondents' counsel was employed under a contingent fee agreement. Also, interest was awarded on the full attorney's fees were not incurred until 2017 and 2018.

Of the damages awarded to Plaintiffs, to avoid a double recovery associated with the 2. cost to enlarge the septic tank found at the property, these costs (\$27,663.95) must be off-set by amounts Plaintiffs recovered by way of settlements from other defendants in this case that settled with the Plaintiffs prior to trial. The amount Plaintiffs settled with their own realtor (\$7,500.00) will be deducted from this amount. The Court finds, however, that the settlement with the sellers in this case (\$50,000.00) cannot all be attributed to the costs of enlarging the septic tank and obtaining a variance, because Plaintiffs possessed significant multiplying claims against the sellers under NRS 113.150 which Plaintiffs could not recover from the remaining Defendants, whereby the Plaintiffs would be entitled to treble damages against the sellers associated with any claim established under NRS 113.150.
