# AGREED MOTION TO STAY OR EXTEND BRIEFING FOR 90 DAYS OR, IN THE ALTERNATIVE, FOR A 45 DAY EXTENSION TO FILE THE BRIEF OF RESPONDENT

With Appellant's agreement, Respondent, Brahma Group, Inc. ("Brahma"), hereby moves the Court for a ninety (90) day extension of the current briefing schedule. Specifically, Brahma proposes (and Appellant, Tonopah Solar Energy, LLC ("TSE") concurs) that the following briefs be due on the following dates:

The Parties have re-opened previously dormant settlement discussions and agree that a 90 day stay or extension of the remaining briefing schedule would be useful to that process. Brahma and TSE would like to focus their efforts on a resolution rather than preparing the extensive briefing that is otherwise required.

<u>Alternatively</u>, Brahma requests an extension of 45 days to file the Brief of Respondent. This is Brahma's second request for an extension. Brahma requests 45 days rather than the typical 30 days because of the intervening holidays. If granted, Brahma's request would make its Brief of Respondent due on Monday January 20, 2020 (the 45th calendar day is a Saturday).

TSE filed its Brief of Appellant on October 3, 2019. The Brief of Appellant was initially due on July 30, 2019. By way of stipulation, TSE's deadline was extended to August 29, 2019. TSE then moved to extend its deadline pursuant to NRAP 31(b)(3), which was granted and which moved its deadline to September 12, 2019. On September 12, 2019, TSE again moved the Court for another extension, to

October 3, 2019. TSE has, therefore, requested and received a total of more than 60 days of extensions, to which Brahma stipulated or did not oppose. Brahma's request allows for a few more total days than TSE received, but as noted, this is to account for the holidays and client and counsel unavailability during that time.

Based on the foregoing, Brahma respectfully requests that the Court grant Brahma a stay or extension of the remaining briefing schedule for 90-days as set forth in the table above. Alternatively, Brahma request an extension to file its Brief of Respondent for 45 days - to no sooner than January 20, 2020.
