REPLY BRIEF ON MOTION FOR EXTENSION TO FILE ANSWER

Real party in interest United Automobile Insurance Company (UAIC) appreciates the Court's granting an extension through July 10 to answer the petition in Docket No. 78243. The Court should likewise grant the requested extension through July 17 to answer this petition.

Counsel's medical and other issues are not "just excuses," as petitioner alleges. Counsel have been working on the answers despite these setbacks and hope for a swift resolution of the petitions. Causing complexity, however, is petitioner's joint pursuit with real party Nalder

of the "finalization of a judgment" against him—rather than a determination that he is not subject to any valid judgment. The questions of UAIC's intervention and consolidation are bound up with these determinations, and if the Court is going to hear either petition, it needs to understand these circumstances.

UIAC asks this Court to recognize the propriety of an extension in this situation and grant the request.
