**ORDER REMOVING FROM SETTLEMENT PROGRAM
AND REINSTATING BRIEFING**


Pursuant to the recommendation of the settlement judge and good cause appearing, this appeal is removed from the settlement program. See NRAP 16. Accordingly, we reinstate the deadlines for requesting transcripts and filing briefs.

While this appeal was assigned to the settlement program, appellant filed a transcript request form.¹ See NRAP 16(a)(1) (upon the clerk's issuance of a notice that an appeal has been referred to the settlement program, the time for requesting transcripts and filing briefs is automatically stayed). Court recorder Yvette G. Sison shall have 30 days from the date of this order to prepare and deliver the requested transcript and to file a certificate with this court acknowledging the delivery of the transcript. See NRAP 9(b).

¹The clerk shall attach a copy of that transcript request form to this order.

Appellant shall have 90 days from the date of this order to file and serve the opening brief and appendix.² Thereafter, briefing shall proceed in accordance with NRAP 31(a)(1).

It is so ORDERED.
