Free Radon Test Kits For Storey County Residents

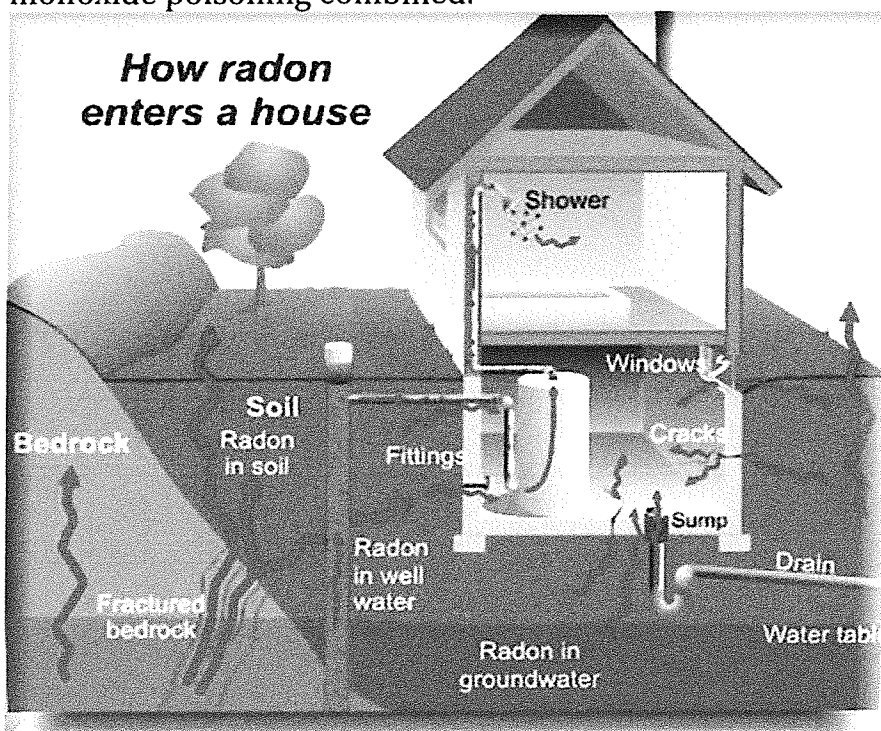

January is National Radon Action Month, and University of Nevada Cooperative Extension's Radon Education Program is offering free short-term radon test kits to Storey County Residents on February 15th.

Radon test kits are available at Cooperative Extension offices and partnering locations, as well as at presentations statewide.

Radon is a naturally occurring, radioactive gas that's colorless, odorless and tasteless. It comes from the ground and can accumulate in homes, raising the risk of lung cancer. The U.S. Environmental Protection Agency estimates 21,000 Americans die each year from radon-caused lung cancer, killing more people than secondhand smoke, drunk driving, house fires and unintentional carbon monoxide poisoning combined.



In Nevada, one in four homes tested show radon concentrations at or above the EPA action level. Living in a home with radon concentrations at the action level poses a risk of developing lung cancer. . This risk is similar to the risk posed by smoking about half a pack of cigarettes a day.

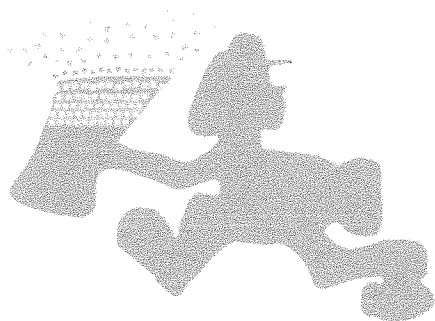
The risk of radon-caused lung cancer can be reduced. A simple three-day test can determine if a house has a radon problem, and winter is an ideal time to test a home for radon. If radon problems are found, they can be fixed.

Free Radon Test Kits distributed on February 15th 2018 at the Storey County Senior Center at 12:45 p.m.

The University of Nevada Cooperative Extension's Radon Education Program will hold a presentation to discuss Radon and the Free Test Kits on February 15th 2018 at the Storey County Senior Center, 100 Mill St., Virginia City, at 12:45 p.m. For those who can't attend a presentation, free radon test kits are available through Feb. 28 at the Storey County Library, 175 E. Carson St., Virginia City.

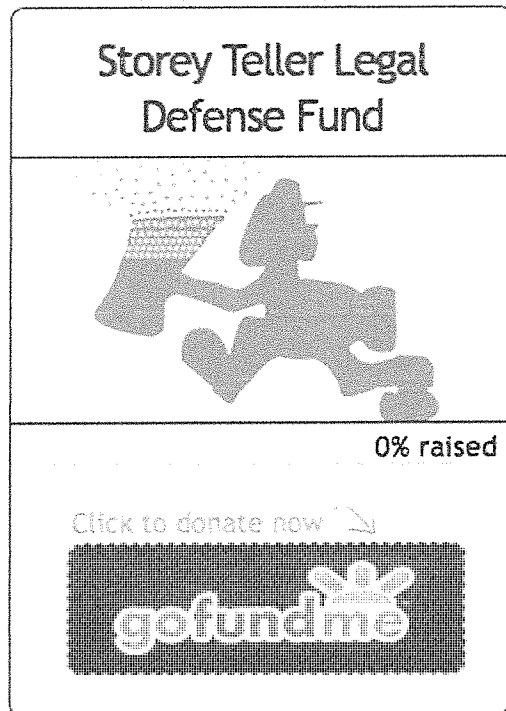

Shame on you and the dinosaur you rode in on.

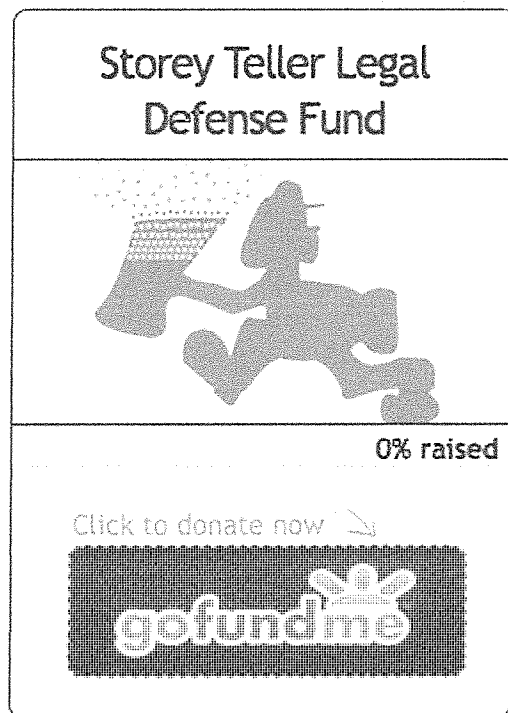

TRIC Sells All Remaining Property At Center

Mustang Ranch Brothel Owner, TRIC Marketing Manager, and Storey County Commissioner Lance Gilman alluded to “a major deal in the works” during recent Commissioner Meetings. Gilman announced today that all remaining available property owned by TRIC has been sold.

Gilman announced yesterday that TRIC has sold the remaining 74,000 acres of available property most of it to a tech company who put down cash to purchase 64,000 acres last week. Blockchains, LLC, (<https://www.blockchains.com/>) currently headquartered in Canoga Park, has purchased the majority of the remaining open space and will most likely build a large facility on the expansive swath of desert.

“And while they have not announced their specific plans for the land, I suspect that they will be building a large facility on one large site in Comstock Meadows along USA Parkway/Infinity Highway, very near the Google site, and adjacent to the Reno Land Tech Park,” Gilman said in a statement. “They purchased all our remaining developable land which has superb facility site possibilities.”

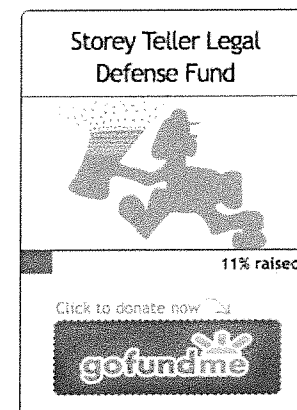
104,000 Acres Sold in 17 Years

Roger Norman and Lance Gilman purchased the 104,000-acre property in 2001. Since then they have built a world-class business park that houses some of the top names in technology. Tesla, Switch, and Google all have purchased land in the park and the growth is really starting to take off. With this purchase, Blockchains will own 62% of the land.

Investors and Developers have also purchased land at TRIC, completing the sellout. As Blockchains begins to recruit people to move to Northern Nevada, further expansion in the region is underway.



TRIC Effluent Pipeline Financing Pulled From GOED

In what may (or may not) be an epic win for Storey County Taxpayers, the effort to use SB1 to fund the TRIC effluent pipeline has been withdrawn from consideration by the Governor's Office of Economic Development (GOED). Jeremy Aguero of Applied Analysis announced the decision at the January 18th GOED board meeting.

"I am here today to announce that we are withdrawing the economic development and financing proposal that was submitted to GOED several months ago. All the parties involved in the project understand that it is an important economic development effort and the project continues to move forward. The shift in approach is due technical challenges that were incurred when working through the details of original financing option," explained Aguero.

Pipeline To Carry "Liquid Gold" To TRIC

The pipeline project was first floated in early 2017 when lawyers from Switch and the Tahoe Reno Industrial General Improvement (TRI-GID) began the heavy lifting of navigating the choppy waters of Truckee water rights. They needed to cut deals with the cities of Reno and Sparks, Washoe County and the water districts in the area.

The pipeline is designed to move effluent that would otherwise be discharged into the Truckee or pumped back into the ground to a treatment center in TRIC. This would provide the high tech occupants of the park with a plentiful and reliable source of water to cool the data server farms who enjoy 75% abatements of property and sales taxes thanks to legislation promoted by GOED.

County Taxpayers Opposed Paying For Project

Citizens and activists joined The Teller to express concern that creating a special tax district to divert property and sales taxes away from other uses in Storey County to pay for the pipeline. People in the county were adamant that the wealthy users of the water pay for the water and not encumber the taxpayers. Town hall meetings were organized by Jay Carmona, who recently announced he will seek the County Commissioner's seat currently held by Jack McGuffey.

During a commissioners meeting, citizens spoke to oppose the use of taxpayer money to fund the pipeline. Nicole Barde of bardeblog.com covered the

meeting (which you can read [here](#)) and The Teller wrote critically about the initial “financing option” [here](#).

The Users Will Pay For The Water And The Pipeline – Or Will They?

“An alternative structure is being pursued that includes a special the development of a special improvement district, special assessment as well as *a tax increment district* through the states bond bank. This will mitigate the challenges that were originally encountered as well as facilitate the development of the pipeline project itself. The alternative approach does not require the creation of an economic development financing proposal or access to GOED’s bonding capacity, thus we withdraw this application today,” said Mr. Aguero.

He went on to say that he looked forward to working with Storey County Manager Pat Whitten to shepherd this project as time rolls on. So it looks like they are getting deep-pocket companies who will use the water to pay for some of the projects, but the use of the phrase “*tax increment district*” remains troubling.

Storey County Taxpayers In Peril. Still.

They probably still want to divert taxes that would normally come from to the coffers of Storey County. And we will continue to fight alongside you, gentle reader, to prevent this.

Once Mr. Aguero delivered his withdrawal, Governor Sandoval asked, “Short and sweet; so the State is out?”

“Um, no, no. I don’t think the state is necessarily out, per se. We’re continuing to move forward but the approach we are taking is without a doubt different. And so it doesn’t require GOED necessarily. And when we use the State’s Bond bank, I am hesitant to say the State is necessarily out,” stumbled Aguero.

Hmmm. Not Good.

Um, yeah. The State is not out. And neither are we.

What he said about continuing to work with Pat “a remarkable resource in this process” Whitten and Storey County does not bode well for us chumps, err.... taxpayers.

While we will continue to pursue this matter with al parties, we don’t expect to get much info from anyone. Trying to get information about this complex deal has been as hard as finding gold in the Lucerne Pit. At least GOED has a communication officer who responded (in an average of 10 days). Now that GOED is out of the picture, the cone of silence will surely descend on the matter.

Therefore it is critical to make sure you call Lance Gilman, Jack McGuffey and Marshall McBride to let them know you think the users of the pipeline should foot the bill, not us, the Storey County Taxpayers.

Don't be invisible. Call or email and give 'em hell.

USPS Responds to Virginia City Highlands Mail Issues

In a former life, we dealt with the United States Postal Service (USPS) on a daily basis with our clients who generated gobs of mail or our mailing houses clients who generated gobs and gobs of mail for their clients. Our experience with the USPS was excellent. While there were occasional problems, the service provided was by far as good as any we get from any government agency. Recently, the VCH email chat group has been aflame with unhappy folks dealing with a rash of issues. Below, The USPS responds to our outreach.

While some of those issues were not related to the USPS (theft and vandalism) many of the complaints surrounded poor service, misdelivered mail and a general lack of give-a-darn from the postal employees.

Teller Contacts USPS Management

Drawing from our past experience with the USPS, The Teller reached out to The United States Postal Service directly. I spoke to a couple of folks and ultimately talked to David Rupert who manages a large swath of the west including Nevada. We copied all the recent email threads and sent them to Mr. Rupert who in turn had a confab with the Reno Postmaster and the folks in Steamboat.

Here is his response:

Mr. Toll,

Thank you for reaching out to us to make us aware of some delivery inaccuracies during recent months. We had an emergency replacement on the route and the similarity in address numbers and names along with a lack of familiarity led to delivery errors which have since been rectified. We are working on some solutions to prevent a reoccurrence and deeply apologize for the inconvenience we caused our customers.

We also understand the sense of frustration when trying to relay these issues to local management. Our central phone number, 1800-ASK-USPS is great first step since it documents the issue and sends it directly to local managers for next-day resolution. We have very few complaints about these delivery issues registered through this system, so we are unable to assess the full breadth of the issue.

However, we still take the issues seriously and will vigorously work to continue our customer's trust.

We invite any concerned party to call the station manager, Sean Bardin, who oversees the Steamboat Station with any concerns and he'll be happy to pursue them until resolved. We are also trying to reach out to some of the customers in this thread to help them individually.

As you can read from his reply, residents of the Highlands are encouraged to follow procedure and put a call into the 800 number. Additionally, the Steamboat Station Manager, **Sean Bardin**, is responsible for serving the Highlands and is accessible.

The problems with stolen mail will continue to be an issue, but qualified personnel are back on the job and it looks like this recent rash of issues will be in the rearview mirror.

The Staff updates were few and are pretty well covered in County Manager Pat Whitten's summary.

Pat Whitten's update was focused on the Zip code issue which has been included in the Postal Reform act currently going thru Congress. It would give all of Storey County one zip code. In addition to including this change in the Postal Reform act it is also part of other bills which should give it a number of ways to get approved. Pat also mentioned that they are still working on trying to get the citizens of Storey County a tax rebate or rollback and mentioned that they have looked at how the state of Alaska and Oregon does this as a way to accomplish it for Storey. He noted that it may take legislative action to accomplish it.

During Board comments Commissioner, TRI Principal and brothel owner Lance Gilman gave a summary of his trip back to Washington DC as part of the Nevada Local Officials Convention. It's pretty well covered in Whitten's report but the thing of note was Lance's comment that it is President Trump's intention to "de-regulate America". The president wants to eliminate 2 regulations for every one new regulation that is enacted. Lance said that he was quite impressed

with this especially in light of the fact that it takes the Department of Transportation up to 9 years to get fully approved for major roads projects (like the spaghetti bowl and other interchanges). He noted that during the meeting with the Department of Transportation that they were eager to get moving on numerous infrastructure projects and that would like to see a 1 year turnaround for permitting in the future. This is important for Storey County since we have numerous traffic issues on I-80 near Lockwood and TRI that need immediate correction.

Agenda Item #14 was a review of the County Manager Job Description. This is a continuation of prior discussions which centered on placing limits to the County Managers authority to independently sign contracts and sign checks with limited Commission involvement. The recent “outrage” over Pat Whitten’s giving of hefty bonuses to a couple of his friends is just one example of what the Commission is trying to curtail. Legal counsel has suggested that the best way to put these types of limits on the County Manger is thru the County’s Administrative Policies and Procedures. Specifically they reviewed policy 042 which is around Contracts and Agreements and have limited the County Manager to have authority up to \$10,000 for contracts and agreements and no more that 10% of a total bid on change orders on existing contracts. Everything else needs to come before the board. There are 2 other policies which will be revised to include authority over Budgets and the retirement bonuses.

Lance agreed that there needed to be a strict limit on dollar amounts.

Comptroller Hugh Gallagher said that the business of the county has grown tremendously and with it a lot of financial and legal liability. That a single individual’s authorization level if too low is restrictive and too high without higher input and authorization places him/her at risk.

During public comment I asked if there was a compensation policy which could limit his actions. Meaning, could the county manager give out of cycle salary increases over what was initially approved for the year and if so how would that be limited. The answer was that there wasn’t a specific limit in the compensation policy.

Sam Toll, Editor of the Storey Teller, got up and agreed with Lance’s sentiment that there needs to be stricter controls since Pat’s successor may not be as sober minded about spending money.

This agenda topic and the approvals were continued to the January 2, 2018 meeting.

During Public Comment at the end of the meeting I got up to ask a clarifying question about Lance’s comment at the Lockwood open forum which he held on Wednesday November 1st.

During that meeting Lance said that the Bond that was being crafted to have the citizens of Storey County pay for the effluvium pipeline from Reno to the TRIC GID was basically dead since the county couldn’t qualify. So I asked for clarification on that this meant.

Bottom-line it means that the “structure” of the Bond didn’t fly because the size of the Economic District from which the revenue would come from to pay that bond was too small from a revenue standpoint. SB 1 which was crafted to provide the rules around abatements and other Economic Development activities stipulates the conditions for how debt can be raised. In this case the “Tax

increment area” approach is required.

The initial thinking was that the revenue from a subset of TRIC would be designated as the payback source. Meaning that the incremental revenue over and above the 2016 revenue levels for that small subset would pay the bond. That “small” subset includes Tesla, Google and Switch as the big players. The Tax increment area approach has a formula for how much of the revenue from that area can be used to pay the debt.....this subset, Tax Increment Area, didn’t qualify. Apparently based on back of the envelope calculations all of TRIC may not qualify.

That’s because the bond can only be paid by INCREMENTAL revenue over and above 2016 levels and since most of TRIC is already sold, and since the big players have tax abatements, and since most of the business license revenue has already been paid, and since the zip code sales tax issue hasn’t been resolved.....TRIC may never be able to qualify based on this approach.

It was stated during the meeting that Bob Sader, TRICs attorney, as well as J & A Consulting, the Las Vegas consulting firm helping Gilman and Norman structure this debt transfer, are working on an alternative solution. Apparently Bob Sader has declared the Tax Increment Area approach “on life support” due to any number of factors not the least of which are the vagaries of how to fund debt and how to create special tax districts.

The feeling in the room was hard to read...on the one hand when Kris Thompson, TRIC employee and Lance Gilman employee and roommate got up during public comment to put lipstick on this pig he said that the Bond hadn’t been heard by the board with jurisdiction over these matters. That it was a preliminary finding and that there were still a string of people for it to go thru.

On the other hand, the information I was given is not optimistic as far as having TRIC revenue paying for the Bond....just not enough incremental revenue in the short/medium run.

Sam Toll, Editor of the Storey Teller, got up to ask the Commission not to burden then taxpayers with this bond. He told them that those who benefit from the pipeline should be the one paying for it directly not by diverting TRIC revenues which belong to the citizens of Storey County.

Next Sam asked the Commission to schedule “workshops” as a separate meeting and after hours so that there can be more participation by Storey County Residents. As it stand now, these “workshops” are held as an agenda item within the Commission meeting and there isn’t enough time, or structure to allow people to hash things out and for the commission to gather robust inputs from the public.

This request fell on deaf ears....along with Sam’s prior requests to allow Public Comment at the beginning of the meeting as required by NRS.

Sam also asked if the \$900k budget for the transferred Fire Marshal and Business License functions has moved from the Fire District to Community Development. Pat Whitten replied that the Fire Marshal function was contracted out and not transferred out and that the General Fund has covered those services in the past. Pat noted that there will actually be savings all around as a result of the changes.

We recently shared our frustrations with Storey County Administration in what we considered to be stonewalling our request for information about the zoning of Mustang Ranch ([which you can read here](#)). Additionally, we question the residency status of two public officials; County Commissioner Lance Gilman and Planning Commissioner Kris Thompson.

Our investigation seeks information and answers to issues posed below:

The actual residence of Mr. Gilman and Mr. Thompson

In documents provided to County Clerk Vanessa Stephens, Gilman and Thompson list 5 Wild Horse Canyon and 56 Wild Horse Canyon Drive as their legal residences.

According to Assessor Jana Seddon, these addresses are associated with two sides of a doublewide trailer on blocks behind the swimming pool of The Mustang Ranch Brothel.

According to Mr. Thompson and Mr. Gilman, they are bunkmates in the doublewide

If Mr. Thompson indeed lives in the doublewide, according to Storey County Ordinance, he needs a work card. Our sniffing around suggests such a work card does not exist. As Brothel owner, if Mr. Gilman *actually* lives on site, he doesn't need a work card.

As you may know, The Storey Teller filed a complaint with the Storey County DA and the Nevada State AG and the Sheriff's Office regarding a public record request regarding the zoning of the Mustang Ranch and 5, 5B and 56 Wild Horse Canyon Drive.

Even though the public records request regarding the zoning status of the Mustang Ranch Property, which NRS requires an answer to within 5 days remains open six months after it was filed, I learned the Mustang Property is not zoned residential after a 3 minute visit to Community Development several months ago.

Both Lance Gilman and Kris Thompson claim 5, 5B and 56 Wild Horse Canyon as their legal residence when filing paperwork with the County Clerk to hold elected and appointed office.

Yet the entire Mustang Ranch parcel is not zoned for residential occupancy.

It is not legal for anyone to live there.

Since this is a Storey County Code violation and the proof of residency to hold public office claims the Wild Horse Canyon addresses, what action will be taken now that your departments have been officially advised of the violation?

What are the enforcement procedures?

Fines?

Red Tags?

Jail Time?

Wrist Slaps?

Please advise what action the County is taking to address this violation.

My readers have asked me why the county has not taken action on this matter.

As you know, the law applies to everyone equally, including those in power.

for \$43 million dollars.

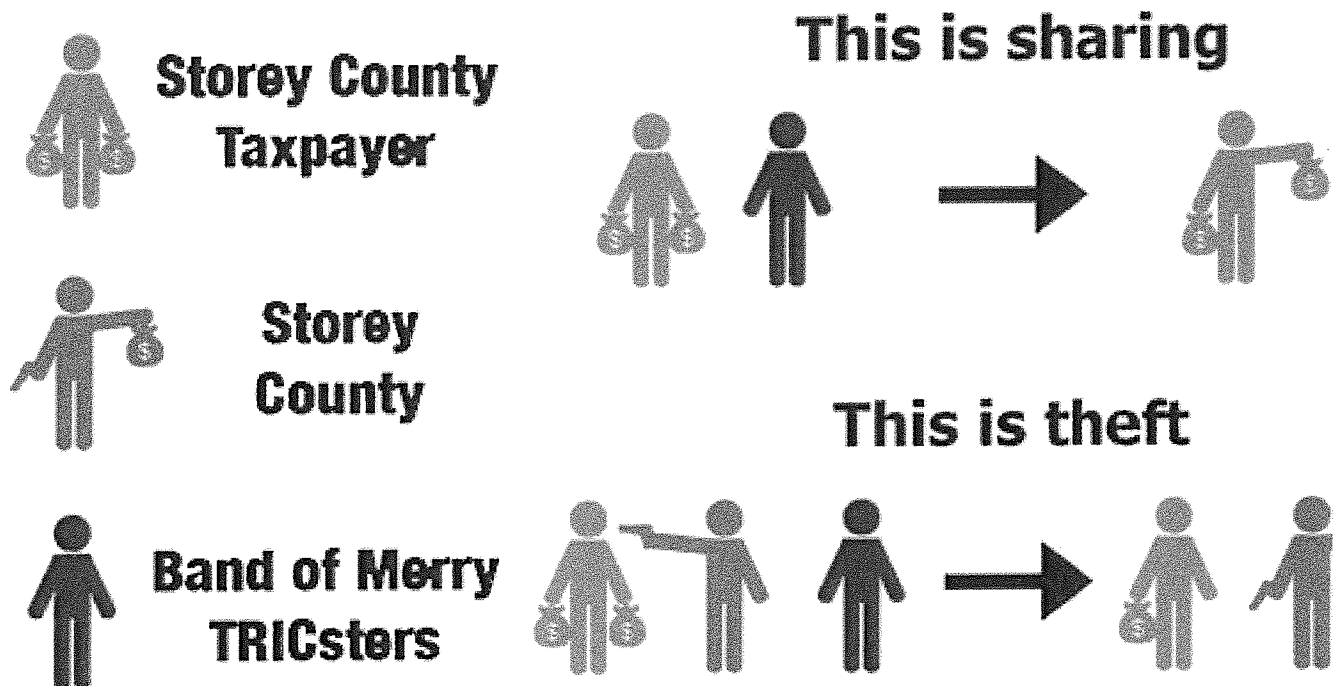
We give them land every time we turn around at Commissioner Meetings with zero financial consideration.

V&T Depot – The Spectre of Eminent Domain

Yesterday I engaged in a cheeky little tit for tat on Facebook with Comstock Chronicler Karen “Storey County Cheer Squad Princess” Woodmanse. She was curious about why I attacked the poor innocent little ol’ Mustang Ranch owner and his bunkmate for code violations (which you can read about here) yet remained silent about all the “violations of my friends”.

I’ll break my silence for Pom-Pom girl here.

The number of my friends cuts a pretty wide swath. According to the recall election tally of Sheriff Antinoro, there were 601 people who voted to recall him. Therefore, the rest of the county (about 3800 folks) I consider my friends. The only potential violation I could think of about concerning “my friends” might be the V&T Railroad Depot on D Street. The V&T Depot is owned by my lifelong friend Pierce Powell.

The V&T Depot Is A Firetrap!

People in the county suggest the V&T Depot (kinda like most wooden structures on the Comstock), is a fire hazard. While all of these fire hazards enjoy grandfathered code exemptions, the invisible hand of property insurance requires code compliance in most cases.

I recently interviewed Pierce Powell and Storey County Commissioner Marshall McBride about the disposition of the Depot.

Commissioner McBride explained Storey County has conducted negotiations with Mr. Powell regarding the purchase of the V&T over the past 5 years. They have conducted the negotiations in good faith getting an appraisal and providing what they consider to be a fair offer of \$710,000.

During this time Mr. Powell has lived in the Depot and has experienced several bouts of illness. “Pierce shared with me he is worried about living alone,” explained McBride. “His recent bout with illness has given him cause to think about the future of his living conditions.”

The Real Estate Appraisal came in at \$635,000 (done in August 2016 according to Mr. Powell). After agreeing to pay the estimated \$60,000 the county owes Powell for sewer pipe installation and connection fees, Commissioner McBride sweetened the pot by offering another \$15,000 for the Model A Ford Trucks and other accessories scattered around the premises. “We even agreed to give Mr. Powell an additional year to live in the depot after the sale so he can arrange for his possessions to be moved or sold.” Said McBride. “I asked him if he wanted to sell and he said he did. However, after giving him everything he asked for, he changed his mind.”

And change his mind he did.

Mr. Powell suggested that at the end of the day, the county simply isn't offering him enough money. Powell considers the county hounding him to sell at a price lower than he is willing to accept as unacceptable. The fact that the county would be retrofitting sprinkler connections and doing roof repairs during the year he is living there, wrangled Mr. Powell.

Then there is the sewer connection that the county has, ten years later, still not made good on. Pierce explained, "I gave them a sweet deal on the property that museum down there sits on, and included in that sale was an agreement to run a sewer line down here with six connections. I asked Whitten to get the line installed so I could buy and move a couple of those bungalows next to the courthouse down here, and he said there was no mention of a deadline for installation and the Public Works fellas are pretty busy. So I missed out on that opportunity."

"The last time I spoke to McBride he started yelling. He accused me of going back on my word. That's nonsense. I did say I wanted to sell, but I was scrupulously careful not to agree to his price. I never agreed to his price. So he stormed off and the next thing I know they want to take my building away from me and force me off the property."

"I was in Los Angeles when they put in the freeways; I know about the judicious use of Eminent Domain. Eminent Domain is used for the Greater Good for the Greatest Number of People the Community. How will the entire county benefit by stealing from me?" Said Powell.

When I posed the question of what they planned to do with the Depot, Commissioner McBride explained: "There are a number of things we could do with the Depot. Imagine punching the tunnel through and have a train engine turning around on a dial. People come from all over the world to see the cable cars turn around on Market Street. That would be something."

As he went on to describe other thoughts they've got on what to do with it once they get their mitts on it, and I love the idea of a steam engine turning on a turntable. However, it became pretty clear after talking to Commissioner McBride; they don't have an actual plan of what to do with it other than to install a sprinkler system in the building so it doesn't burn down.

Great ideas, no plan.

I agree with the sentiment in the courthouse and the snippy tat that Karen Woodmanse (mostly). It would be a crying shame if the building burned down. Contrary to what Karen suggests, I would not point my finger at the county and demand answers on “why they didn’t do something” to prevent this imaginary fire.

It is not the county’s pervue to be held responsible for every fire that may claim a building.

The County’s interest in this transaction claims to be the desire to prevent the building from being burned to the ground. They have not provided anything that could be mistaken for a sober, well thought out plan for using the building for the greater good of all people in the community. There is no project so critical to Virginia City or Storey County’s safety or public well being, infrastructure or otherwise, that is urgent enough to steal this man’s property.

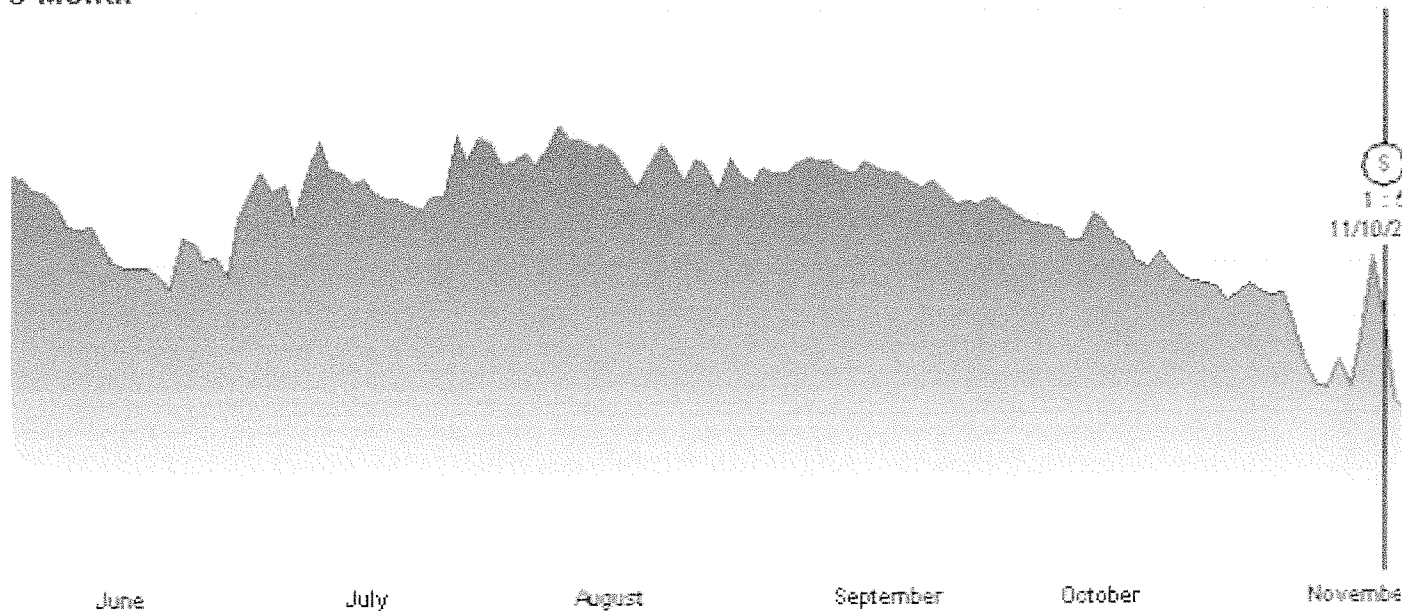
“That Trick Never Works” – Rocky The Flying Squirrel

This split satisfied the New York Stock Exchange’s minimum share price requirement and the company is and has always been compliant with all other requirements. We sincerely consider this just *a mechanical change that does not impact* our strategy, business plans, liquidity, operations or *the intrinsic value of the shares*. Our focus is on growing that value with an outstanding investor and share base.”

While the CFO considers it a “mechanical change”, the market sees a bit differently. The day before the split (November 9th), CMI’s stock went buck. At one point trading for 3x value; the volume was 6-7 times the normal shares changing hands. In the days since, the stock has tanked.

As you can see from the above chart, CMI's stock has fallen 50% since October. If they were set to be delisted at .13 a share, they seem to be headed for the inevitable. Trading at .40 a share at the time of this keyboard clattering, they are now at a pre-split equivalent share price of .08. OMG, that hurts.

Maximize Intrinsic Stockholder Value

This news does little to slow down the the spin doctors. With eloquence reserved for the toppest top-shelf Flim-Flammers, de Gasparis alongside CMI Shareholder Relations Officer and Comstock Chronicle Owner Zach Spencer, (*Wait.* What?) emote the following “forward-looking statement” tucked inside a truly remarkable Q3 statement which you can read **here**:

“The near-term goal of our business plan is to maximize intrinsic stockholder value realized, per share, by continuing to acquire mineralized and potentially mineralized properties, exploring, developing and validating qualified resources and reserves (proven and probable) that enable the commercial development of our operations through extended, long-lived mine plans that are economically feasible and socially responsible.”

How's that Intrinsic Shareholder Value working out, CMI Shareholder?

Oh, and yes, Zach Spencer, with his wife Elaine (former CMI public relations employee), own the Comstock Comical... err Chronicle.

The next time you see an article about CMI in the Comical, you know who's getting paid.

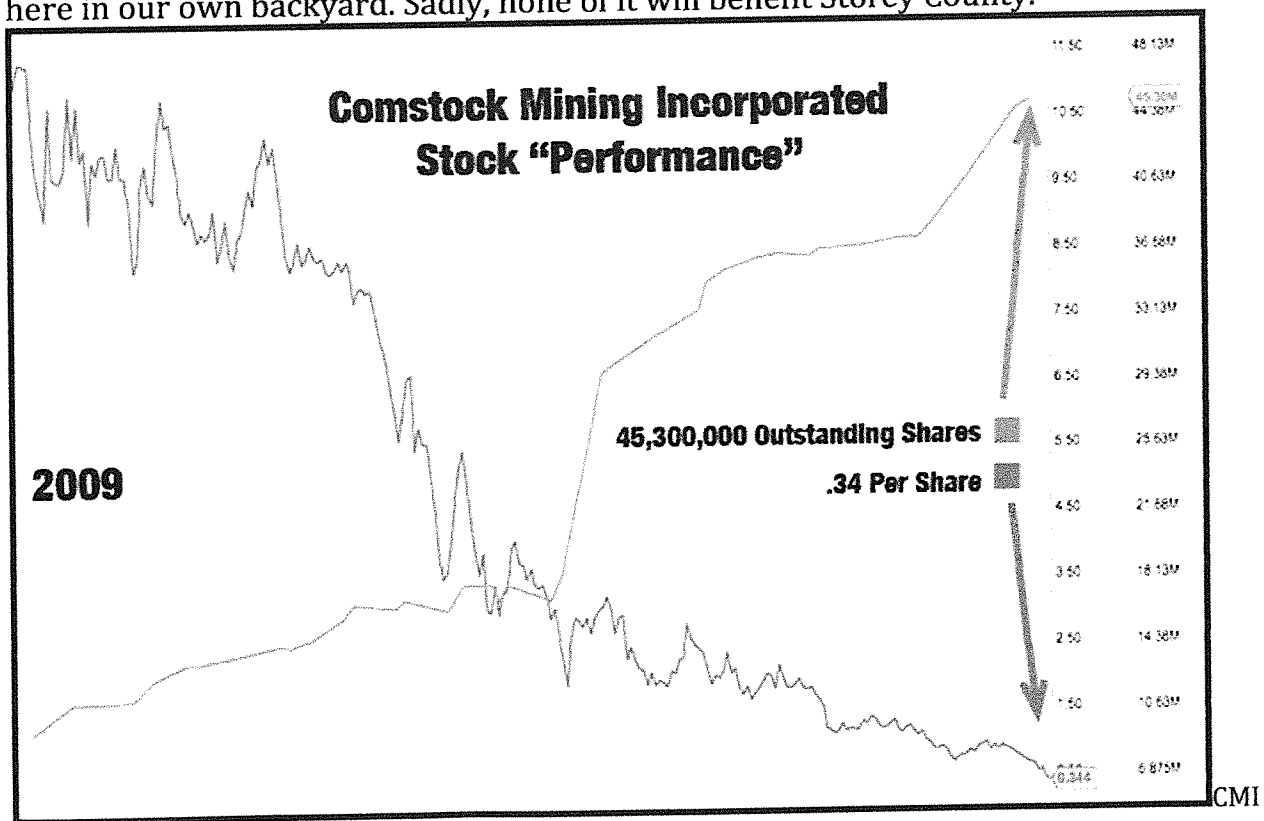

CMI Stock Returns to NYSE Compliance after Reverse Stock Split.

The NYSE removed the below compliance rating from CMI's Stock after the successful completion of a 5 for 1 reverse stock split.

"We are pleased with our ongoing compliance with the NYSE American listing standards and we could not be prouder of our commitment to and collaboration with this world-class platform," explained de Gasparis.

At the time of the reverse split, the price per share went from 13 cents per share to 65 cents per share. As of today, less than six weeks after the split, CMI shares are trading at 34 cents a share.

Today CMI Stock is trading at a pre-split value of .06

But that's not all. Corrado de Gasparis continued, "We look forward to providing our investors with more frequent updates on our ongoing agreement for the potential joint venture with Tonogold, the monetization of our non-mining assets, and the planned development activity for the Dayton Resource Area, toward full feasibility."

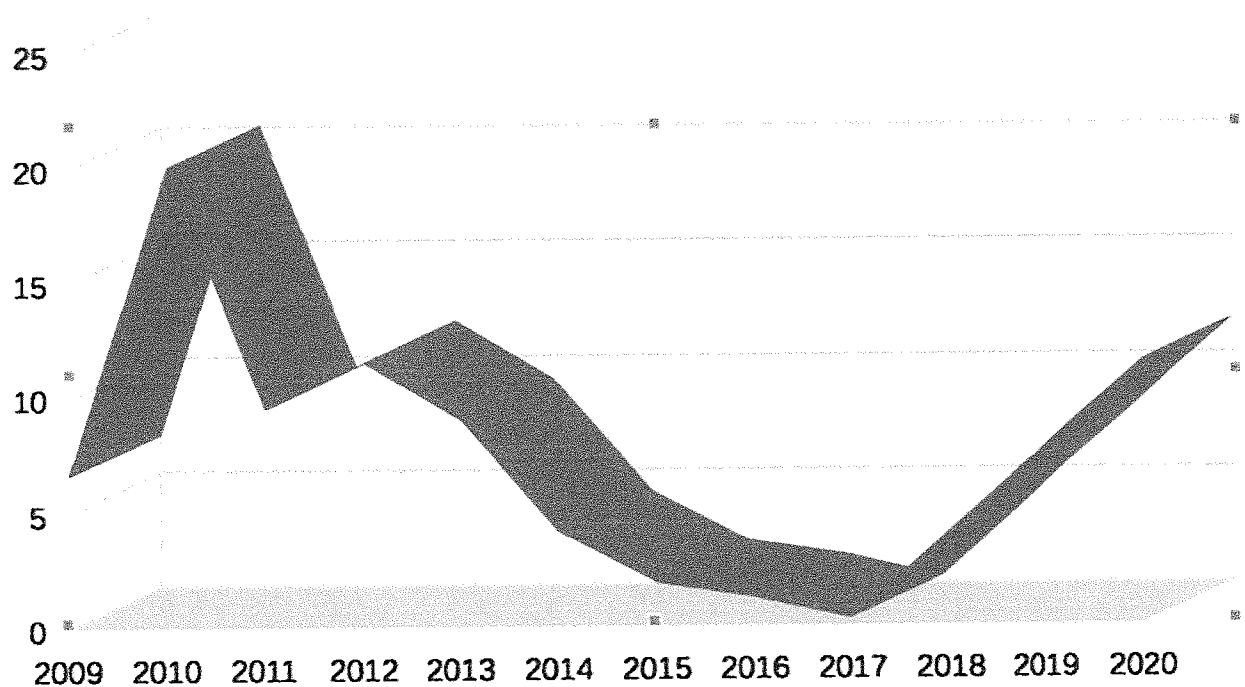
As expected, the Tonogold joint venture has produced exactly zero mining activity at the Lucerne Pit. Our sources tell us that they are in the process of mining the data relating to the drilling and other lode analysis done over the past five years to determine if they will continue with the venture. Given the grade of the ore and what it will take to get it into the gold bar smelter, we fully expect Tonoigold to come to their senses and not make the \$20 million dollar payment in April.

But the flim-flammetry of Tonogold is nothing compared to the flat-out lies every time they open their press release mouth.

Consider These Two Fantastic Claims Seen Every Comstock Mining Press Release:

The Company's goal is to deliver up to \$500 million of accretive share value by 2020, both through its existing mineral resource development targets and the ongoing development of the various partnerships, ventures and exploration and development activities that, all together, are capable of sustaining **production equivalent to 100,000 gold ounces per annum**. (Since I was 8 years old, gentle reader, my goal has always been to start in Center Field for the San Francisco Giants.)

- **Claim One: \$500 million of accretive share value by 2020**



According to the Press Release, CMI is poised to make the greatest turnaround in Comstock History.

To consider the remarkable audacity of this statement, you have to look at the data.

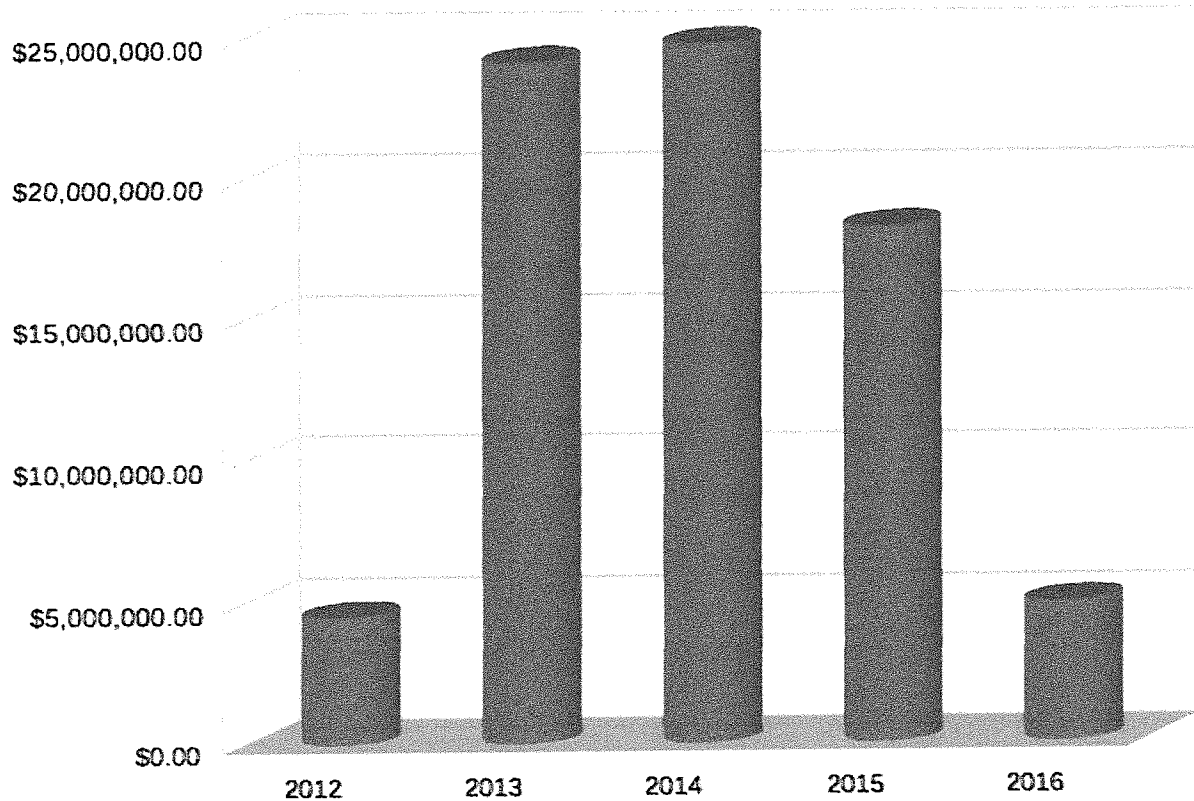
The chart above represents the stock price from when Goldspring took over from Plum Mining and we watched our first episode of the de Gasparis Winfield show. In looking at the first chart, we can see the stock is trading at .345 at the close of business today December 11th. There are 46.3 million shares outstanding. That is a market cap of \$16.45 million dollars. The second chart above shows the stock needs to climb to \$11.55 per share by December 31, 2019.

In order for CMI stock to have a \$500 million share value by 2020, the stock needs to rise 2939% in 24 months. I'll have my statue next to Willie Mays at ATT Park before that ever happens.

- **Claim Two: At some magical point, Comstock Mining will generate the “production equivalent to 100,000 gold ounces per annum.”**

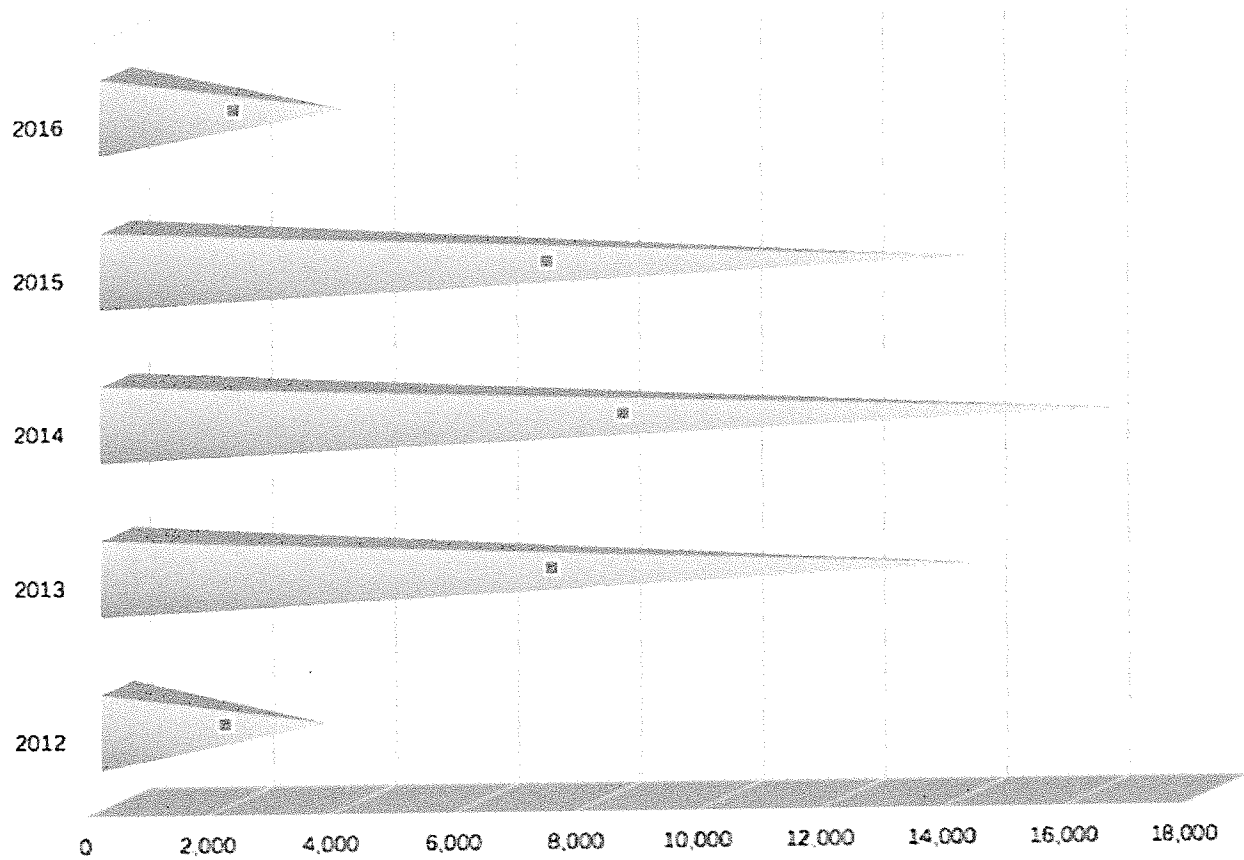
To show how absurd this nonsense is, we have to make some assumptions based on opaque or non-existent data. In looking at the 10-k reports (which you can see [here](#)), we find revenue generated from mining operations. Rather than monkey around with trying to figure out the percentage of Silver to Gold that CMI has produced (knowing that Lucerne has historically produced more Silver than Gold), let's assume all the precious metal they have extracted is gold.

Here is a look at their revenue from mining operations to date:



Mining Revenue 2009 – 2016. Note that there was no revenue prior to 2012 and no reported mining revenue since 2016.

With this in mind, looking at the above chart, CMI has generated \$76.5 million in revenue. That's a lot of gold. Just how much gold? We eyeballed the average price per ounce in each calendar year and came up with the chart below showing the annual production of gold in ounces:



CMI's gold production in ounces, per year.

Wow. That's a lot of gold. However, if you pencil it out, it's roughly 51,973 ounces of gold. Total. From 2009 to 2017. Yes, CMI has produced roughly 6,500 ounces of gold a year or about %6.5 of 100,000 ounces of gold per year.

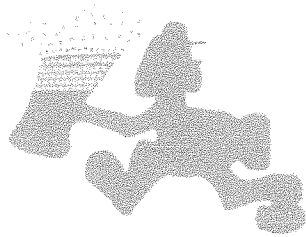
To produce 100,000 ounces of gold per year, CMI will have to increase production by %1439 percent. I will have my own plaque in Cooperstown before that happens.

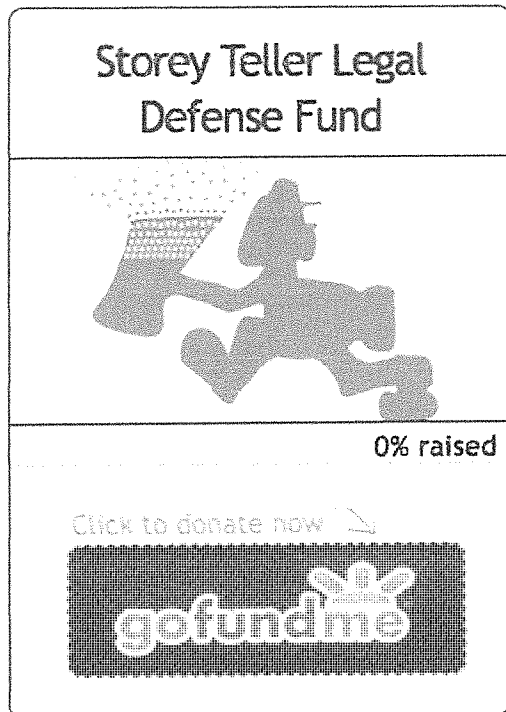
After all, who *really* cares about Storey County Politics?

On Tuesday Storey County Commissioner Lance Gilman served me with a lawsuit.


The writing on The Teller has somehow defamed him and this defamation has injured him and his bank account.

He claims his injury has a monetary value greater than \$ 15,000.






I have attached the complaint. It is a remarkable document, when you read it you get a grasp of Commissioner Gilman's frame of mind.

Readers of The Teller have seen me share my responses to Kris Thompson's musings on the Virginia City Highlands email chat group. I post them here.
