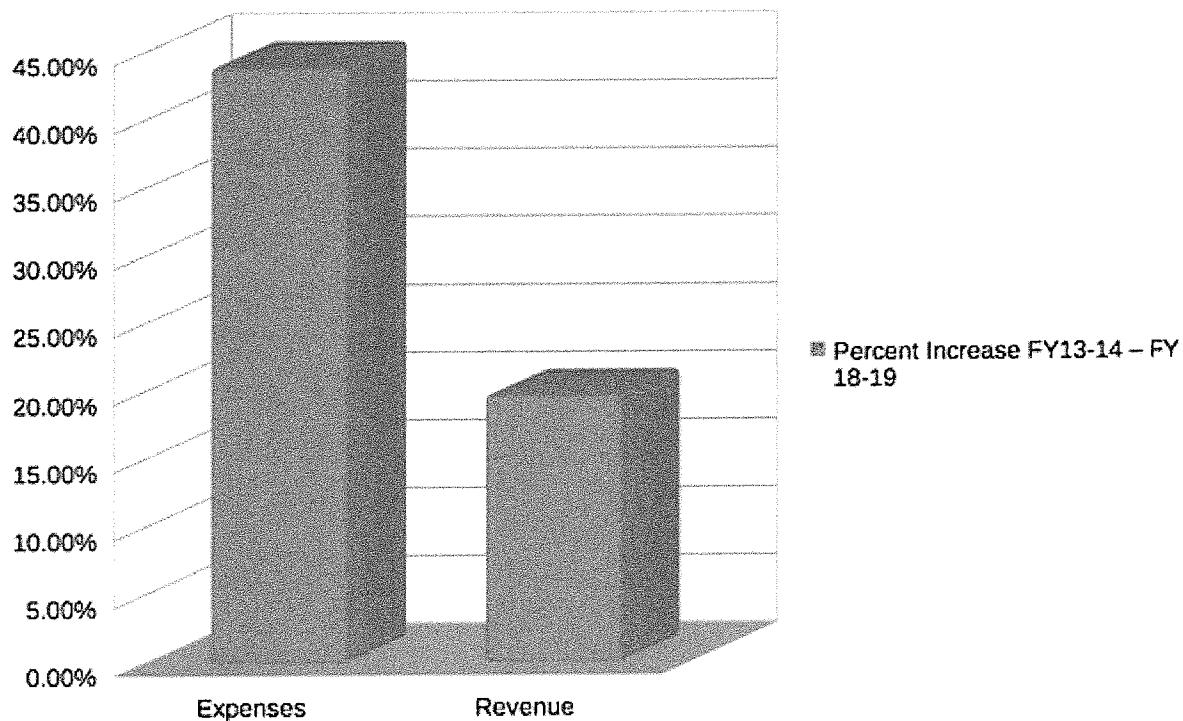


Before Tesla Expenses were below Revenue. That is good. Five years later, Expenses exceed Revenue.

That is not good.

This chart shows the troubling fact about the growth of revenues and expenses. Storey County spending growth outpaces revenue growth two to one.



Expenses outpace Revenues 2:1 From FY13-14 – FY 18-19. This should trouble every Storey County Taxpayer.

Yes, Virginia, from FY13-14 to FY18-19 our expenses have grown 44% while our revenues have only 22%. Expenses are growing 100% faster than our revenues, and C Street continues to not be swimming in cash. Yet Commissioner Gilman and Commissioner McGuffey continue to promise free money and a chicken in every yard due to the abundance of money here in **“The Richest Place On Earth”**.

All sectors of the County Personnel County have grown from 2104 levels. Wages and benefits are the driving force of our expense growth. The rise in the payroll costs and the additional fire and police body count is a direct result of the services required at TRIC. We documented the rise in headcount and payroll costs in our budget article here. Many of the added personnel are the direct result of TRIC. Yet TRIC revenues are not keeping pace with their impact on the County. There is only

one place Commissioners Gilman, McGuffey and McBride can pick up the slack, and that is from the wallets of Storey County Taxpayers.

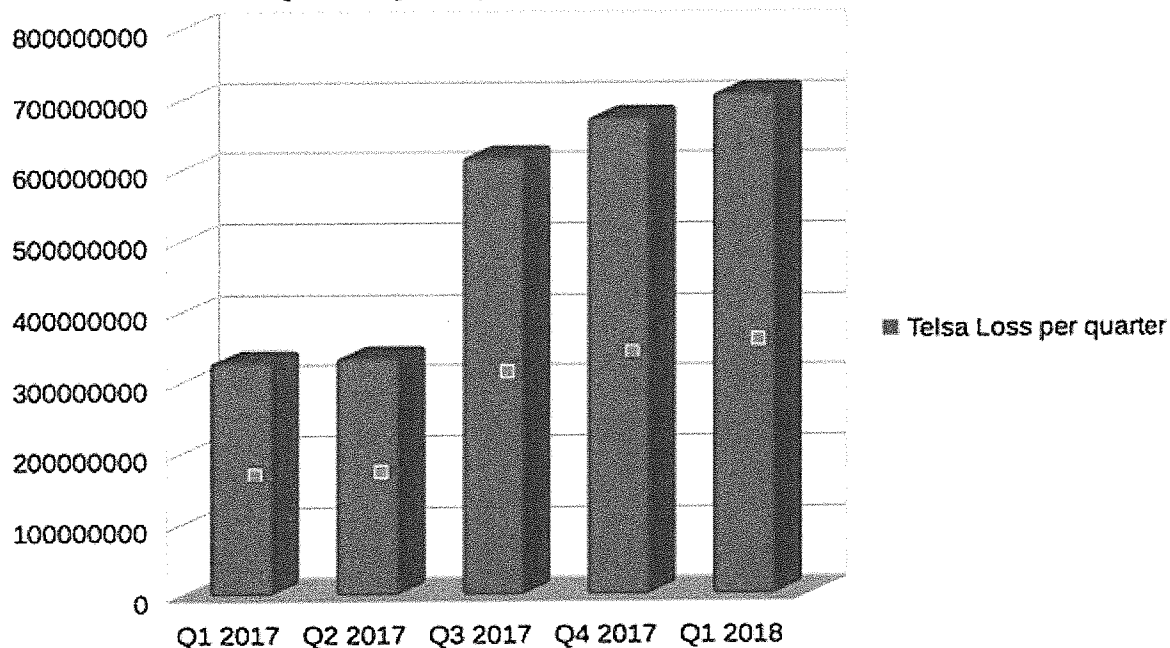
## The Miracle In Storey County – Tesla

The Tesla business model was to introduce boutique high-end cars so he could develop a market and interest in electric vehicles. With his charismatic personality, he has been able to cultivate a loyal base of enthusiastic supporters and customers who have followed him wherever he has led them.

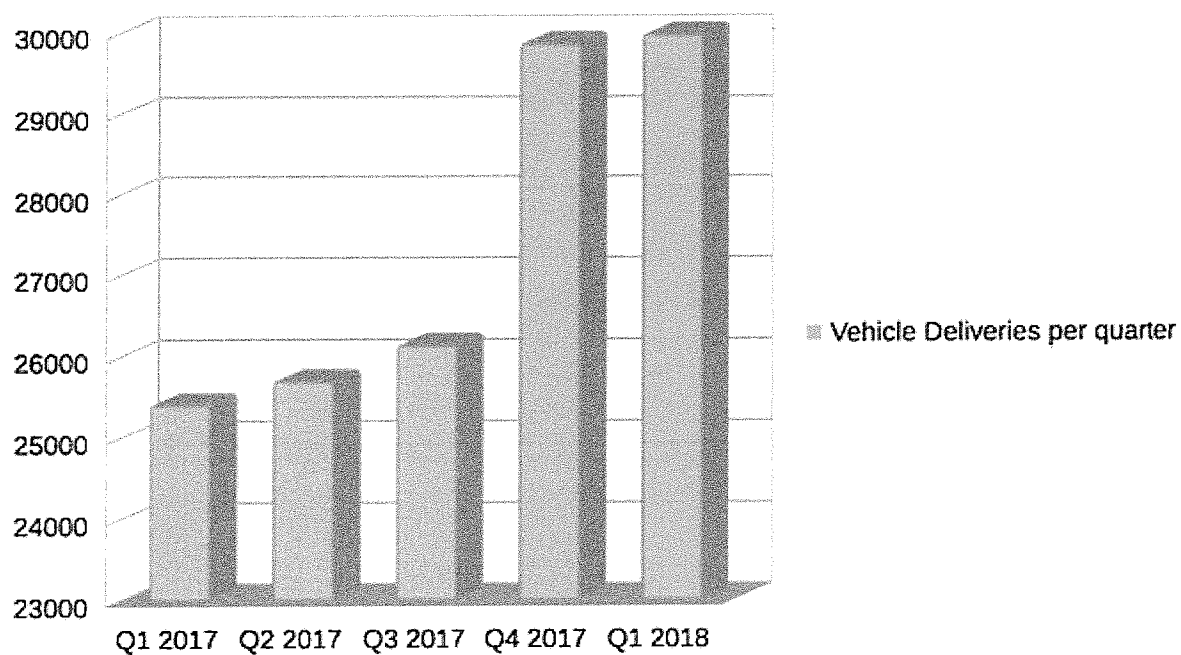
However, while other car manufacturers rely on producing cars they sell at a profit, Tesla has relied on myth and mystique. And taxpayer money. Without the Zero Emission Vehicle (ZEV) tax credit incentivized initially by California and now by the Federal Government, a dozen or so other states and governments around the world, Tesla would have already been a distant memory.

There are thousands of articles that talk about the cult-like following of Musk, and he is to be lauded for creating this company that has lost money since it's inception and continues to maintain an astounding market cap. However, it is becoming more clear with each broken commitment and production gaffe, that the wheels are loosening and may soon be coming off.

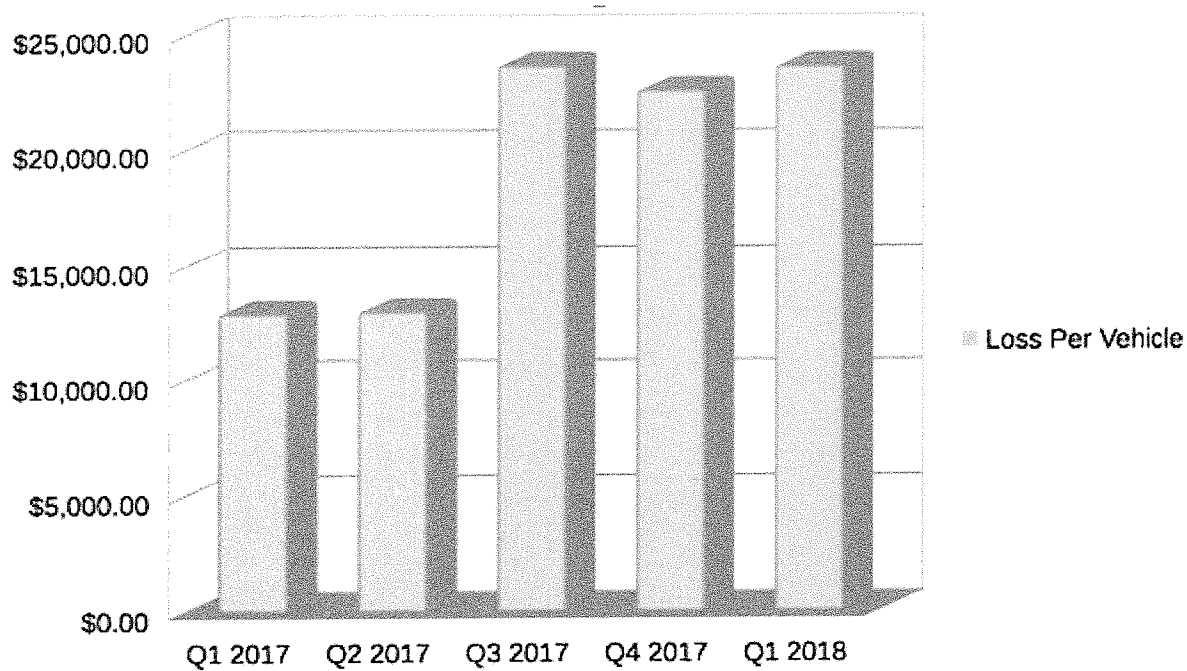
I'll begin a more detailed set of reporting on Tesla in the coming weeks, but let's take a look at their quarter profit/loss performance over this past year:



Tesla posted a loss of \$709 million dollars in Q1 2018



Tesla delivered 29,980 vehicles in Q1 2018 (Tesla.com)



Tesla Lost \$23,667 per vehicle in Q1 2018



I am guessing that Telsa would have been out of business years ago if not for the government welfare checks. Storey County Taxpayers have unwillingly been tossed into this group of check writers thanks in part to Governor Sandoval, the Nevada Legislators, and TRIC frontman Lance Gilman.

This increase of 114% is great. It would be even more had the County Commissioners not given away some of this cash with abatements. However, Community Development salaries have outpaced this growth due to the increased workload. This means that the added revenue from the license fees with all the work at Tesla ends up costing the county money. Total License revenue went up \$148,892 but salary and benefits went up \$333,253 costing the county \$184,360. (Source, Audited Budgets from Storey County Website)

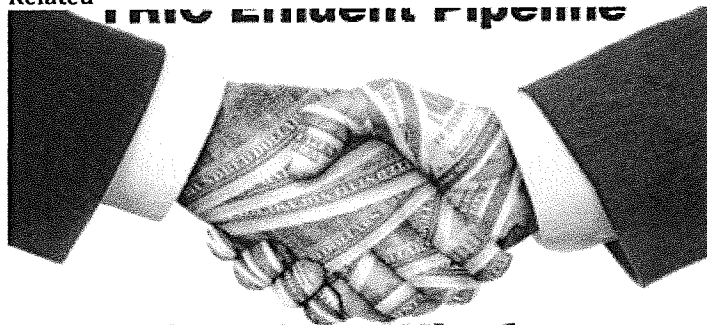

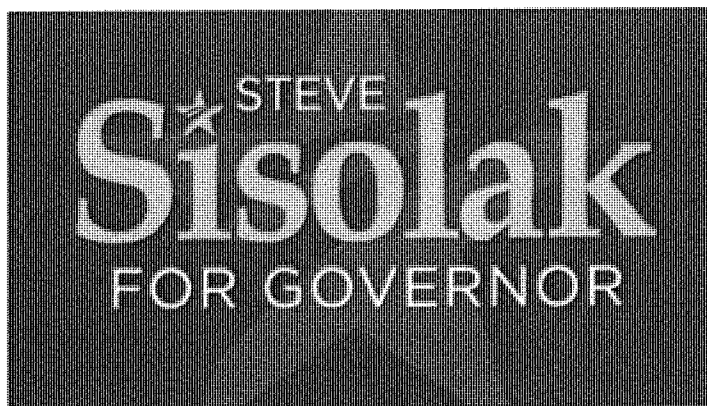

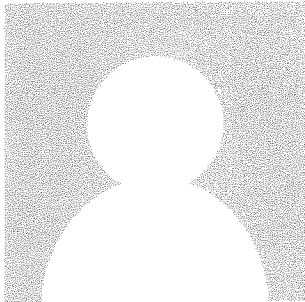

## Storey County Candidate Forum Held In Virginia City

Pipers Opera House hosted the first Storey County Candidate Forum of the 2018 political season in Virginia City. The rainy weather did not discourage county residents from showing up in force to hear the candidates discuss their platforms.

Over a hundred people in the audience were asked to submit questions to the candidates. Candidates not in the Primary had two minutes to introduce themselves.

Karen Woodmansee and Loren Purcell approved the questions submitted by the audience and Loren moderated the event.

### General Election Candidates

Nicole Barde introduced herself as Candidate for Storey County Commissioner and described her 30 years of business and non-profit management. She shared her plans for moving forward that include conservative fiscal policy, growing and diversifying the county revenues, providing transparency and accountability to the residents and keeping ahead of the complexity that we face as a growing county.

School Board candidate Sam Toll explained his thoughts on the Jump Start Program and financial literacy. The Jump Start Program gets Storey County High School juniors and seniors into classes at the community colleges to get them ready for college and reduce the financial burden of college on families. He also explained the need for financial literacy curriculum. Kids take algebra, trigonometry, and calculus, while schools ignore basic life skills like knowing how to balance a checkbook or how credit cards can be dangerous. Toll's opponent Jeff Nevin was conducting a School Board meeting and was unable to attend.

## District Attorney

Then the attention turned to the District Attorney's Race as Storey County DA Anne Langer and challenger Dave Niedert took the stage. Anne described the function of the department and how her department works with the Sheriff's Office in investigations and prosecutions. She described her office as having a good working relationship with the Sheriff's Office.

Dave Niedert explained that he decided to enter the race after talking do a Storey County Deputy who told him there wasn't enough cooperation between the Sheriff's Office and the District Attorney's office. Neidert has 28 years as a practicing attorney with much of that being a prosecutor in rural Nevada.



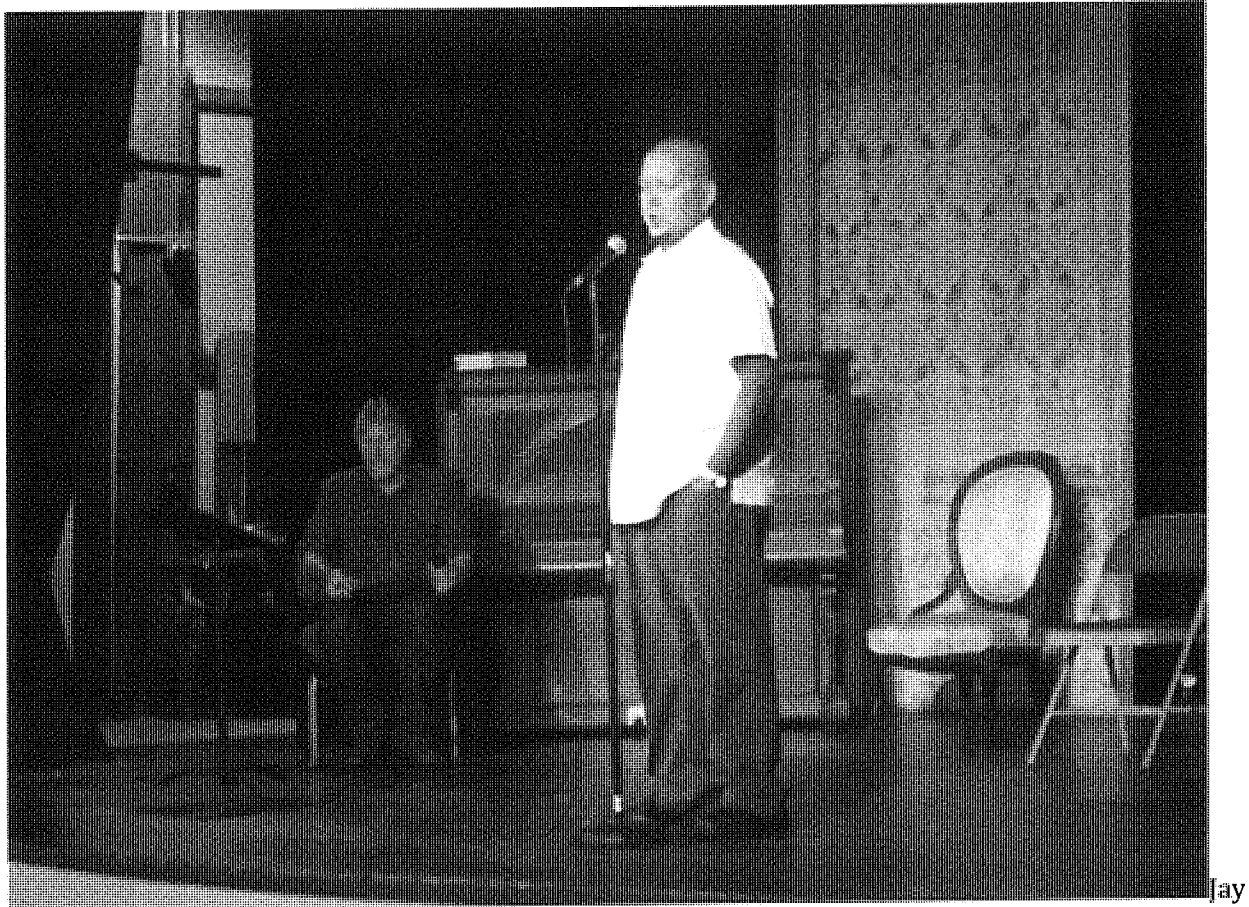

## Storey County Commissioner

Storey County Commissioner Candidates were next. This was a bit awkward because incumbent Jack McGuffey was in Idaho for a NACO conference. Loren Purcell read a statement from Commissioner McGuffey that included his commitment to returning excess money from the success of TRIC to the people of Storey County.

The first question fielded by Jay Carmona addressed that very issue. Mr. Carmona stated that based on his research of the budget, the rebates were pretty much not happening. (You can read more about the budget [here](#), [here](#), [here](#) and [here](#).) It

was super awkward for Mr. Carmona to answer his questions alone.



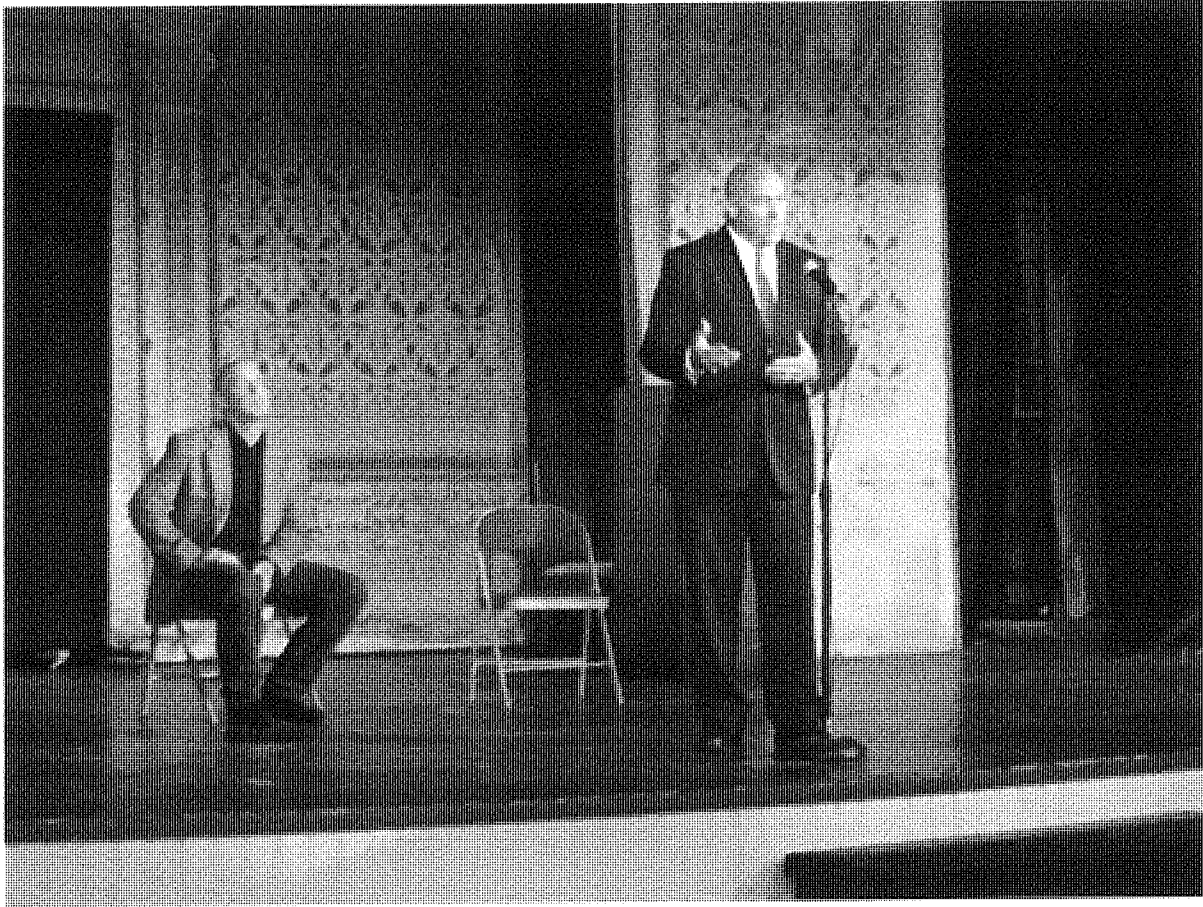

## Storey County Sheriff

Most of the questions were for the Sheriff candidates. Candidates Cullen and Antinoro both shared their experience in Law Enforcement with Antinoro starting in 1984 and Cullen in 1994.

Antinoro mentioned his experience holding every job from jailer to Sheriff and heading state agencies during his career.

Cullen described his career starting as a Corrections Officer at the State Prison. He then joined the Carson City Sheriff's Office. After stints as a detective and motorcycle cop, he is now Sergeant and day shift commander.

### Budget

Some of the questions for the Sheriff Candidates surrounded the budget. **The Teller** has noticed an adversarial relationship with County management and the Sheriff's Office surrounding the budget. While the Fire Department seems to get everything they could possibly need to keep the people of Storey County safe, attention to the needs of the Sheriff's Office and the safety of the citizens of Storey County in terms of budgeting is not the same.

The people in the audience may feel the same way based on their questions about the budget. Candidates were asked how they would increase their budget in the coming years based on the need to get ahead of the policing requirements of TRIC. Cullen suggested that there should be a minimum of two officers responding to traffic stops out at TRIC because "you never know when a traffic stop will turn into a gunfight". Mr. Cullen assured the audience that he would work to establish a better relationship with the County Commissioners to get more funds for the Sheriff's Office.

Sheriff Antinoro reminded the audience of his excellent track record of fiscal responsibility and maximizing the use of the dollars he has to work with.

K9 and SWAT Teams

Candidates were asked about adding K9 and SWAT teams to the Storey County Sheriff's enforcement tools at their disposal.

Mr. Cullen indicated that he was a big supporter of the K9 program and suggested that there were grant dollars and free training to add K9's to the office. He told the audience he would implement a K9 unit quickly if elected.

Sheriff Antinoro indicated there was little to no need for K9 units and pointed to the amount of money and training that would need to be diverted from current uses. The impact on the deputy and the county would not provide a substantial improvement in safety especially since the crime statistics revealed that overall crime is consistently down over the last five years.

Similarly, Sheriff Antinoro did not support a SWAT team in Storey County. He suggested that with the dynamics of our county and the nature of the threats posed here, there is no real need for the time, effort, equipment, and training required to maintain a team.

Mr. Cullen backed off his original position he put forth at a recent event. During that event, he suggested that he would implement a SWAT team and lauded their benefit to the community. Cullen has nearly 20 years of experience being involved with the SWAT team in Carson City. At the forum, he echoed the Sheriff's sentiment that SWAT teams could be dispatched from surrounding counties should the need arise and that he would not push for one if elected.

#### Department Morale and Leadership

Both candidates addressed their experience in leading a team of deputies and personnel.

Mr. Cullen explained that he has had people under his command for years and is currently the day shift patrol commander.

Sheriff Antinoro shared his decades of leading teams in many different departments and state agencies beginning in 1989. Mr. Cullen suggested this is a critical issue and he would represent a change from the way Sheriff Antinoro has run things.

#### Next up: Lockwood & Rainbow Bend

After the event, the candidates were able to talk one on one with members of the community. Folks talked for a good thirty minutes after the Sheriff candidates left the stage.

Karen Woodmansee and Loren Purcell are to be commended for their critical efforts in making this a success.

The next Storey County Candidate Forum is at the Rainbow Bend Clubhouse on Tuesday, May 29th at 5:00 p.m.

I was at the Candidates' Forum last Thurs. (Thank you, Karen & Loren!). When I took my front row seat, I noticed I was sitting next to Kris Thompson & Lance Gilman. Since there was time to kill, I started a conversation with them about the wild horse situation and our choices for Governor. Now I know this was nothing formal and we didn't disagree about anything, but it was so civilized to be able to talk about a couple of civic situations with the three of us having equal air time with each other. I got to thinking about how our county has



become like a dysfunctional family, and we can't just sit down with our civic leaders in a group and talk with them and come to some kind of meeting of the minds. Even at the forum, the questions were fine, but since the questions had no follow up, there was no opportunity to ask, "Would you be specific?" or "You didn't answer the question, please do." It was a softball kind of exchange.

I wish we could have a round table with the County Commission, the County Manager and the County Comptroller. This would be an opportunity for Sam, Nicole and whomever else to ask their questions and get some answers (hopefully). You certainly can't do this at a County Commission meeting. It would be so productive to do this with everyone's tempers on hold, and everyone prepared with facts and figures so we could get down to brass tacks. I've heard that individuals have called the County Comptroller (as Commissioner McBride entreated when he questioned and called out as incorrect, Sam and Nicole's reportage) to find out if Sam & Nicole's figures were off-base – according to the Comptroller they aren't – the figures agree. Right now, it seems there's a very adversarial relationship between the Commission and the individuals who report on the meetings. It would be good to know where there REALLY is misinformation and start on the road of mutual cooperation between the county's taxpayers and its public servants. I'm sure all of the county employees are trying to do their best for us, but it should not be taken as a negative, personal challenge when they are questioned about the budget, decisions and actions that affect all of us. I know this sounds Utopian, but it's good to have high goals.

My next comment will be taken as a plug for Nicole, but it's really not. When I heard Nicole's remarks about her background and qualifications for office at the forum I just had to think, "Why has this woman been pushed away all the years she's lived here? It's obvious to anyone who has eyes and ears that she's probably the most qualified business person in the county, if not Northern Nevada. Why has the county not taken advantage of her talents?" It's so disheartening that after all these years of her reporting on meetings, that the county seemingly treats her like some kind of mad woman who should be ignored like the neighborhood cat hoarder. No matter what happens in the elections, I'd really like to see Nicole's business talents utilized in some way for

our county. It would be a GIANT step in the right direction. We are WASTING valuable TIME and MONEY not bringing her on board.

I'd also like to see a round table with the Sheriff's and DA's offices with the people. There are individuals I know who have been violently harassed in writing by a law enforcement professional who lives out-of-the-county. Nothing has been done about this, although it's been reported. I also heard about an incident of extensive vandalism in the River District. The perpetrators were arrested. No charges were made by the DA. Are there other incidences like this? Right now, there's no recourse for community dialogue between the Sheriff and DA.

Yes, I'm an idiot for considering these ideas, but if only.....

Storey County is blessed to have a solid group of dedicated women and men who work at the Sheriff's Office. With the upcoming election on June 12th, they felt it was appropriate to chime in on the topic of candidate endorsement. Below find the letter The Storey County Deputy Sheriff's Association sent to The Teller for publication:

Speaking on condition of anonymity, one deputy told The Teller, "We are pretty much divided about who to support. Many of us support Sheriff Antinoro, but some do not. We felt that because we can't all unite behind one candidate or another that we would choose to endorse neither candidate."

While the deputies are divided about who to support in this upcoming election, their support of the community is clear and undivided.

On the subject of the Deputies who wear the badge and patrol our streets, as voters, we should consider how our county has dealt these women and men a low card. In every jurisdiction I have ever been in, one place where budgets don't scrimp is with public safety. The hard-working women and men of the fire department have their own revenue stream and enjoy a budget twice what the Sheriff's Office has yet they go on vastly fewer calls. Each provides vital services, but because there seems to be an ax being ground on the Sheriff's budget from certain elements inside the Courthouse, the Deputies suffer.

In the 2014 budget cycle, the County Commissioners tried to slash the Sheriff's Office budget massively. The people of Lockwood took the streets, packed the Courthouse, and stood united in their support of the Sheriff's Office and the Deputies. They demanded that the Commissioners restore the Sheriff's budget. In the face of this public outrage, the Sheriff's budget was restored.

The discussion about budgets at the recent candidate forum held on Thursday, May 24th directly affects the day to day lives of the Deputies. The deputies are hamstrung as they work short staffed to provide us the best level of service possible. The impact of TRIC with the added patrols and traffic issues affect our community directly.

Candidate Mike Cullen talked about how he would deploy increased deputy presence to get ahead on the issues at TRIC that he described as "issues that are already ahead of us". He suggested he would work with the Commissioners and the Comptroller to get additional funds to increase Deputy manpower and add a K9 unit. Sheriff Antinoro put forth a message of financial restraint given the financial woes the county finds itself in.

The budget shortfall of \$1.7 million dollars is the direct result of Tesla's cash crunch. Once the promise of TRIC come to fruition in 2024 when some of the tax abatements expire, perhaps we can get these hard-working women and men the funding they deserve so they can do the job we pay them for more effectively and safely. Sadly, they have to pay the price of the impact of TRIC until that happens

Regardless of who the community chooses to lead the Sheriff's Office, we are grateful to have the Storey County Deputies and their steadfast dedication to our community.

Virginia City Highlands own Juliana Carmona, daughter of Storey County Commission Candidate Jay Carmona, sang the National Anthem and after the pledge of allegiance the recently installed Mark Twain Veterans Memorial was officially dedicated by Kris Thompson.

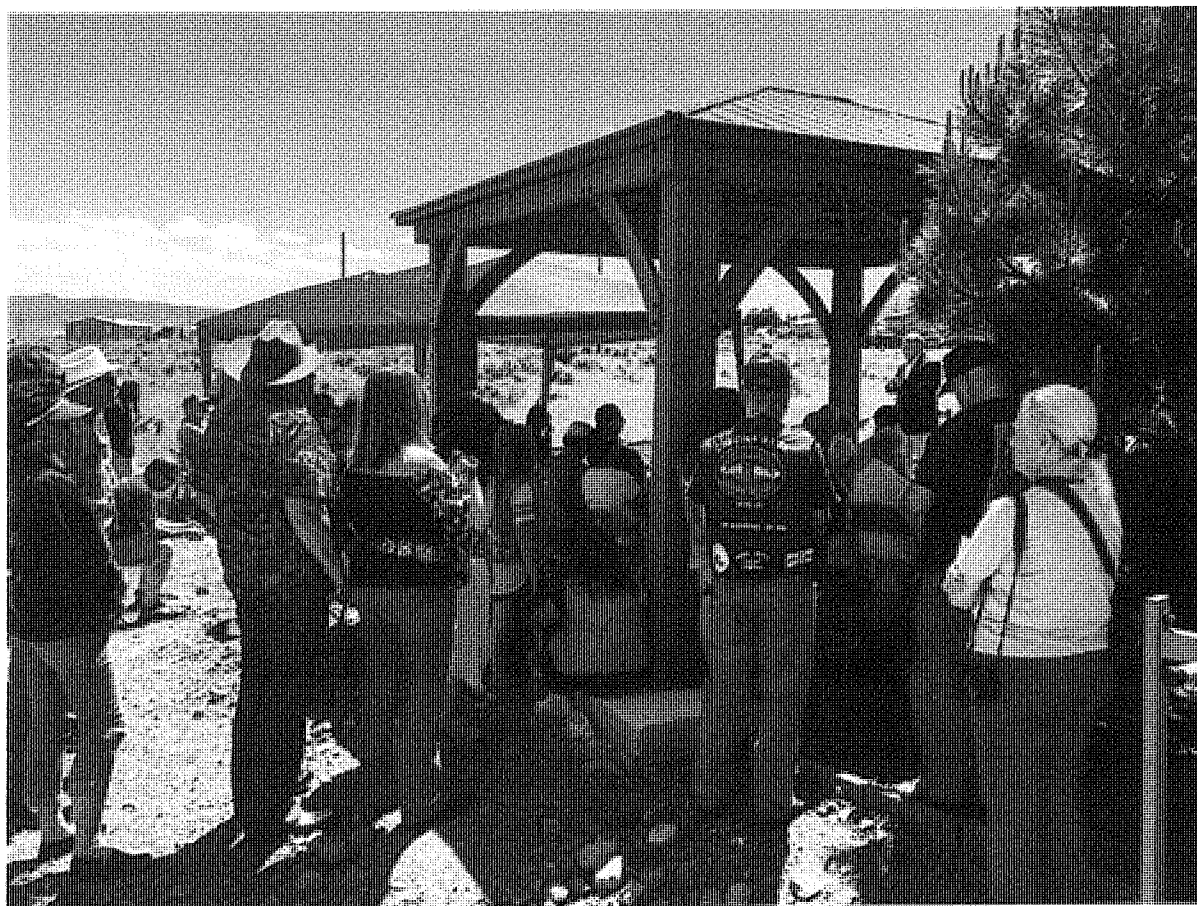
# Mark Twain Veterans Honored on Memorial Day

# Virginia Range Horses Fate To Be Decided Soon

The Department of Agriculture released an RFP yesterday that would transfer ownership of the Virginia Range Herd to a private group. The RFP can be seen at the end of this article. This fate of the herd has provoked passionate discussions on both sides of the fence.

In October 2017, the Department of Agriculture abruptly abandoned their working agreement with the American Wild Horse Preservation Campaign (AWHPC). The agreement, originally made with the Return to Freedom (RTF) in 2013, originally covered feral horse adoptions. An additional agreement with RTF was signed in 2015 to include managing the wild horse populations in the Virginia Range area. In 2016, the agreement transferred all responsibilities to AWHPC. The NDA is scrapping these agreements and will seek a consolidated agreement with a single partner.

Supporters of the Virginia Herd have mounted a vocal and energetic campaign to stop this effort. They fear that this new partner will scrap the idea of managing the herd, in favor of relocating the entire population of animals. This new partner could relocate the horses to another part of Nevada. Worse yet, the horses could be sold to slaughterhouses.

## Protect The Harvest, Slaughter The Horses?

It is rumored that Protect the Harvest, a non-profit group registered in Missouri and with offices in Indiana will submit a proposal to relocate the herd. Dave Duquette, the group's strategic planner, told The Teller Protect the Harvest has no interest in taking ownership of the herd.

"There have been a lot of rumors regarding our organization and the fate of the Virginia Range. Protect the Harvest has no desire to be in the management position of these horses," he said in a conversation with us Monday. "We're not planning on submitting a proposal, but we encourage all the different wild horse supporters to get together and put one in."

Deniz Bolbol of the American Wild Horse Campaign told The Teller, "The Nevada Department of Agriculture (NDA) and Governor's ill-conceived plan to give away the 3,000 Virginia Range wild horses has only one intention: to destroy the horses. The Virginia Range horses are currently the property of the state and people of Nevada; according to state law, the state is not liable for any injury or damage done by the horses."

"The Governor and his administration completely understand the liability issues involved with owning 3,000 free-roaming wild horses who move across 500 square miles of roadways and private property parcels. Governor Sandoval's Department of Agriculture is disingenuous when they claim that a private entity could take "ownership" of these 3,000 free-roaming horses and keep them wild

and free. No insurance company will issue an insurance policy to cover injury or damage if the horses are privately owned and allowed to continue to move freely on the 500-square-mile Virginia Range," she explained.

## **Gilman Grandstanding?**

Meanwhile, Brothel Owner, TRIC Executive, and Storey County Commissioner Lance Gilman stepped into the fray when he penned a 2-page letter to Governor Sandoval asking him to "step in and broker a deal" to keep the horses under state control.

**LANCE GILMAN REQUESTS NEVADA GOVERNOR TO STEP IN

(Tahoe-Reno Industrial Center, Nevada) – Lance Gilman, a principal in Tahoe-Reno Industrial Center this morning went public with a request directly to Governor Brian Sandoval to step in and help work out a deal between the Nevada Department of Agriculture and the Wild Horse advocates. Lance Gilman's official position and statement reads as follows:

"Through the Governor's amazing work in economic development, he has created a new Nevada brand for attracting business, which we here at TRI have leveraged into amazing success under his leadership. This new successful brand centers on the notion that we are NOT San Francisco, New York, or Chicago. We are the West...proud of our heritage, where a handshake means something, and it's ok to wear cowboy hats and bolo ties to business meetings where businesses can get things done, and not be hamstringed by bureaucrats and red tape!

Our Nevada wild horses are the best emblem we have for that brand. Everyone coming to TRI notices them, comments about them, and asks about them in a positive light.

Elon Musk himself is a great example – just two months ago, he posted on his Instagram account a video he took of the wild horses as he was leaving the Tesla Gigafactory. In just the first two months, over 750,000 people have viewed that video, and the positive comments these people posted about the video are really enlightening – 100% were in admiration of the horses and how "cool" it was that they roam free amidst such industry giants in such a peaceful and cohesive existence.

A couple days ago, Elon Musk posted another comment on his Twitter account that his Gigafactory was in the land where horses can "roam free."

This infatuation with our Nevada wild horses has gone viral in the business world. A couple of examples. Here's a headline from the Financial Post:

**Hidden where cowboys gamble and wild horses roam: Tesla turns on its \$5-billion Gigafactory**

"Musk said he can get emotional thinking about this giant battery factory.

"I think it's quite romantic, actually," he said.

When finished it will be shaped almost like a diamond with one end pointed toward true north. Also, it's nestled in a valley through which thousands of wild horses roam in the desert heat."

And there are a huge number of other articles and quotes about Tesla, TRI, and Nevada mentioning the wild horse. A Google search of "Gigafactory wild horses" will quickly demonstrate how pervasive and popular our wild horses are in the global business world.

Rob Roy and Adam Kramer from Switch absolutely love the wild horses and even donated significant money to the group doing the darting out here at TRI, which is no longer allowed since the termination of the cooperative agreement.

Transferring these horses to private ownership means they are no longer roaming free. They would be domesticated by law and in reality. In addition, the private group would overnight become liable for any accidents on fenced roads and highways, as the horses would be domesticated. (NRS 568.360.) This makes it virtually impossible for any private group to take ownership in a responsible way.

This would hurt the Nevada brand considerably.

The recent action by the Nevada Board of Agriculture is not irreversible. If the Governor's office were to step in and order the NDA to meet with landowners and wild horse advocates and broker a deal between them, this deal could be approved at the next Board of Agriculture meeting, and the prior action by the Board of Agriculture ordering every single horse in the Virginia range be transferred to a private owner could be rescinded. It's easy. Let's make a deal. We have willing parties on the wild horse side, and we have landowners and corporate stakeholders who are ready to be involved. A deal which is good for all parties is very doable here.

No one has done more for Northern Nevada economy than Governor Brian Sandoval. He saved Northern Nevada from economic misery. I've seen him in action with the world's business leaders, and he was magical. His legacy will be forever carved in stone that he is the founding father of the new Nevada where global tech and manufacturing companies come to do business.

This would be one more step on the broad path he has championed to create economic excellence here in Northern Nevada." — Lance Gilman

“Our Nevada wild horses are the best emblem we have for that brand,” Gilman wrote. “Everyone coming to TRI notices them, comments about them, and asks about them in a positive light.”

In response to questions about Gilman’s letter, Sandoval reconfirmed he won’t override the decision by the board. It is customary for government types to have their minds made up regardless of how loud the unwashed masses howl. As County Commissioner, Gilman knows this. And as a good politician, he won’t let a good crisis go to waste.

It now seems likely herd will be sold to the highest bidder and removed from the Northern Nevada desert.

## A Potential Win-Win Solution

Here at The Teller, we have been critical of Mustang Ranch owner Gilman and his TRIC partner Roger Norman. This criticism is the result of the appearance of Gilman using his position as Marketing Manager and Sole Real Estate Salesman for TRIC **and** Storey County Commissioner to benefit himself and his business interests at the expense of the Storey County Taxpayer. We have been so critical of this conflict of interest, Gilman has taken us to court to try to get us to shut up.

However, we also recognize the business prowess Lance and Roger posses. The way we see it, now would be a perfect time for Roger Norman and Lance Gilman to do something that would benefit all of Northern Nevada. As we reported recently, TRIC has sold basically all remaining property in a series of deals. The deal with Blockchains.com netted the duo a reported \$175 million.





The Storey Teller encourages Gilman and Norman to submit a proposal to take ownership the Virginia Range Herd. This would cement their legacy as men who have grown and protected Northern Nevada. They could also claim ownership of an entity that actually benefits the community.

We encourage Gilman and Norman to show us they aren’t “All Hat, No Cattle”.

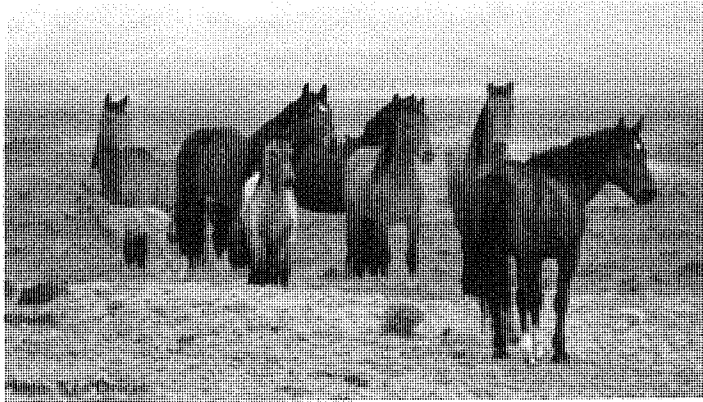

## Storey County Fire Captain's Son Seriously Injured

On Monday, February 19th Fritz Klinger, Storey County Fire Captain, got the call that strikes terror into the heart of every parent. While on duty in Virginia City, he learned his youngest son, Rhett Klinger, was struck by an automobile while riding his bike in his front yard.

Earlier in the day, the Klingers dealt with their oldest son's snowboarding accident where he was treated at Renown Hospital for a broken tailbone. After reporting for duty, Captain Klinger got the call that his youngest son was in the hospital.

"My son was riding his bike on a ramp he set up on the sidewalk. The car struck Rhett and hit the ramp throwing him into the street. As he tried to get up, the car rolled over him further injuring him and then continued down the sidewalk. The

driver got out of the vehicle and stood by her car seemingly unfazed by the incident. She didn't appear to realize what she had just done." said Mr. Klinger. Sparks Fire Department rushed Rhett to the trauma center at Renown Hospital where he remains in Critical but stable condition. Rhett suffered a head injury with small brain bleeding, a serious concussion, and a broken femur. He is in a drug-induced coma and on a ventilator, and his family is by his bedside.

## Surgery Scheduled for Thursday

We spoke with Mr. Klinger earlier today and the concerned father shared with The Teller this update.

"He's stable right now but has been unconscious since Monday. His right femur is broken and he has a bad concussion. He has been slowly improving making small movements and even opened his eyes a few times.

They have him scheduled for surgery first thing tomorrow as long as he keeps improving today. He just got back from his MRI, so we should hear the results from the radiologist soon but from what the neurological doctor said, he looks really good. He just needs time to heal", Klinger told The Teller this evening.

## GoFundMe Fundraiser Set Up

The Storey County Fire Fighters Association set up a GoFundMe fundraiser page and the heartfelt support from the community is running strong. At the time of this writing, the page has raised over \$ 14,000. The Storey Teller encourages you to donate what you can by following this link.

While the Klinger Family has medical insurance through the county, it is unknown how hard this will impact the family financially. With the worry of a potential long-term effect of this accident, needing to pay for the medical care should be the last thing on the family's mind. If you can contribute, please do so.

## A Father's Positive Attitude Gives Us All A Reason For Hope

We were impressed with the calm positive tone in Mr. Klinger's voice when we spoke to him today. Perhaps it's a result of his years of experience dealing with traumatic situations in the Fire Department, but it is a testament to the courage of the family.

"It's a freak accident but it could have been so much worse. We are just so grateful that we have this opportunity to fight for him. Please keep him in your prayers", Mr. Klinger told us.

Pray we will.

## Barde Announces Candidacy for Storey County Commissioner

Nicole Barde announced on [bardeblog.com](http://bardeblog.com) she is running for County Commissioner in District 2. With her announcement, there are now three candidates vying for the seat. Barde, who ran in 2014 as a Democrat will be running as a Non-Partisan in 2018.

Storey County Senior Center Executive Director Stacey Gilbert's monthly reports account for every cent of Senior Center Funds and quick inspection confirmed that Mr. McGuffey was talking out of his hat; there was never a moment when any Senior Center Funds were unaccounted for. This accusation prompted Ms. Barde to read the following into the record at a January Storey County Commissioners Meeting:

It came to my attention over the holidays that Commissioner Jack McGuffey has once again been spreading untrue rumors about the senior center. The first time that this happened was in 2017 and I had to have a clarifying conversation with Commissioner McGuffey in Pat Whittens office with Pat Whitten present. the future he had any questions or concerns about the Senior Center to come to me first.

When I heard this I knew that it was not true but had to speak with Center Executive Director Stacy Gilbert and ask her the question " are we missing \$800?"

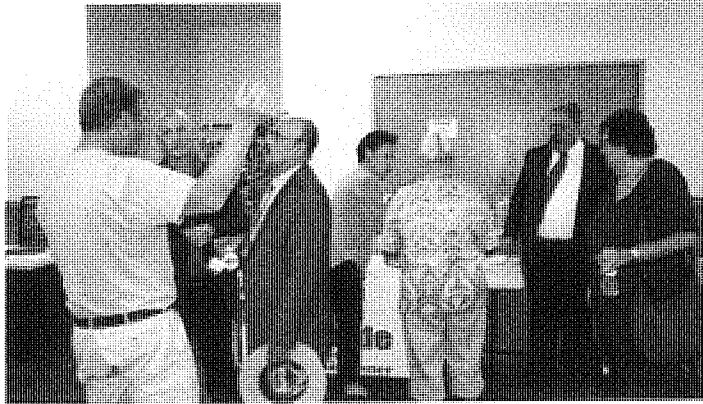

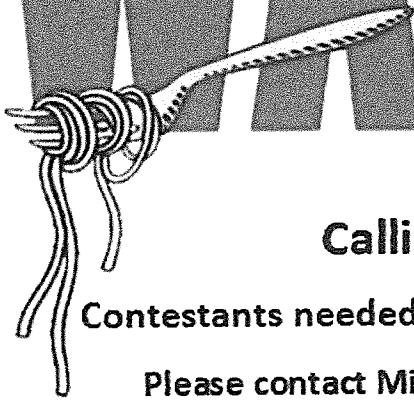

# Court Dismissed 7 of 8 Charges in Gilman v. Toll

## First District Court Dismissed 7 of 8 Charges in Gilman v. Toll

On April 9th, 2018, The Honorable James E. Wilson Jr. of the First District Court dismissed 7 of 8 charges in Gilman v. Toll. In his ruling, Judge Wilson dismissed the arguments of Lance Gilman who hoped to prove that Mr. Toll lied and maliciously knew he was lying about the facts of 8 articles written in the Teller over the course of 2017. On the Count not dismissed, Judge Wilson allowed Gilman to seek limited discovery to help him prove Mr. Toll knew he was lying when he accused Gilman of not living in a trailer behind his brothel.

The burden of proof now shifts to Mr. Gilman to prove that Sam Toll maliciously lied when he wrote the potentially defaming prose and that he knew the prose was a lie and posted it to purposefully damage Mr. Gilman.

Mr. Gilman will be granted limited discovery relating to the lying. This discovery is "limited solely to information as to whether Toll knew the resident communications were false or whether he acted with a high degree of awareness of the probable falsity of the statement or had serious doubts as to the publication's truth."

## Some Background

On December 7th, 2017, Brothel Owner, TRIC Executive, Blockchains Government Affairs Representative and Storey County Commissioner Lance Gilman sued The Storey Teller Editor Sam Toll for Defamation Per Se. Sam Toll filed an anti-SLAPP (Strategic Lawsuit Against Public Participation) special motion to dismiss, which Gilman opposed.

In documents filed with the court, Mr. Gilman complained that "virtually every article" written in The Teller contained malicious attacks against Mr. Gilman's character. In fact, 40 of the 247 posts mention Gilman and 21 of them are critical of his behaviour in office, 16% and 11% respectively. He went on to accuse Mr. Toll and the Teller of not operating The Teller as a good faith communication in furtherance of the right to petition of the right to free speech in direct connection with an issue of public concern (NRS 41.637(1)-(4)).

## Matters of Public Concern

In deciding the case, Judge Wilson used the criteria to determine if the case was anti-SLAPP worthy including:

- The Matters are of Public Concern



- “public interest” does not equate with mere curiosity;
- A matter of public interest should be something of concern to a substantial number of people and a relatively small specific audience is not a matter of public interest
- There should be a degree of closeness between the challenged statement and the asserted public interest; the assertion of a broad amorphous public interest is not sufficient;
- The focus of the speaker’s conduct should be the public interest rather than a mere effort to gather ammunition for another round of private controversy; and
- A person cannot turn otherwise private information into a matter of public interest simply by communicating it to a large number of people

Further, Judge Wilson considered the fact that “a good faith communication in furtherance of the right to petition or the right to free speech in direct connection with an issue of public concern” means any:

- Communication that is aimed at procuring any governmental or electoral action, result or outcome;
- Communication of information or a complaint to a Legislator, officer or employee of the Federal Government, this state or a political subdivision of this state, regarding a matter reasonably of concern to the respective governmental entity;
- Written or oral statement made in direct connection with an issue under consideration by a legislative, executive or judicial body, or any other official proceeding authorized by law; or
- Communication made in direct connection with an issue of public interest in a place open to the public or in a public forum; and which is truthful or is made without knowledge of its falsehood.

He concluded that all 8 matters were of public concern.

## Are Taxpayer Waste, Abuse and Mismanagement A Matter Of Public Interest?

Unsurprisingly, Mr. Gilman argued that articles published by The Teller are not matters of public interest and should, therefore, are not be protected by the First Amendment.

When discussing the article written on Storey County Taxpayers sending Gilman and Hess to attend the presidential Inauguration, Justice Wilson concluded (on page 34 of the pdf file attached below) that “The focus of Toll’s communication was whether the use of tax dollars for the trip was legitimate and in the best interests of Storey County taxpayers. The Court concludes Toll’s statement was in the public interest and not a mere effort to gather ammunition for another round of private controversy. This guiding principle weighs in favor of finding

the communication and the statement was made in direct connection with an issue of public interest.”

## What Happens Next?

Since the court dismissed 7 of 8 charges in Gilman v. Toll, the burden of proof shifts to Mr. Gilman to prove on the remaining count that Mr. Toll lied when he wrote the potentially defaming article. Mr. Gilman may conduct the limited discovery described above which must be concluded by May 11th. Mr. Gilman will then have until May 25th to file and serve a supplemental opposition to the anti-SLAPP motion. Mr. Toll will have until June 8th to file a supplemental reply and will request to submit the matter for decision on or before June 8th, 2018.

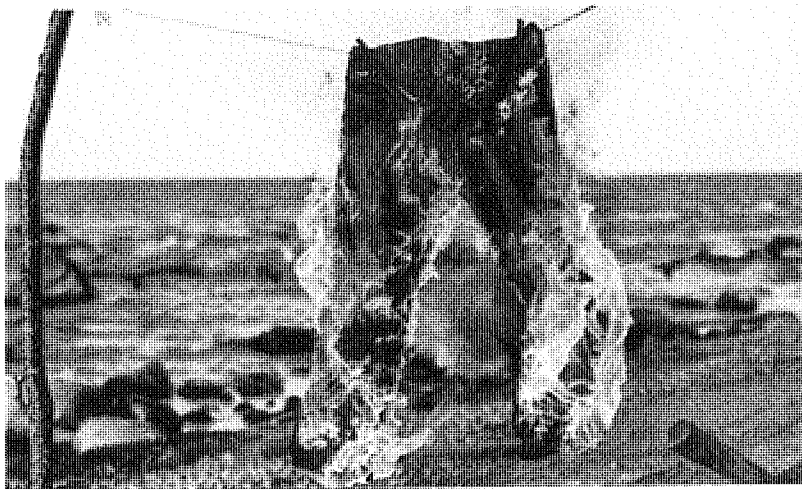

## **So how much did we get?**

I too asked the Nevada Department of Taxation (NDT) about how much money Storey County received from the record \$1.6 billion in taxable sales in the form of a public records request on March 25th, 2018. Given the relatively basic nature of the request, I am amazed NDT can't figure out by now. Confidence level waning.

I too asked Storey County Comptroller Hugh Gallagher how much we got from the record \$1.6 billion in taxable sales, and he said "about a million". Since Mr. Thompson chose not to provide a number for FY 2016-2017, we can assume he either doesn't have them or they are pretty close to "about a million". Pants on fire by omission.

Even if we got \$3.5 million or even \$5 million from the \$1.6 billion in taxable sales, it's chump change as I will show below.

## **Numbers May Be Tortured to Lie, Math Can Not.**

Storey County's rate is 7.6% and is made up of:

- 2% sales tax
- 2.6% local school support tax (LSST)
- .5% basic city-county relief tax (BCCRT)
- 1.75% supplemental city-county relief tax (SCCRT)

- .25% promotion of tourism
- .25% infrastructure
- .25% tri county railway commission

Here is what Mr. Spreadsheet has to say about what we **should have** received from the record \$1.6 billion in taxable sales:

Taxable Sales = \$1,600,000,000	
2% Nevada State Sales Tax	\$32,000,000.00
2.6% Local School Tax	\$41,600,000.00
.5% basic city-county relief tax (BCCRT)	\$8,000,000.00
1.75% supplemental city-county relief tax (SCCRT)	\$28,000,000.00
.25% promotion of tourism	\$4,000,000.00
.25% infrastructure	\$4,000,000.00
.25% tri county railway commission	\$4,000,000.00
Total Tax Revenue	<b>\$121,600,000.00</b>

Mr. Spreadsheet says our schools **should have** gotten \$41,600,000 and the county **should have** gotten a whopping \$ 48,000,000.

Party on, Wayne!

## Bait and Switch

Mr. Thompson reminds us that **only two companies** (Tesla and Switch) enjoy the status of tax freeloaders thanks to the GigaFactory “Deal (**hustle**) of the Century”, and that they can only dance on Storey County Taxpayer shoulders for another six years.

We can’t know for certain what impact this dancing has until the NDT comes clean with the breakdown of receipts from the record \$1.6 billion in taxable sales from FY 2106-2017. When they do I will push that in another article on The Teller.

But if Mr. Gallagher’s estimate of “about a million” is close, we have two major takeaways from that:

1. The two freeloaders represent nearly all the volume of the taxable sales in Storey County, and
2. Since these sales are for one time purchases surrounding the building of the “GigaFactory”, we will **never** enjoy similar robust taxable sales numbers once the building is completed.

In other words, when the taxable sales music stops and the dance ends for Tesla and Switch in six years, there could very well be little to no taxable sales revenue coming in from TRIC.



In fact, I'll bet you a doughnut that in six years it will forever be less than the \$121,600,000 we should have received from FY 2016-2107.

Meanwhile, the cost to the county of maintaining three fire stations and law enforcement will dance on.

BTW, Have you seen the cost of our Fire Department lately? Dang!

Time will tell what the real impact of Tesla, Switch and the other 150 "world class" companies have on our bottom line.

I remain hopeful that dancing to the music of the band of merry TRICsters will be a net win for all of Storey County and not just the select few.

According to the most recent "TRI Public Private Partnership Schedule of Project Revenue and Net Revenue" dated June 30, 2016 the independent auditor from Kohn & Company CPAs found as follows:

**Total Project Revenue to Storey County \$5,299,815**

**Net Revenue \$2,788,141 (this is the auditor's calculation of revenues less costs which were paid to the County from TRI)**

Also, the total project revenue is understated because for the first 15 years of the project through the inadvertence of both parties the calculation did not include Franchise Fees paid by TRI businesses to Storey County (which would be 1% of all energy bills paid by customers within TRI). Nor has it included all the fuel taxes paid to the county by purchases of gas, diesel, and propane by users in TRI. This is being corrected shortly.

By comparison the total project revenue to Storey County from TRI as stated in this report is over 1.5 times the amount of the entire county budget in 2001.

TRI has been very profitable for Storey County as the above figures show.

Of all the 150 companies at TRI, only 1 has full property tax and sales abatements, and that is Tesla. And half of the abatements expire in about 6 years. And even with all the abatements Tesla still pays significant money to reimburse Storey County for all it costs to Tesla, in seven figures I understand – and that revenue is not included in the above numbers.

Only one other company has major abatements – Switch, and Switch still pays 2.5% on their sales taxes.

And neither Tesla nor Switch have abatements for other categories of revenue to the County.

Of all the other companies, only around 17 or so are receiving incentives which include small tax credits and are for a year or two. All the other 120 companies receive no abatements nor incentives. And, the recent buyers into TRI – Google, Blockchains, and Reno Land, have not applied or asked for any abatements.

Ms. Barde and her buddies are anti-TRI and anti-Tesla, and always have been. Had it been up to up to her, Telsa and its 9,000 jobs would not be here. She railed in meeting after meeting that Tesla was a bad deal for the County and Northern Nevada and it would be a big failure. It isn't a failure to the 9,000 people who have good jobs and all the small businesses that have contracts with the Gigafactory.

In fact, in the Commission meeting a few weeks ago Ms. Barde was frantic about Tesla and ranted that the County needs to make immediate plans to layoff County workers and staff, and cut back the County workforce because Tesla is going bankrupt soon. 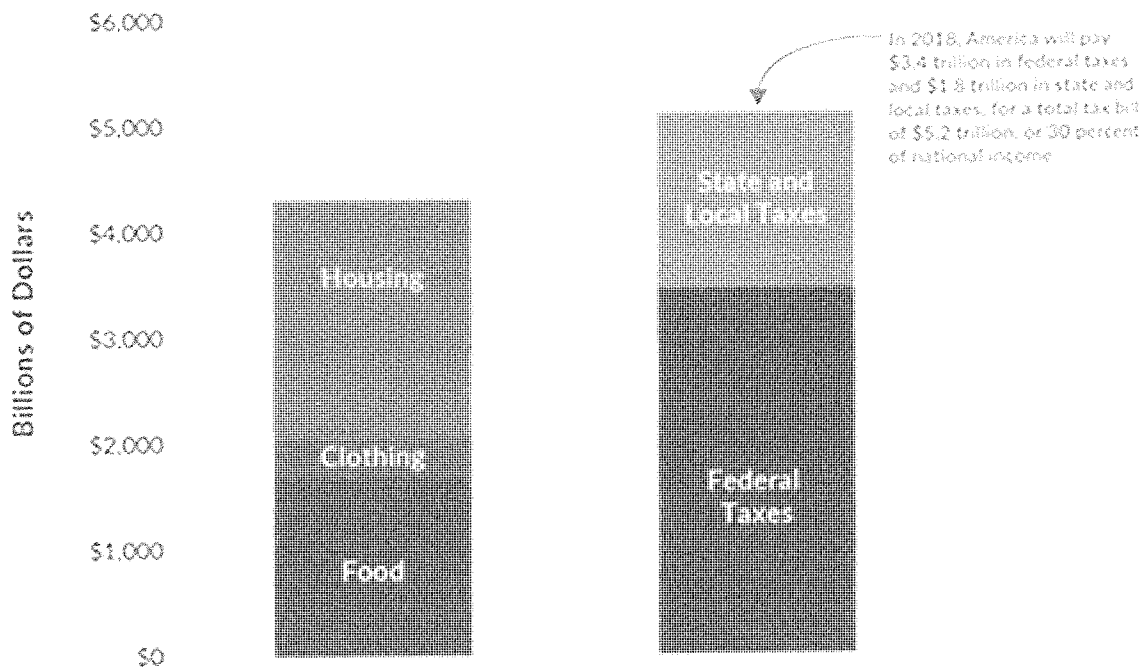

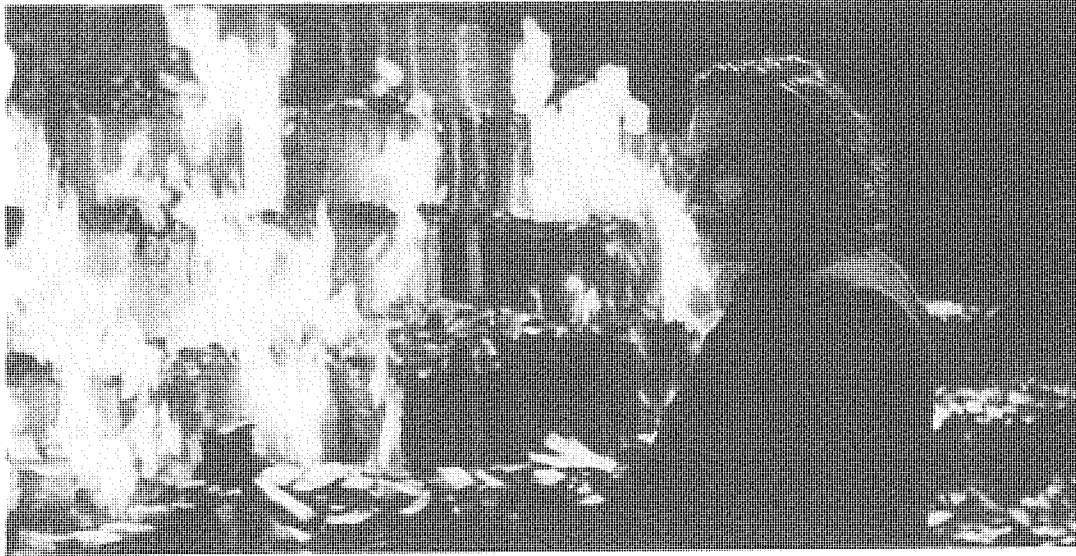

### June 30, 2017 – \$436,248.12 Misappropriated for Wealthy "Retiring" County Employees

In a stunning, in you face case of plain old theft, County Manager Pat Whitten gave his pals Gary Hames, Mike Nevin and Dean Haymore a \$215,000

retirement bonus. In an article I wrote [here](#), the total amount of cash we were ripped off actually totals 436,210 as of June 30. We continue to get ripped off every time the unqualified former fry cook Gary Hames gouges the county for 11,354. each month his no-bid, no expiration date contract is paid.

For those of you paying attention, Commissioner Jack McGuffey was bewildered when this was brought to his attention. In fact all of the Commissioners were asleep at the wheel while Whitten and his cronies hands were in our cookie jar. This is the kind of thing that will either continue or change this November depending on what you, gentle voter, has to say. If I could give this less than an F -, I would.

### July 2017 – \$1,564,589.07 The “Million (and a half) Dollar Parking Lot”

At least we got something nice for the money. But seriously, this is absurd. Lockwood has to buy hard to cafeteria food from Washoe County for the meals on wheels program because there is no kitchen in the Senior Center. The Highlands has been fantasizing about a community center for generations while Jack McGuffey has done zero to take even the first step to get his district anything but an empty garage for the community to meet in. Mark Twain could use anything, even an new swing set. There are literally hundreds of things that would benefit the entire community more than something that keeps mud off the courthouse floor. Grade: F-

### November 17th, 2017 – \$355,000 Spent on 10 South B Street

Storey County ended the year with a couple of transactions that raised my eyebrows. The purchase of the private residence between the Court House and Pipers Opera House was one. With the ever expanding employee head count, we need more space to park the fannies. This historic building built in 1876 after the fire is conveniently situated and would be a great place for a county museum. But the plan is to convert it into offices. At 1450 square feet, The building is super small and has been used for 142 years as a house. Retrofitting it for office use will probably cost another \$50-\$75k making this a very expensive purchase. While the potential use might help offload some of the space at the Court House, could this money and the money we blew on the Bank of America and Black and Howell disaster have been used to build a building that would server more people better? If we had a 5, 10 and 20 year plan for the County this purchase might make more sense. Sadly, the county doesn't seem have much that can be mistaken for forethought. Grade: D-

## December 5th, 2017 – \$300,500 Spent to Purchase Pipers Opera House

This purchase is one that many people think was a good thing for the County to make. It protects one of the Crown Jewels of the Comstock and joins St. Mary's Church and the 4th Ward School as cherished historic buildings the County owns. These buildings are accessible to the public, being cared for and are not falling into disrepair.

The concern I have with the Pipers Purchase is twofold. First, they are under the umbrella of Deny Dotson and the VCTC. Dotson proven himself to be inept at managing money and people. He is hypnotized by budget spreadsheets, thinks that losing money is an investment, and lists the thousands of bottles of Cemetery Gin inventory as cash in the bank. Not exactly what folks who know what GAAP stands for would put up with.

Second and more important, is the notion that the county is now in the tourist business. Pipers Opera House now competes directly with other venues and represents competition with other businesses in Virginia City. But I ask more fundamental question: What is the core business of a public entity? If you think that the government should provide all kinds of services and should be involved in all sorts of endeavors, then the more the merrier. But if you think that the government should do **only** the things that are in and serve the best interests of all County citizens, in the most minimalist of ways, then this purchase is outside this circle.

If the county leaders intended to run Pipers like St. Mary's and the 4th Ward, with a 501c3 and a board of directors, then this might make sense. To me it does not.

Grade: D+

## December 15th, 2017, – \$6226.23 Spent on The Storey County (Employee) Christmas Party

Storey County ended the year with a bash at the freshly minted County asset by treating "The Entire County" to a Christmas party. By sending the invite to all county residents via the Comstock Chronicle they insured that nobody would get the invitation. They may have used smoke signals and Morse Code to invite Lockwood and Mark Twain residents based on the number of folks from those communities who partook. As a result, the 2017 version of the Storey County Christmas Party, as in years past, was actually the Storey County Employees Christmas Party.

I was in attendance and I counted about 60-80 people in attendance, 6 of whom were not County employees or their relatives. County Employees sopped up free booze and grub while the people of the rest of the county got a tax bill. Nice work if you can get it. Full disclosure, The cash outlay was 4726.23. The other \$1500 was the opportunity loss if the County had rented Pipers to a cash customer.

Grade: F-

## \$30,765,000 Dollars not spent thanks to Public Outrage

County residents prevented this insult to our pocketbooks from being vastly worse. Readers of the Teller will remember our coverage of the Effluent Pipeline Corporate Welfare effort (if you missed it, read [here](#) and [here](#) and [here](#) and [here](#)) and the private property theft of the V&T Depot via emmenint domain. While the county has tabled the notion of stealing the Depot from Pierce Powell, the Pipeline deal remains very much alive. As usual the details are kept secret from us chumps er.. taxpayers, but we are promised they won't use our money to benefit the potential freeloaders at TRIC. I don't believe it for a minute and will pay close attention to this as the year unfolds.

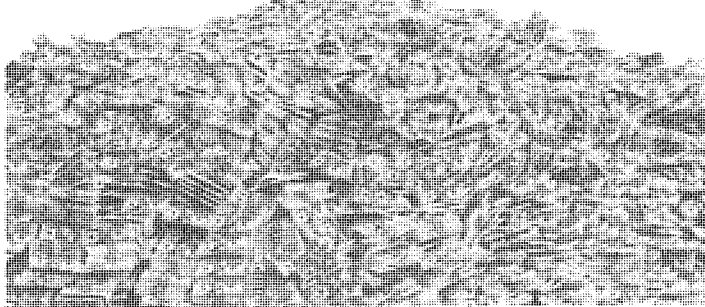

We're super busy right now and this isn't as important as what we are super busy on.

Had I asked Assessor Jana Seddon, I would have gotten my answer in two minutes as she has access to the same data that Mr. Osborne has.

The reason I asked Mr. Osborne is that he is Assistant County Manager and Manager of the Planning Department. He is the compliance officer for the County regarding zoning matters. He would be the guy to enforce a zoning violation. After waiting 6 months for Mr. Osborne to act, I got fed up and wrote the infamous piece that describe my filing a complaint with DA Langer and AG Laxalt regarding Commissioner Gilman. My complaint (which you can read [here](#)) essentially said:

- If Gilman does not live at the Mustang Ranch (as I continue to believe) then he committed perjury or
- If Gilman actually does share a double wide with Kris and Jennifer, then he is in violation of Storey County's rules.

Shortly after the letter to DA Langer, Austin sent me this:

### The Matter Is Being Addressed Otherwise

I got more annoyed about being blown off and since he finally disclosed that the Mustang Ranch is zoned "Agriculture", I wrote my most popular posting on The Teller, the satire piece about Glance "The Thrill" Thrillman's partnership with the Mustang Ranch to open a Petting Zoo at the Brothel.

Within thirty minutes of the posting, Gilman's bunkmate Kris Thompson fired off an email demanding an apology and getting none, Gilman served me two days later with his lawsuit.

On April 23rd, I decided to see how the looking was going. I send Austin the following email:

Mr. Lance Gilman, Ms. Jennifer Milsap-Barnes, Mr. Kris Thompson, Ms. Shirley Jensen, Ms. Ciara Martin, Ms. Rachelle Ussia, Ms. Luz Armas Ms. Yu Kang, claim 1000, 1011, 5, 56 and 5B Wild Horse Canyon Drive addresses as their legal residences according to records on file with the County Clerk.

These "legal residences" are all located on the Mustang Ranch and Wild Horse Brothel properties located on parcels 004-161-021 through 124.

Parcels 004-161-021 through 124 are zoned A/I-2.

Anything more than a single family dwelling is not permitted under the zoning designation A/I2.

I sent Mr. Osborne a public record request over a year ago, which means that the county has known at least that long of this violation, yet there has been zero enforcement of this violation.

Are Mr. Gilman and his flock exempt from obeying the rules that govern the rest of us?

If I were to start a 1000 head pig farm in Gold Hill it would be shut down in a New York Minute.

I am tired of being stonewalled on this issue and my readers ask me 3 times a week about the county's handling of this matter.

In the dozen or so email requests which I've sent to numerous Storey County officials over the past year and the responses I have received I have yet to see an unequivocal and definitive answer to this question. If there was one I'd appreciate one of you pointing it out. Otherwise I'll ask you the same question I asked Mr.

Hames:

**Will Storey County continue to allow Mr. Gilman/Cash Management Services/Mustang Ranch and the group of people listed above to remain in violation of County Code/Ordinances without enforcement action?**

**A simple yes or no will suffice.**

## Tesla and TRIC – The Story Behind The Numbers, Part 1

Storey County made news last year when the Nevada Department of Taxation (NDT) released their figures for the Fiscal Year 2016-2017. Around the state, people took notice of the remarkable increase in taxable sales in Storey County. Thanks to Tesla and TRIC, Storey County's taxable sales increased 568% over FY 2015-2016, thanks in large part to construction at the Gigafactory hitting stride.

The casual observer and anyone reading the press releases coming from GOED and TRIC would think that Storey County is enjoying quite the windfall from these sales. After all, Storey County takes home 5.6% of the 7.6% sales tax collected from sales within the County. However, when you take a closer look, you can see the windfall is not what you might expect.

The Storey Teller contacted the NDT and posed the question: How Much Did Storey County Deposit from that record \$ 1.6 billion dollars windfall?

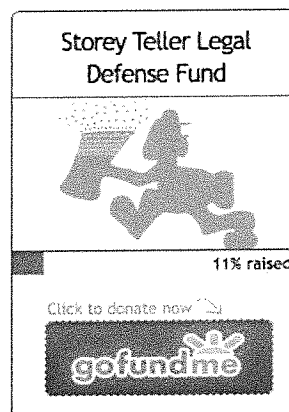
The answer will surprise you.

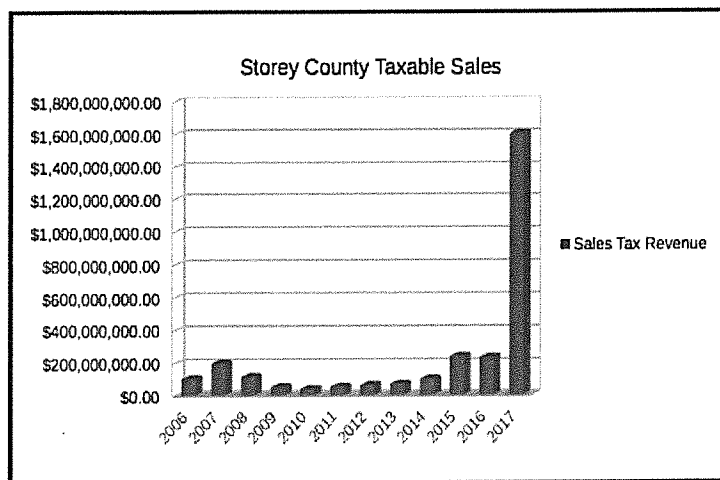


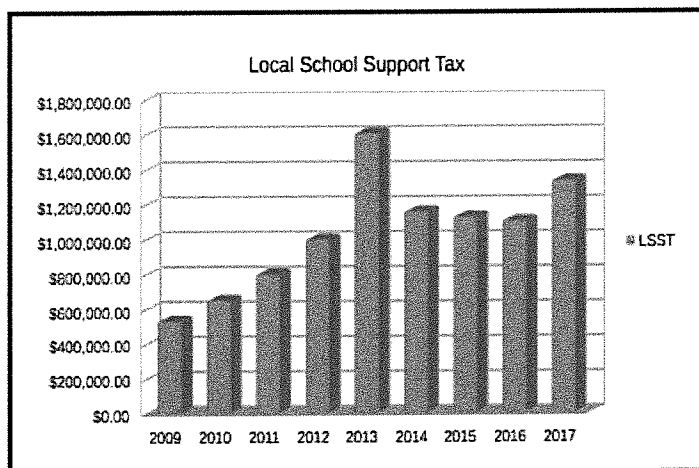
Chart 1 – Total Taxable Sales 2009-2017. 2017 is off the chart (almost)

## Sales Tax Revenue Broken Down

The NDT websites annual statistic reports break the tax revenue to the counties in various categories. The major categories are Local School Support Tax (LSST), Basic City/County Relief Tax (BCCRT), and Supplemental City/County Relief Tax (SCCRT). In Storey County, we have three special tax revenue streams from voter-approved sales tax increases. Tourism, Infrastructure and the V&T Railroad all receive a quarter percent of taxable sales. Below we will compare the annual amount received from the years 2009-2017 to see how the trends stack up.

### Local School Support Tax – 2.6%

Each County receives a portion of the tax collected for the schools; called the Local School Support Tax (LSST). In Storey County, the State transfers 2.6% of the 7.6% they collect here. The chart below shows the money Storey County received from 2007 – 2017.

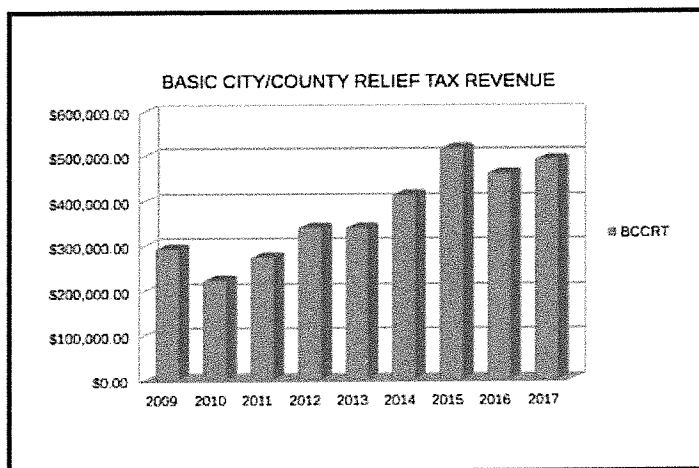




The takeaway from this chart is that in 2013, when taxable sales were \$77.28 million dollars, Storey County Schools deposited \$1.61 million dollars while in 2017 we only deposited 1.37 million. When the taxable sales were truly off the charts, Storey County Schools did not enjoy record revenues.

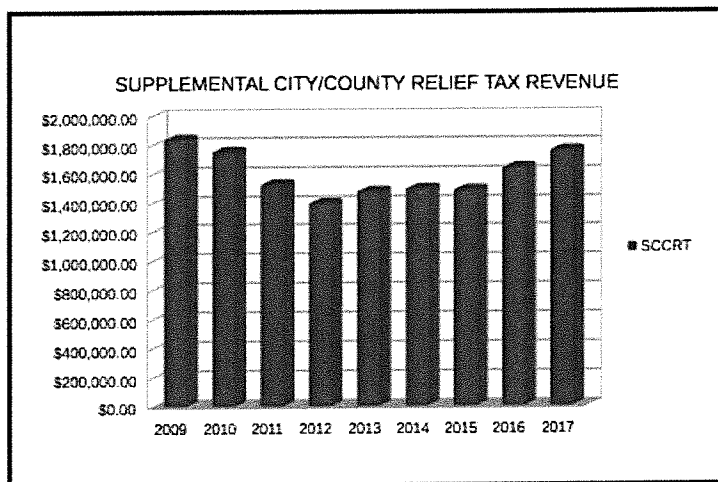
### Basic City/County Relief Tax (BCCRT) – .5%

Below is the BCCRT chart for 2009 – 2017.



The takeaway here is the 2015 figure of \$518k is greater than the 2017 figure of \$493k. Again, not what we would expect from a record year in taxable sales.

### Supplemental City/County Relief Tax – 1.75%



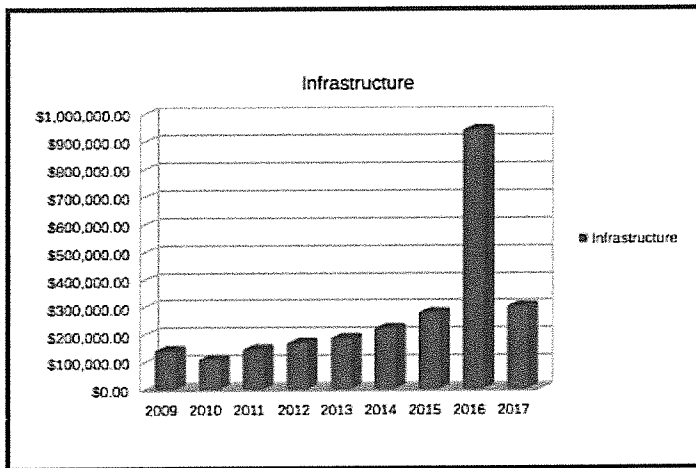
Here we see that both 2009 and 2010 are greater than or equal to the record 2017 revenue. While this revenue is making a comeback, it is still not at 2009 levels in spite of the record \$1.6 billion in taxable sales.

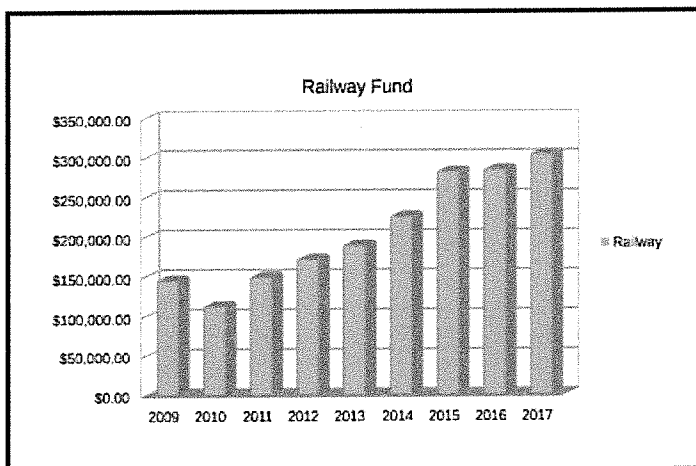

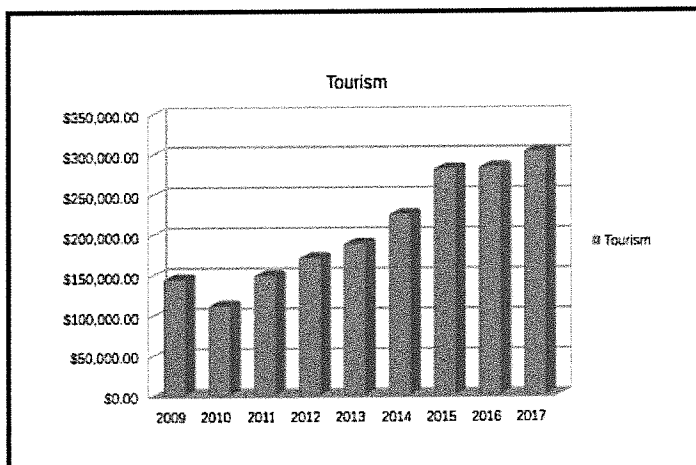

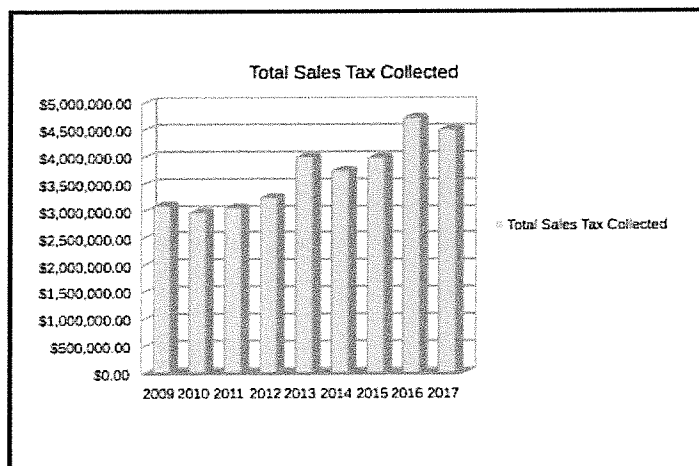

## Tesla and TRIC – Conclusion.

When we tally the figures above (LSST, BCCRT, SCCRT, Tourism, Railway, and Infrastructure) we discover that in terms of revenue from 2009 – 2017, **total revenue fell in 2017 compared to 2016** despite the record 1.6 billion in taxable sales. And remember, we have to repay 35% of this money generated at TRIC so the amount we can actually use is even smaller.

In spite of what we hear from the County and TRIC public relations machines, the spectacular \$1.6 billion in taxable sales yielded disappointing results in terms of total revenue in the coffers of the County. Without abatements, Storey County would have deposited nearly \$90 million. However, we abated \$85.5 million and deposited only \$4.5 million.

On the other hand, our spending and hiring, however, continues to grow. The County has advertised for a half-dozen new hires in recent months while Comptroller Gallagher's lone voice of guarded caution asks for the department heads to tighten belts.

When we compare these abatements to just two transactions TRIC made this year of \$29 Million (Google) and \$174 million (Blockchains) it's not hard to figure out who the winners (Tesla and TRIC) and losers (you and me) are.

Meanwhile, Commissioner Jack McGuffey's Website (<http://electjackmcguffey.com/#>) lists his Current Priorities. At the top of his list is:

#### CURRENT PRIORITIES?

1. Continue to push through a tax rebate or other means of compensation to the residents of Storey County from the extra revenues generated by the success of TRIC as proposed years ago by Commissioner Lance Gilman.


Commissioners Gilman and McGuffey are irresponsible when they make these unrealistic claims. By suggesting they are tirelessly working to give "tax rebates or other means of compensation to the residents of Storey County", they paint a picture of Storey County finances not based in financial reality. Either they know the county's revenues are flat and continue to talk about something they know is simply not possible, or they simply aren't paying close enough attention to the actual numbers.


Either way, they sell us short. Keep this in mind when you head to the ballot in the primary and the general elections this year.

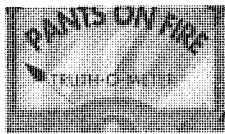

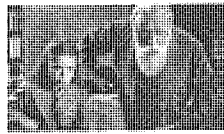



## Letter To The Editor

I wrote another article illustrating how the County's tentative FY 2018-2019 Budget, obtained from Storey County's website, had a nearly \$2 million dollar shortfall. I identified the numbers were from the tentative budget and promised a followup article once the final budget was released.

As the facts illustrate in both articles, C Street is not awash with TRIC cash as we have been lead to believe. The tentative budget shows projected revenues are expected to be below 2014 levels while expenses are projected to be up 32% over the same period.

If Commissioner McBride wants to take umbrage with my opinions, I encourage him to do so. If he calls me a liar on the front page and on the record, he'd better back it up with facts.

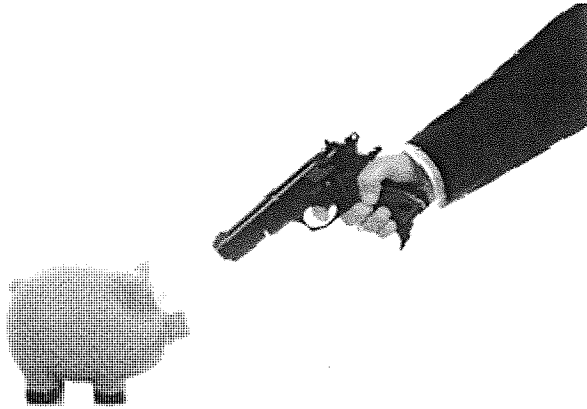

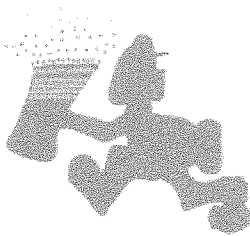

## Tesla – The Miracle In Storey County

It has been nearly five years since Governor Sandoval and the Nevada Legislature saddled The Miracle In Storey County, aka Tesla up onto the backs of the Storey County Taxpayer. With the news of the Tesla deal reaching all four corners of the globe, scores of new companies have purchased land at TRIC and set up shop. These companies are creating rapid growth in Northern Nevada and are responsible for dramatic growth in our little slice of paradise.

This is seemingly a good thing for Northern Nevada and Storey County. It has been an especially good thing for Roger Norman, Storey County Commissioner Lance Gilman, and TRIC project manager and Mustang Ranch brothel resident Kris Thompson. The Tesla announcement has proven to be a massive windfall for TRIC. TRIC recently announced they have sold out and are winding down their real estate business. At 80, Roger Norman will now ride the fruits of his work into the sunset.

While Blockchains has taken the reins from Norman by buying up all the remaining acreage, County Commissioner Lance Gilman has been hired to work his magic for Blockchains. While past performance is no indication of future developments, I am confident that Mr. Gilman will wear hats on both sides of the table as he has in the past to benefit the few (himself and Blockchains) at the expense of the many (The people who elected him to represent them and their best interests).

### Past Performance

We've seen Tesla's impact here in Northern Nevada. But what is the impact on Storey County residents and revenues? We have written about the record Taxable Sales success in recent years which [you can read here](#). We have [written about the grim outlook](#) presented by the FY18-19 Storey County Budget that was approved on Monday, May 21st. The budget, with \$ 1.7 million dollars of red ink, is upside down primarily because of Tesla.

Tesla signed an agreement with Storey County in 2015 to pay for providing County provided activity including Fire, Sheriff, and Building Inspection services. That agreement, which pays the county 1.2 million dollars a year is set to expire on June 30th, 2018. Pat Whitten has been trying, unsuccessfully, to get Tesla to commit a couple hours to hammer out a new agreement. Tesla is in the middle of a remarkable cash crunch, so it's no surprise that they aren't interested in talking

about committing cash to pay for what we have been providing them. Presumably Tesla will negotiate a new agreement before the current one expires. However, unless it is for \$1.7 million dollars, Comptroller Gallagher warns us of belt tightening on the horizon.

In response to our critical view of the condition of our condition, Kris Thompson posted a remarkably rosy picture of the County's health on the Virginia City Highlands email chat group, which you can find in its entirety at the end of this article. In this article, we address some of the points he brought up (using numbers from the Storey County Audited Budgets and the Governors Office of Economic Development, Tesla and others) to provide some balance to his numbers.

## Key Facts about Storey County's condition now (2018) compared to 2014 before Tesla

Despite the tens of thousands of jobs, billion dollars of capital investment and vast the growth at TRIC, revenue growth is slim to none here in Storey County. Given the County's flat revenue growth and the robust spending, the County's General Fund's balance dropped last years and we recently approved Budget to be \$1.7 million in the red this year. Since Telsa's arrival as TRIC's the anchor tenant, the General Fund up only \$1.1. While good, this can hardly be considered miraculous in light of our financial health.

Another useful number to consider might be the ratio of revenue and expenses growth since Tesla showed up on the scene.

This chart shows the growth of revenue and expenses over the 5 years since Tesla broke ground. As the chart reveals, the county's revenue is flat while spending is not.
