MOTION FOR EXTENSION TO FILE REPLY BRIEF

Appellant requests a 60-day extension, through February 26, 2020, to file his reply brief. NRAP 31(b)(3). This is the third such request. The brief was originally due August 26, 2020. Two extensions were previously granted, and the brief would otherwise be due December 28, 2020. No request for extension has been denied in full or in part.

Extraordinary circumstances and extreme need necessitate this extension. Difficulties related to the COVID-19 outbreak persist, and the primary drafting attorney has had to dedicate significant time to child care, sometimes even more than anticipated and planned for. The primary drafting attorney has also been diagnosed with a medical

condition that is ongoing and has proven extremely time-consuming to deal with.

The subject brief is not an ordinary response brief, but rather is a combined response/reply brief that needs to address the issues raised in the Appellant's appeal, the Estate's cross-appeal, and the Estate's consolidated independent appeal arising from an action that has been ongoing since 2013 and that has an extensive trial record as well as voluminous pre- and post-trial briefing.

Additional time is also needed due to the current holiday season and the need to accommodate different schedules and familial obligations, including allowing sufficient time for client communication and revisions.

The Court's understanding in light of these unique and challenging circumstances is appreciated.
