Motion for Extension to File Reply Brief on Cross-Appeal (No. 78341)
and Reply Brief on Appeal (No. 79464)

Respondent/Cross-Appellant, the Dr. Miriam and Sheldon G. Adelson Educational Institute respectfully requests a 60-day extension to file its Reply Brief on Cross-Appeal (No. 78341) and Reply Brief on Appeal (No. 79464) (“Combined Reply Brief”), consolidated in Docket No. 79464. The Combined Reply Brief is currently due on March 26, 2021.

This is Respondent/Cross Appellant’s first motion for an extension to file its Combined Reply Brief and the fourth motion for an extension in this consolidated appeal. No request for additional time has been denied or denied in part to either party to this appeal.

Completion of the Combined Reply Brief has been delayed due to a multitude of circumstances. First, the briefing in this case is extensive and requires additional time to review and address the arguments addressed in Appellant/Cross-Respondent’s 114 page combined reply and answering brief. *See* Appellant Cross Respondent’s Reply Brief and Answering Brief on Cross Appeal (114 pages) filed on February 26, 2021. Second, both Respondent/Cross-Appellant’s lead and primary drafting counsel have been in trial since March 22, 2021, and trial is not

expected to conclude until April 2, 2021. Therefore, additional time is necessary to complete the Combined Reply Brief.

If the Court grants this request, then the Combined Reply Brief would be due on May 26, 2021.
