**MOTION FOR EXTENSION TO FILE PETITION FOR REHEARING**

Appellant requests a 60-day extension of the deadline in which to file a petition for rehearing, through June 17, 2022. NRAP 26(b), 31(b)(3). Without an extension, the petition would be due April 18, 2022. This is the first such motion related to this brief. NRAP 40(a)(1).

Good cause justifies the additional time. The panel's decision was rendered on March 30, 2022, but attorneys on the case had pre-scheduled travel and personal plans around the Easter and spring break holidays, including needing to take time to care for children who

were not in school. Lead appellate counsel was also largely unavailable due to illness and the preparation for oral argument before this Court. The additional time will enable appellant's counsel to ensure the petition addresses all points and authorities essential to appropriate reassessment.

Appellant appreciates the Court's consideration.
