This case involves a question certified by the United States District Court, District of Nevada, to this Court on a question of Nevada law. The certified question is as follows: "Does NRS 258.007 give the Clark County Board of County Commissioners the power to remove a constable from office, or can a constable be removed only with a quo warranto action?" The POST Commission has no enforcement authority over the North Las Vegas Township Constable for his failure to become certified as required by NRS 258.007. As a result, the POST Commission has no authority to remove Mr. Eliason from office. Because the POST Commission cannot take any enforcement action against Mr. Eliason, the POST Commission does not take a position on the certified question of law currently pending before this Court. The POST commission desires to maintain its neutral position on the question of law, and therefore provides this Court with notice that it waives its right to file an opening brief.
