MOTION FOR EXTENSION OF TIME TO FILE OPENING BRIEF AND APPENDIX

Appellant requests an extension of 30 days, through February 5, 2020, to file the opening brief and joint appendix. NRAP 31(b)(3). The original October 16, 2019 deadline was extended by stipulation, NRAP 31(b)(2), and then appellant file two unopposed motions for extension. Without the requested extension, the brief would be due January 6, 2020.

Although counsel have prepared a draft brief, extraordinary circumstances necessitate this extension. First, Lewis Roca Rothgerber Christie are appearing today as new appellate counsel. They have not

yet had the opportunity to review the brief or confer with their client regarding further streamlining of the issues. The requested extension would greatly ease counsel's ability to communicate with appellant and make these revisions.

Second, even if new appellate counsel had appeared earlier, they would still have needed this extension. Mr. Smith has had to take several days off of work (beyond the holidays) with his own illness and caring for ill members of his family and dealing with the aftermath of the traumatic death of a family pet.

Third, while counsel understand that counsel's caseload is—without other reasons—not a basis for an extension, counsel note that they have faced unforeseeable emergencies in several cases. In just one example, counsel today had to respond to a supplemental brief filed over the weekend regarding long-pending oral arguments set for tomorrow in the opioid litigation. Appellate counsel have also been short-staffed with Mr. Henriod involved in overlapping trials, Mr. Polsenberg traveling for hearings, and their paralegal out of the office.

In these extraordinary circumstances, undersigned counsel appreciate the Court's courtesy in granting this extension.
