- i. The petition for en banc reconsideration is currently due Thursday,

- ii. Respondents previously requested a 14-day telephonic extension to extend the original deadline of Thursday, October 15, 2020. The court granted the extension request and set a deadline of Thursday, October, 29, 2020.
 - iii. This is respondents' first motion request.
 - iv. No requests for extension of time have been denied.
- v. Good cause exists to extend the time to file the petition for en banc reconsideration because the handling associate for respondents had a serious medical emergency and, consequently, the petition has been internally transferred to another associate. Good cause also exists to provide additional time because the unique issue raised in this appeal has not been uniformly decided, and has substantial importance to dozens of pending quiet title actions. *Compare Sage Realty LLC Series 2 v. Bank of N.Y. Mellon*, No. 73735, 2018 WL 6617730 (Nev. Dec. 11, 2018) (3-0 panel disposition), *with Anthony S. Noonan IRA, LLC v. U.S. Bank N.A.*, 136 Nev. Adv. Op. 41, 466 P.3d 1276 (2020) (2-1 panel opinion).
