**MOTION FOR EXTENSION
TO FILE OPENING BRIEF AND APPENDIX**

Appellant moves to extend the deadline for filing the opening brief and appendix by thirty days, up to and including, December 4, 2019. NRAP 31(b)(3). This is the second motion for extension.
